I. Overview

- 1. The financial situation as at 31 August 2019 can be summarized in the following major points:
- (a) Regular budget gross expenditure of €102.4 million, equivalent to 73.6 per cent of the gross biennial appropriation, reflects a slightly lower implementation level than that of a similar period in the previous biennium of 76.4 per cent;
- (b) The operational budget expenditures amounted to €27.5 million in the reporting period, which is slightly higher than the operational budget performance for the same period of the prior biennium of €26.2 million;
- (c) The expenditure level for buildings management amounted to €44 million in accordance with the prevailing workplan;
- (d) The collection rate of 2019 assessed contributions as at 31 August 2019 was 78.4 per cent, compared to the 2018 and 2017 rates of 83.4 and 78.9 per cent, respectively;
- (e) The collection rate of prior years' arrears, as compared to the current year's assessments, was 3.4 per cent. The rate as at 31 August 2018 and 2017, as compared to the assessments of those years, was 11.9 and 10.2 per cent, respectively;
- (f) Outstanding assessed contributions amounted to ϵ 99.3 million, as shown in the annex to the present document (including arrears of ϵ 69.1 million by the United States of America, and ϵ 2.1 million by the former Yugoslavia). The outstanding amounts as at 31 August 2018 and 2017 were ϵ 93.8 million and ϵ 98.5 million, respectively;
- (g) The Working Capital Fund was at the level of $\[\in \]$ 7,423,030. However, an amount of $\[\in \]$ 5,281 was outstanding as at 31 August 2019;
- (h) A conference room paper (GC.18/CRP.2) will be provided on the status of assessed contributions and voting rights, updated to 16 October 2019.

II. Regular and operational budgets, 2018–2019

A. Regular budget

- 2. As at 31 August 2019, regular budget allotments for the biennium totalled €128.5 million, which represents 92.3 per cent of the gross expenditure budget.
- 3. During that period, the regular budget expenditures totalled €102.4 million, which represents 73.6 per cent of the gross expenditure budget for the biennium 2018–2019. These figures are slightly lower than those of the previous biennium. On 31 August 2017, regular budget expenditure amounted to €106.2 million with a 76.4 per cent utilization rate of the gross expenditure budget. As planned, the rate of expenditure is expected to increase in the last quarter of the biennium with additional budgetary expenditures relating to convening the General Conference, as costs for conference services and other related common services will be incurred before the end of the biennium.

B. Operational budget

- 4. As at 31 August 2019, the total operational budget release for the biennium, €34.1 million represents 94.4 per cent of the approved operational budget estimates.
- 5. In the current reporting period, operational budget expenditures amounted to \in 27.5 million, slightly higher than the expenditures of \in 26.2 million for the similar reporting period in the previous biennium.

6. As at 31 August 2019, technical cooperation activities reached a level of \$136.1 million, including commitments. Income from support costs as at 31 August 2019, amounted to €12.8 million.

C. Buildings management

- 7. The total biennium release of €52.7 million, as at 31 August 2019, corresponds to 94 per cent of the approved budget. The buildings management budget is being implemented in accordance with the prevailing workplan.
- 8. Expenditures as at 31 August 2019 amounted to €44 million, which is higher than the expenditure of €39.9 million in the same period in the previous biennium. This rate represents 78.6 per cent of the buildings management gross expenditure biennial budget.

III. Prioritizations and efficiencies

- 9. In compliance with General Conference decision GC.17/Dec.18, paragraph (f), this section provides an update on the implementation status of the areas for de-prioritization aimed at identifying further efficiencies.
- 10. UNIDO continues the full cost recovery exercise aimed at improving cost recovery leading to increase of organizational capacities and improved tracking, monitoring, recording, and allocating of staff time spent on programme and project implementation of TC activities funded from extrabudgetary sources.

IV. Assessed contributions

A. Collections

11. A total of sixty-eight Member States, including eleven least developed countries (LDCs), made full payments. Thirty Member States, nine of which are LDCs, made partial payments and/or their adjustments were credited towards their assessed contributions for the year 2019. The collections in the period from January to August 2019, broken down by List of States, are shown in table 1.

V. Voting rights

13. As indicated in the annex to the present document, the voting rights of 41 Member States had been suspended as at 31 August 2019, in accordance with Article 5.2 of the Constitution and financial regulation 5.5 (b). The status of voting rights in respect of the various policymaking organs is shown in table 3.

14. To restore their voting rights for 2019, these Member States must pay their full contributions for 2016 and prior years, including advances to the Working Capital Fund, as well as a partial contribution for 2017. The minimum total amount that would have to be paid by these Member States is €4,549,315.

VI. Multi-year payment plans

15. Table 4 shows, in summary form, the current status of those Member States that have entered into payment plan arrangements to settle outstanding assessed contributions. The Secretariat notes with appreciation and recognizes the considerable efforts made by all those Member States that have honoured their commitments and obligations as stipulated in their respective payment plans. Other Member States in arrears are encouraged to consider submitting payment plans to steadily reduce their outstanding assessed contributions.

VII. Arrears by former Member States

16. The amount of arrears owed to UNIDO by the United States of America is €69,068,887 (1994–1996), while the arrears of the former Yugoslavia amount to €2,081,599 (1990–2001). Payment of these arrears is being pursued by the Secretariat.

VIII. Unutilized balances of appropriations as at 30 September 2019

17. Information on the unutilized balances of appropriations will be provided in a conference room paper (GC.18/CRP.3).

IX. Action required of the Conference

18. The General Conference may wish to consider adopting the following draft decision:

"The General Conference:

- (a) Takes note of the information provided in document GC.18/5;
- (b) Urges those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years' arrears, to do so without delay;
- (c) Requests the Director General to pursue his efforts and contacts with Member States and former Member States to effect the collection of arrears."
