



Net approvals and expenditures 2019



PROGRAMME FOR COUNTRY PARTNERSHIP (PCP)

PCPs UNDER IMPLEMENTATION

PCP ETHIOPIA

Progress in 2019

Governance and coordination: The governance structure of the PCP was revised to align with changes in the government. The PCP's six task forces were consolidated into four: (i) Resource Mobilization and Partnership Management; (ii) Manufacturing; (iii) Agricultural Productivity Enhancement and Commercialization; and (iv) The newly established Investment Promotion Task Force. Two high-level committees comprising ministers and State ministers lead the PCP: (i) The Inter-Ministerial Coordination Committee; and (ii) The Joint Steering Committee. All task forces and high-level committees met regularly in 2019 to review progress, identify solutions to challenges and strengthen synergies with partner programmes. An independent terminal evaluation of the PCP was initiated in 2019, the results of which will help inform the way forward.

Partnerships and resource mobilization: Through the PCP, UNIDO has supported the Government in forging partnerships and creating synergies for its industrial development priorities and flagship initiatives. In addition to the Government of Ethiopia and its specialized agencies, the PCP includes three multilateral development banks, seven major bilateral donors, three multilateral facilities, five private sector actors, and three United Nations entities.

An estimated \$1.2 billion of parallel funding was leveraged through the PCP, while the funding pipeline for 2019/2020 amounts to approximately \$458.4 million. The integrated agro-industrial park (IAIP) initiative has mobilized the largest share of financial resources through partnerships. This amounts to over \$500 million committed by the Government and over \$640 million leveraged from development partners. In 2019, the Government of Ethiopia and partners launched a new \$270 million multi-stakeholder initiative, "Promotion of Sustainable Ethiopian Agro-industrial Development (PROSEAD)", to support the four pilot IAIPs. PROSEAD involves the European Union (EU), the Republic of Korea, Germany, the Ethiopian Agriculture Transformation Agency, and the International Fund for Agricultural Development (IFAD), among others. In addition, the Government and partners signed a \$100 million African Development Bank (AfDB) support project for the IAIPs. The Resource Mobilization and Partnership Management Task Force is also seeking investments of \$515 million for a project to support the upgrading of the agricultural production and supply systems around the IAIPs. In December 2019, the Government of Ethiopia submitted an official financing request to the European Investment Bank (EIB) for €100 million for the Modjo Leather City (MLC), a flagship project of the PCP.

To date, the UNIDO technical cooperation (TC) portfolio directly related to the PCP amounts to over \$54 million, spread across 34 projects. In 2019, four new TC projects started: (i) Funded by the Government of Japan, the second phase of the "Improving the public health by solar-powered water sanitation systems in Ethiopia" project to establish a solar-powered slow filtration system to produce clean water; (ii) Funded by the EU, the "Support business friendly and inclusive national and regional policies and strengthen productive capacities and value chains in African, Caribbean and Pacific Group of States (ACP) countries" programme allocated approximately €640,000 to establish an investment-friendly policy and business environment in Ethiopia; (iii) Under the PROSEAD project, UNIDO received €3.3 million to support the overall coordination and harmonization of the EU-funded initiatives around the IAIPs, and to address key performance issues of the Ethiopian agro-industrial sector; and (iv) A \$4.5 million grant from the AfDB to UNIDO through a new five-year project, agreed to by UNIDO and the Ethiopian Ministry of Trade and Industry in October 2019, to provide capacity-building support to the federal and regional institutions responsible for IAIP management, and to support the coordination and monitoring of the Bank's parallel initiatives linked to the IAIPs.

Policy advisory services: UNIDO conducted five studies to support the development of comprehensive national sectoral strategies: (i) A roadmap for the textile and apparel sector; (ii) A strategy for the cluster development of small and medium-sized enterprises (SMEs); (iii) A policy paper to support the development of the chemicals industry; (iv) A study on the Ethiopian trade show and exhibition sector; and (v) A national entrepreneurship strategy developed in collaboration with the United Nations Conference on Trade and Development. The Government endorsed the studies in 2019.

Implementation highlights in PCP priority areas:

Agro-processing: The construction of the four pilot IAIPs is 50 to 70 per cent complete. Basic infrastructure will be finalized in 2020 to start attracting private investment. In total, 150 investors have already registered with respective Regional Industrial Park Development Corporations. Five companies have already commenced construction of premises within two of the parks (SNNPR and Amhara) and one company, an avocado processor, has started operating. The IAIP initiative has created approximately 21,000 new jobs (27 per cent for women) to date.

UNIDO and the Food and Agriculture Organization (FAO) conducted several value chain studies, strategic analyses and business plans for the agro-corridors around the IAIPs. As part of this exercise, more than 360 actors from selected value chains were assisted through extension services. A sub-contracting scheme is being implemented for avocado cooperatives to supply the SNNPR park.

In the area of agricultural productivity enhancement and commercialization, UNIDO projects supported four selected food value chains (coffee, beles, moringa and fisheries) through technology transfer, capacity-building and market access support. To date, more than 17,000 smallholder farmers have benefited from agricultural extension services, while two unions and four farmers' cooperatives have upgraded production facilities.

Textiles and apparel: With the support of a UNIDO project on capacity-building and job creation for youth and women in Ethiopia's migration-prone areas, 369 young people have obtained jobs with the textile and garment companies operating in the Mekelle Industrial Park. UNIDO is implementing this project in synergy with an EU-funded project focused on stemming irregular migration in regions of Ethiopia.

The Mekelle Garment College Centre of Excellence (CoE) was inaugurated in September 2019 with the presence of high-level government representatives. The CoE will serve as a training hub for skilled workers and as a model for potential replication in other parts of the country. In May 2019, UNIDO organized a study tour to Bangladesh for selected high-level representatives of Ethiopian ministries and sectoral associations to learn from best practices in the industry.

Leather and leather products: Five footwear and leather goods clusters in the Addis Ababa region have benefited from PCP support so far. Together, they employ over 4,850 workers, 33 per cent more than the number recorded as the baseline in 2014. Of these, 48 per cent are women and 90 per cent are below the age of 24. In April 2019, a common production unit was inaugurated at the premises of the Ethio-International Footwear Cluster Cooperative Society Ltd. as a means to increase the cluster's production capacity and overall sales. UNIDO also organized several trainings and peer-to-peer initiatives aimed at fostering cluster development in the country.

The governance structure of the "Leather Initiative for Sustainable Employment Creation", an EU-funded programme linked to the Modjo Leather City, was established in 2019. Initial activities have focused on identifying the immediate environmental challenges and solutions for the tanning sector.

Outlook for 2020

- UNIDO will support the Government in fully operationalizing the new Investment Promotion Task Force. This will include revising and strengthening its membership and reinforcing the Task Force's mandate.
- The independent terminal evaluation of PCP Ethiopia will conclude in 2020. The results and recommendations of the evaluation will help determine the way forward.
- In terms of resource mobilization and partnerships, approximately \$10 million is in the pipeline for new UNIDO TC projects. In terms of parallel funding, the Resource Mobilization and Partnership Management Task Force will work to mobilize the \$1.5 million needed for the feasibility study and masterplan for the establishment of a new Exhibition and Convention Centre in Addis Ababa. Another priority of the Task Force will be to mobilize around \$1 million for the organization of Ethiopia's Third International Agro-Industry Investment Forum, scheduled to take place in November 2020.
- The strategies for industrial capacity-building, the textile sector and SME cluster development will be presented to various partners for fundraising.
- The infrastructure of the four pilot IAIPs is expected to be completed in early 2020 to pave the way for private sector investment. Efforts will focus on continuing to promote investment opportunities in the four parks, in collaboration with national institutions.

- The Creative Hub for leather will be completed and inaugurated within the premises of the Federal Micro and Small Enterprise Development Agency with an innovative management framework based on a public-private partnership model.
- The Addis Ababa Coffee Training Centre will be finalized in 2020.
- The realization of the MLC will begin with the support of the EIB, the Government of Ethiopia and other development partners.

PCP SENEGAL

Progress in 2019

The PCP is integrated in the second phase of the "Plan Sénégal Emergent" (PSE) and its Priority Action Plan for 2019 to 2023. The new Action Plan recognizes "Inclusive and Sustainable Industrialization" as a strategic priority and recommends the strengthening of partnerships with UNIDO as a means to achieve SDG 9 and advance the Third Industrial Development Decade for Africa.

Partnerships and resource mobilization: The PCP Senegal has supported the Government in leveraging significant investments from financial entities and development partners, particularly for large-scale industrial projects such as the establishment of agro-poles and industrial parks. In December 2019, the AfDB and the Islamic Development Bank (IsDB) approved loan agreements of \$43 million and \$27 million respectively for the southern agro-pole, based on the feasibility study conducted by UNIDO.

In December 2019, Belgium's Development Agency, Enabel, signed a funding agreement with UNIDO over $\in 860,000$ to conduct a feasibility study for an agro-pole in central Senegal. In parallel, the AfDB and the EIB have pledged to co-finance approximately $\in 100$ million in concessional loans to the Government. The funding agreement for the feasibility study for an agro-pole in the north of the country is under finalization with the AfDB. Other areas under discussion with the AfDB include supporting the review of Senegal's industrial policy, several sectoral studies such as leather and automotive, and the establishment of a regional mining hub.

The Export-Import Bank of China has committed over \$100 million to the Government of Senegal to expand the Diamniadio industrial park. Moreover, several new UNIDO technical cooperation projects have secured funding from various sources. These include the West Africa Competitiveness Programme funded by the EU, an investment promotion and value chains programme funded by the EU and the ACP, a youth employment programme in the context of the G20 Compact with Africa funded by Germany, and a project on the mainstreaming of gender in industrial policy also funded by Germany.

Highlights of implementation in priority areas: The establishment of agro-poles gained momentum in 2019. The first feasibility study for an agro-pole in southern Senegal, conducted by UNIDO and funded by the Government of Senegal, is expected to be completed in early 2020. The AfDB and the IsDB have already committed funding the development of the agro-pole. The other two studies, for which funding agreements are being finalized, will focus on the setting up of agro-poles in northern and central Senegal, and will start in 2020. In addition, Germany agreed to fund a UNIDO project supporting vocational training and job creation around the southern agro-pole in Senegal.

The Diamniadio industrial park is increasingly attracting tenant companies. As of December 2019, the park hosts 14 companies and employs over 1,000 staff. An additional 30 companies have expressed interest in establishing their operations within the park. Some of the sportswear produced within the industrial park is exported to the United States of America within the framework of the African Growth and Opportunity Act. The Government of Senegal plans to enlarge the Diamniadio park by 40 hectares, to which the Export-Import Bank of China has already committed funding. UNIDO will continue providing technical expertise and advisory services as the park expands.

UNIDO supported public-private partnerships in the area of vocational training through South-South cooperation. In the course of 2019, young women and men from Senegal participated in a training programme at the Training Academy for Heavy Duty Equipment and Commercial Vehicles in Morocco. This is part of a public-private development partnership initiated between the United States Agency for International Development, the Volvo Group, the OCP Foundation, the Moroccan Ministry of National Education and Vocational Training, the "Office de la formation professionnelle et de la promotion du travail" (OFPPT), and UNIDO.

Cross-cutting issues: The PCP also supports cross-cutting issues, such as private sector development, entrepreneurship and job creation, quality support for trade facilitation, and environmental sustainability. Among

other activities, UNIDO is promoting the integration of renewable energy, waste management and sustainable industries in the Diamniadio industrial park as part of the Sustainable Cities Initiative, which is jointly implemented by the World Bank and UNIDO in the context of the Global Environment Facility (GEF) Integrated Approach Pilot. In October 2019, France approved the co-financing of a solar power plant that will cover 60 per cent of the energy needs of the Diamniadio industrial park. In addition, UNIDO works with local communities to help them improve land management and climate resilience in partnership with IFAD and GEF.

Outlook for 2020

UNIDO will continue working with the Government and other partners in the implementation of PCP focus areas and cross-cutting activities. Priorities in 2020 include the finalization of the feasibility studies for the three agropoles, the further development of industrial parks, the review of Senegal's industrial policy, conducting sectoral studies (leather and automotive), as well as a feasibility study on the potential of a regional mining hub. In addition, UNIDO will work closely with the EIB in the organization of the "Africa Day 2020" in Dakar and an investment forum in November 2020.

UNIDO will continue to support the PCP National Steering Committee in coordinating and guiding the implementation of the industrial policy, and reinforcing industrial partnerships. An independent terminal evaluation of the PCP Senegal will launch in 2020, which will determine the way forward.

PCP PERU

Progress in 2019

Governance and coordination: In November 2019, a presidential decree officially established the refined governance structure of the PCP national coordination body, the Multi-sectoral Commission.

Policy advisory services: The PCP supported the Government in formulating a national Strategy for Industrial Park Development, which launched in December 2019. The Strategy is integrated in Peru's new national Competitiveness and Productivity Policy for 2019–2030.

UNIDO's technical expertise and advisory services also supported the development of a national road map for circular economy. The national validation and consultation process launched at the end of 2019. As part of this, UNIDO and Peru's Technological Institute of Production conducted a joint study on the integration of circular economy in the operations of the Centres for Productive Innovation and Technology Transfer (CITEs).

In 2019, the Government of Peru requested UNIDO's support in the formulation of a national industrial development policy as well as national guidelines for the establishment of science and technology parks (STPs). UNIDO began collaborating with the National Council of Science, Technology and Technological Innovation to design the national technical guidelines for the establishment of the STPs.

Policy advice provided through the PCP will also support the Government in the area of women's economic empowerment related to industry. The Peru component of the "Global Programme Economic Empowerment of Women in Green Industry" launched in 2019 and involves Peru's Ministry of Production, Ministry of Environment, and Ministry of Women and Vulnerable Populations. In addition, UNIDO and the World Association of Women Entrepreneurs (FCEM) signed a joint declaration on cooperation in the field of women's economic empowerment, circular economy and resource efficiency on the occasion of the 67th FCEM World Congress held in Lima in November 2019.

Partnerships and resource mobilization: UNIDO's technical portfolio in Peru amounted to \$8.5 million in 2019. This includes a GEF-funded project on sustainable industrial zone development with \$44 million expected in public and private co-funding.

Strengthening cooperation with financial institutions was a focus in 2019, in particular with the National Development Bank (COFIDE). UNIDO and COFIDE are establishing a cooperation framework to support industrial park development, innovation, and to establish credit schemes for SMEs in industrial zones. The Development Bank of Latin America and the Inter-American Development Bank have also voiced interest in supporting PCP projects, industrial policy development, and the implementation of the new strategy for industrial park development.

To facilitate regular engagement and consultations with the private sector, the PCP Peru Coordination Office relocated to the premises of the National Association of Industries (SNI) in February 2019. To formalize this

enhanced collaboration, UNIDO and the SNI signed a joint declaration on the promotion of PCP activities in June 2019.

The Investment and Technology Promotion Office (ITPO) of the Republic of Korea allocated \$350,000 for the promotion of investment opportunities in Peru, as part of the ITPO advisory programme. By the end of December 2019, 100 Peruvian SMEs were identified for potential ventures with Korean investors.

Several new technical projects are in the pipeline. Among these, a \$2 million project for eco-industrial park development in Peru will launch in 2020. This project is part of UNIDO's "Global Eco-industrial Parks Programme in Developing Countries" funded by the State Secretariat for Economic Affairs (SECO) of Switzerland. In June 2019, the GEF Council approved a project proposal aimed at addressing the biodiversity and conservation of Amazonian forests. This is a joint endeavour between UNIDO, FAO and IFAD. UNIDO will implement around \$6 million of the \$17 million total of the proposed project.

Implementation highlights in PCP priority areas:

Quality and innovation: UNIDO is implementing a four-year project to improve Peru's export competitiveness in the coffee and cocoa sector, initially focusing on the San Martin region. An analysis of the quality infrastructure along the coffee and cocoa value chains is being finalized.

Value chain and enterprise development: In 2019, GEF approved the joint UNIDO-FAO-IFAD project proposal on "Building human well-being and resilience in Amazonian forests by enhancing the value of biodiversity for food security and bio-businesses, in a context of climate change" for further development.

Sustainable industrial parks: The implementation agreement on the sustainable industrial zone project was signed by the Director General of UNIDO and Peru's Ministry of Production during the eighteenth session of the UNIDO General Conference in November 2019. A project management unit was established and the workplan for 2020 is being finalized.

UNIDO, the Ministry of Production and SNI organized Peru's first international conference on "Industrial Parks for Inclusive and Sustainable Industrial Development" in June 2019 in Lima. The event served to share international experiences and know-how on different aspects of industrial parks, including government policies, financial tools, private sector initiatives, eco-industrial parks, circular economy business practices, and applications of Industry 4.0. It brought together 800 participants from more than 30 countries.

Resource and energy efficiency, and renewable energy: UNIDO assessed the capacity-building needs of CITEs in terms of circular economy and innovation and presented the results of the study to counterparts in December 2019, as part of a project on the mainstreaming of energy and environmental dimension in the PCP Peru.

Outlook for 2020

UNIDO will focus on enhancing national PCP monitoring and coordination capacities, strengthening linkages between the PCP and the priorities of the Government's new National Competitiveness and Productivity Policy, finalizing and launching pipeline projects, and providing cross-cutting policy advice including for the formulation of a national industrial policy. In 2020, UNIDO will also support the Government in setting-up a PCP Partner and Donor Working Group.

PCP MOROCCO

Progress in 2019

Signing of the programme document and national commitment: The Director General of UNIDO and Morocco's Minister of Industry, Investment, Trade and Digital Economy signed the finalized PCP programme document at an official ceremony held in Rabat in March 2019. A trust fund agreement was signed on this occasion, confirming the Government's financial commitment to the PCP. In the course of 2019, UNIDO advanced in the development of nine new technical projects to support the priority areas of the PCP in view of starting its implementation in 2020.

Partnerships and resource mobilization: UNIDO carried out various activities to mobilize partners and identify concrete cooperation opportunities as the PCP moves towards implementation in 2020. UNIDO conducted a mapping exercise, in particular for collaboration with financial institutions and the business sector, and, together with the Government, held meetings on cooperation prospects with various bilateral and multilateral partners.

Financial entities interested in cooperation through the PCP include the AfDB, the European Bank for Reconstruction and Development (EBRD), the EIB, the IsDB and the World Bank Group. Cooperation with the AfDB is ongoing on the industrial zones component of the PCP.

Partnership prospects are also being explored with the following partners: China's Department of International Cooperation of the General Administration of Customs; the French Development Agency; the EU; Enabel; the Millennium Challenge Agency; as well as the Governments of Austria, Belgium, Denmark, Germany, Japan, Norway, the United Kingdom of Great Britain and Northern Ireland, the Republic of Korea, Spain, and Sweden.

UNIDO also participated in several key industry events in Morocco to promote the PCP and potential partnerships. This included "Industry Meeting Day 2019", the largest annual national conference on the industrial sector, the country's first Forum on Industrial Parks and the first Global Industry 4.0 conference held in Morocco.

Closer synergies were also established with the national private sector and international enterprises. UNIDO developed a proposal to set up a Partnership Platform for Inclusive and Sustainable Industrial Development, requested by the National Confederation of Moroccan Enterprises.

Outlook for 2020

The implementation phase of the PCP Morocco is expected to commence in 2020. A PCP Committee for Funds Mobilization will be established to lead and coordinate resource mobilization efforts. A Morocco Investment Forum is planned for 2020 to promote investment opportunities in key industrial sectors and projects.

PCPs IN PROGRAMING

PCP CAMBODIA

Progress in 2019

The PCP Cambodia is in the final stage of the programming phase. Several projects are already in implementation supporting the identified priority areas and cross-cutting activities. Over \$20 million was mobilized for UNIDO technical projects within the PCP, in particular for industrial policy support, industrial statistics, the fisheries value chain, the development of special economic zones (SEZs), and the promotion of clean technologies. Additional projects are in development.

Partnerships and resource mobilization: A partner briefing, led by Cambodia's Under State Secretary of the Ministry of Economy and Finance and the Secretary-General of the high-level Economic and Financial Policy Committee, was organized at UNIDO's headquarters in Vienna in September 2019. The briefing provided an update on PCP progress and discussed new collaboration opportunities. In addition to ongoing partnerships with China, the EU, Germany and the Republic of Korea, interests in cooperating through the PCP were expressed by Japan, Norway and Switzerland in areas such as skills development, investment promotion, technology transfer, and SEZ development.

New partnerships were initiated with the General Administration of Customs of the People's Republic of China (GACC) and the China State Administration for Market Regulation to support Cambodia in meeting international standards for the export of agro-products. The Ministry of Agriculture, Forestry and Fisheries, GACC and UNIDO signed a joint declaration in June 2019, which led to the establishment of a tripartite technical working group on export-related compliance issues.

Building on its long-standing experience in the development of SEZs, the Urban Planning and Design Institute of Shenzhen (UPDIS) of China is supporting Cambodia in the development a master plan for a multi-purpose SEZ in the province of Sihanoukville. The Government has committed over \$3 million in national funds towards this endeavour and is working with UNIDO to mobilize the resources for this master plan.

Highlights of technical assistance and policy advisory services: As part of the PCP priority area on agroindustry value chains, a large-scale fisheries programme was launched in 2019. UNIDO will support the Government in developing the fishery sector through a €16 million five-year programme funded by the EU (CAPFish). The new programme focuses on strengthening national control systems, increasing the capacities of the private sector to comply with international standards and market requirements, and enhancing overall business competitiveness. Industrial diversification, in particular through SEZs, is being supported through the partnership with the UPDIS of China. UPDIS conducted a preliminary study to develop the masterplan concept, which the Government subsequently approved. Other cross-cutting activities include skills development, the promotion of clean technologies, investment promotion activities, and ongoing industrial policy advice.

UNIDO's policy advice and technical expertise supported the Government in designing the next phase of Cambodia's Trade Integration Strategy covering the period 2019 to 2023, with a particular focus on quality infrastructure and conformity assessment services, skills development and e-commerce. PCP Cambodia is also supporting the Government in enhancing national capacities for policy design, monitoring and evaluation. This is being done through a capacity-building project of \$1.2 million funded by the Republic of Korea. A complementary project, funded by China, is helping to develop industrial statistics and monitor the PCP's contribution to the implementation of the national industrial development policy (IDP) and progress towards the Sustainable Development Goals (SDGs).

Outlook for 2020

Priorities in 2020 include the operationalization of the PCP's national coordination body, the finalization and signing of the PCP Cambodia programme document, and the subsequent start of the implementation phase. Advancing the development of the master plan for the Sihanoukville province will be among the prioritized large-scale interventions of the PCP. Technical interventions and resource mobilization activities will continue, with new interventions to be developed in areas such as the tourism industry and digitalization for industrial diversification.

PCP KYRGYZSTAN

Progress in 2019

Approval of the national industrial development strategy: On 27 September 2019, the Prime Minister of Kyrgyzstan signed a government decree approving the new Sustainable Industrial Development Strategy for 2019–2023 and its accompanying Action Plan, both developed with the support of UNIDO.

Revision of the PCP Kyrgyzstan programme document and alignment of priority areas: The draft PCP Kyrgyzstan programme document was revised in line with the new priorities of the Strategy. UNIDO submitted the revised programme document to the Government for approval in November 2019.

PCP Kyrgyzstan will focus on five prioritized sectors: (i) Energy; (ii) Agro-processing with a focus on food and beverages; (iii) Construction materials; (iv) Textiles and apparel; and (v) Sustainable tourism. In addition, it will address cross-cutting issues such as institutional capacity-building, access to finance and investment promotion, export promotion and quality infrastructure, regional development, environmental sustainability, and gender mainstreaming.

Ongoing technical cooperation activities: UNIDO is implementing several technical projects that align with the upcoming priority areas of the PCP Kyrgyzstan. An ongoing project focuses on the energy sector, in particular small-hydropower development. Another project seeks to improve market access for SMEs involved in the fruits value chain, as part of the Switzerland-funded Global Quality and Standards Programme. In addition, a UNIDO project has been strengthening linkages between the tourism industry and productive activities in the Issyk-Kul region over the last four years.

Outlook for 2020

Next steps include the setting up of a national coordination body, the official signing of the programme document once approved by the government, and ongoing resource mobilization activities in view of starting implementation in 2020.

PCPs IN EARLY PROGRAMING

PCP CÔTE D'IVOIRE

Background

In October 2018, the Executive Board of UNIDO approved the development of the PCP for Côte d'Ivoire. In March 2019, the Director General went on an official visit to Côte d'Ivoire to discuss the next steps for the realization of the PCP. The Director General met with representatives of the Government of Côte d'Ivoire who confirmed their commitment to the PCP, including the President of Côte d'Ivoire, Alassane Ouattara, the Vice-President Daniel Kablan Duncan, and the Prime Minister, Amadou Gon Coulibaly.

Progress in 2019

National commitment and resource allocation: In August 2019, the Prime Minister of Côte d'Ivoire, through an official letter to the UNIDO Director General, committed a national contribution of €120,000 to support the programming phase of the PCP. This commitment was reaffirmed on the occasion of UNIDO's Seventh Inclusive and Sustainable Industrial Development (ISID) Forum, held in November 2019, through a signing ceremony and an exchange of letters between the Director General and the Minister of Trade and Industry of Côte d'Ivoire.

Governance and coordination: A national coordination body (NCB) is being set up under the chairmanship of the Prime Minister's Office. The Government has endorsed the terms of reference for the NCB, which were developed with the support of UNIDO. The inter-ministerial composition of the NCB and private sector representation have been agreed upon.

In addition to the NCB, a Partner and Donor Working Group (PDWG) will be established. The Ministry of Economy and Finance and the Ministry of Trade and Industry will co-chair the PDWG, which will include technical and financial development partners, the private sector, financial institutions and United Nations entities. The government is reviewing the terms of reference of the PDWG.

Partnerships and resource mobilization: Partner engagement activities are ongoing, in particular with the following institutions: AfDB; Agence Française de Développement; EIB; the EU; West African Development Bank; and the World Bank. The PCP was also presented to the United Nations Country Team (UNCT). Once established, the PDWG will facilitate funds mobilization, coordination and synergy of partner interventions. A funds mobilization strategy is under development with the Ministry of Economy and Finance and the Ministry of Trade and Industry.

UNIDO signed joint declarations with the Chamber of Industry and Commerce of Côte d'Ivoire, the General Confederation of Ivorian Enterprises, and the Federation of Ivorian Small and Medium Enterprises at the occasion of the Director General's visit to the country in March 2019. These partnership agreements will support the design, programming and implementation of the PCP.

Programming initiated: Based on consultations with the Government, four tentative PCP focus areas were identified to support the implementation of the country's National Development Plan (2017–2020) and Social Development Programme (2018–2020): (i) ISID governance, competitiveness and innovation; (ii) Eco-industrial parks; (iii) Agro-industry; and (iv) Circular economy. Cross-cutting interventions will comprise skills development, including skills related to Industry 4.0, and investment promotion.

Outlook for 2020

In 2020, UNIDO will conduct a country diagnostic as part of the PCP's programming phase. The results of the diagnostic will help finalize the priority areas and develop a full-fledged PCP programme document. The national coordination mechanisms (NCB and PDWG) will be established and operationalized. In parallel, UNIDO will work closely with the government and the UNCT in the design of the upcoming United Nations Sustainable Development Cooperation Framework (2021–2025) and the next phase of the Government's National Development Plan (2021–2025), thus ensuring full alignment of the PCP.

PCP EGYPT

Background

In October 2018, the Executive Board of UNIDO approved the development of the PCP for Egypt. In December 2018, the Director General met with the President of Egypt, Abdel Fattah Al-Sisi, and other key stakeholders during an official visit to the country, during which the Government reaffirmed its full commitment to this new phase of collaboration with UNIDO. The Government of Egypt also pledged to allocate national funds to PCP programming. The PCP will support the national sustainable development strategy, "Egypt Vision 2030", and the implementation of its industrial roadmap for the period 2020–2025.

Progress in 2019

Governance and coordination: The PCP inter-ministerial national coordination body (NCB) was established and held three meetings in the course of 2019. The Prime Minister's Office chairs the NCB, which is composed of representatives from all relevant ministries and national authorities.

Programming: UNIDO initiated the programming phase in 2019, in close collaboration with the Government of Egypt. A country diagnostic was conducted to define the priority areas of the PCP and guide the formulation of a

comprehensive programme document and related technical interventions. The results of the diagnostic will support the development of Egypt's industrial roadmap for the period 2020–2025. The diagnostic will be finalized early 2020.

Tentative priority areas for the PCP Egypt were identified as: (i) Industrial policy and governance; (ii) Investment promotion; (iii) Green industry; (iv) Smart cities and sustainable parks; (v) Sectoral value chains; and (vi) Industry 4.0. Egypt's regional integration will form a cross-cutting element of the PCP.

In December 2019, the Director General again met with the President of Egypt to discuss the PCP. They agreed to expedite the programming phase and move the PCP into implementation in early 2020.

Partnerships and resource mobilization: The PCP has engaged the United Nations development system, donors, financial institutions and the private sector from the onset of programming. UNIDO and the Government jointly organized several round tables in Egypt to raise awareness on the PCP and identify collaboration opportunities. In September 2019, the United Nations Resident Coordinator in Egypt and UNIDO hosted a workshop for representatives of the Afreximbank, the EBRD, IFAD, and the World Bank Group.

In June 2019, UNIDO organized a national consultation workshop that brought together the private sector, government institutions and academia to discuss cooperation opportunities. On the occasion of the Director General's mission to Egypt in December 2019, the President of the Federation of Egyptian Industries also indicated a strong interest in participating in the PCP.

Outlook for 2020

The NCB is expected to validate the findings of the country diagnostic in early 2020. This will guide the development of a comprehensive programme document, which is expected to be signed by UNIDO and the Government of Egypt within the first quarter of 2020. UNIDO's PCP team will conduct missions to Egypt to formulate detailed technical interventions within PCP priority areas, in parallel to ongoing resource and partnership mobilization efforts.

PCP RWANDA

Background

In October 2018, the Executive Board of UNIDO approved the development of the PCP for Rwanda. The PCP will support the implementation of the National Strategy for Transformation (2017–2024) and the Government of Rwanda's "Vision 2050".

Progress in 2019

Programming initiated: UNIDO conducted several missions to the country in the course of 2019 to discuss the PCP with the Government. The initial PCP request to UNIDO from June 2018 identified the proposed priority areas of the programme, however, following a reshuffle in the Government, there was a need to reconfirm the priorities of the PCP.

A PCP roadmap was developed and the tentative priority areas reconfirmed with the new administration. The proposed focus areas are: (i) Integrated agro-industrial parks, particularly for fruits and vegetables; (ii) Livestock value chain development; (iii) Garments; and (iv) Industry 4.0. Cross-cutting areas will include technological upgrading to leapfrog in the areas of industrialization, circular economy, and quality control and enhancement. UNIDO has established a multi-disciplinary PCP team to formulate the programme.

Governance and coordination: Discussions were held with the Government on the national coordination structure and its composition, as well as on national in-kind and financial resource allocations to the PCP. Three levels of coordination were identified for the PCP: (i) Ministerial-level coordination through a National Steering Committee; (ii) Specific task forces with a strong private sector presence; and (iii) Project steering committees. The PCP coordination and steering structure will provide strategic direction and oversee overall implementation of PCP activities, coordination of resource mobilization efforts, and the sequencing and prioritization of programme activities.

The Government of Rwanda has committed in-kind contributions to PCP programming as well as funding for the realization of the integrated-agro industrial parks. In November 2019, Rwanda's Minister of Trade and Industry met with the UNIDO PCP Rwanda Programme Manager to discuss the way forward. The Government expressed its commitment to allocate the required resources for infrastructure development and strengthening coordination efforts for industrialization in the country.

Partnerships and resource mobilization: A number of partners have already expressed their interest to support the PCP Rwanda, including: the AfDB, the Government of China, the Government of the United Kingdom of Great Britain and Northern Ireland, the EU, the Republic of Korea, and United Nations Development Programme (UNDP).

UNIDO is an active member of the UNCT in Rwanda and acts as co-chair of the Economic Transformation Results Group, along with UNDP. The PCP for Rwanda will align with and support the United Nations Development Assistance Plan for 2018–2023.

Outlook for 2020

In 2020, UNIDO will conduct a country diagnostic, which will help to finalize the PCP priority areas and develop a programme document. UNIDO will organize formulation missions to Rwanda to finalize the programming phase and identify synergies and resource mobilization opportunities with various partners. The national coordination body is expected to be formally established by mid-2020.

PCP ZAMBIA

Background

In October 2018, the Executive Board of UNIDO approved the development of the PCP for Zambia. The PCP will support the implementation of the Seventh National Development Plan (2017–2021), its national industrial policy, and the Government of Zambia's "Vision 2030", which aims to transform Zambia into a middle-income nation by 2030.

Progress in 2019

Programming initiated: UNIDO conducted several missions to the country in the course of 2019 to discuss the PCP with the Government and partners, and identify tentative PCP areas. UNIDO also held regular consultations with the Permanent Mission of Zambia to the United Nations Office and other international organizations in Geneva.

Three tentative PCP priority areas were identified: (i) Improving the policy environment; (ii) Industrial skills development; and (iii) Promoting value addition in light manufacturing.

Governance and coordination: Discussions were held with the Government on the national coordination body (NCB) and its composition. The NCB will include all relevant ministries as well as the Central Statistics Office, the Zambia Development Agency, and the national Chamber of Commerce and Industry. The Government has committed in-kind and financial resources towards the PCP.

Partnerships and resource mobilization: There is a significant potential for resource mobilization in Zambia and discussions with potential PCP partners have been ongoing. This includes the AfDB, IFAD, Swedish International Development Agency (SIDA), and World Bank.

The OPEC Fund for International Development and China are jointly supporting the development of Zambia's energy sector through an existing UNIDO project focused on upscaling hydropower and solar renewable energy. A strong partnership already exists with SIDA and the Volvo Group as part of an ongoing public-private partnership project supporting the Zambian Industrial Training Academy.

Outlook for 2020

In 2020, UNIDO will conduct a country diagnostic, which will help to finalize the PCP priority areas and develop a programme document. The national coordination body is expected to be established in the first quarter of 2020. The EU-funded regional investment programme, which includes Zambia as part of the ACP states, will launch in early 2020.

In terms of industrial policy advice, UNIDO will follow-up on the Government's requests to support the formulation and implementation of a national strategy for the pharmaceutical sector, the revision of the existing policy on the development of micro, small and medium enterprises, and the establishment of a national Industrial Statistics Observatory.






