# Statement of Pakistan for the 48<sup>th</sup> Session of the Industrial Development Board of UNIDO (23-25 November 2020, Vienna)

### Mr. President,

We thank the Director General for the Annual Report for 2019 which provides an overview of the activities and achievements of UNIDO and the challenges faced by the organization during the past year.

We would like to mention that Pakistan has always been paying its assessed contribution in time, despite financial challenges at times in our country. We would also like to encourage the Member States for timely payment of their assessed contributions which are necessary for maintaining a stable financial outlook for UNIDO.

Pakistan would like to congratulate UNIDO for its recent accreditation to the Green Climate Fund (GCF) which is the world's largest dedicated fund helping developing countries reduce their greenhouse gas emissions and enhance their ability to respond to climate change.
