Report by the Director General

I. Introduction

- 1. The General Conference, in its resolution GC.18/Res.7, requested the United Nations Industrial Development Organization (UNIDO) to organize consultations on circular economy for experts from Member States with a view to facilitate exchanges on best practices, emerging innovations and the promotion and adoption of circular economy principles and practices by industries of Member States.
- 2. Prior to the global consultations, a series of regional preparatory meetings was convened in November 2020 to allow Member State representatives and other stakeholders to present their initial views on the topic of circular economy and identify issues to shape the debate at the global consultations.


II. Organizational and procedural matters

3. The global consultations on circular economy were held virtually from 10 to 12 May 2021.

Participation

4. The following 63 Member States of UNIDO participated in the consultations: Angola, Argentina, Armenia, Austria, Bahrain, Bangladesh, Bosnia and Herzegovina, Brazil, Cambodia, Chile, China, Colombia, Costa Rica, Côte d'Ivoire, Dominican Republic, Eswatini, Georgia, Germany, Ghana, Guatemala, Hungary, India, Indonesia, Iran (Islamic Republic of), Iraq, Israel, Italy, Japan, Jordan, Kenya, Kuwait, Lebanon, Madagascar, Malaysia, Mauritius, Mexico, Morocco, Nepal, Nicaragua, North Macedonia, Oman, Pakistan, Panama, Paraguay, Peru, Philippines, Poland, Republic of Moldova, Romania, Serbia, Slovenia, South Africa, Spain, Sri Lanka, Sudan, Syrian Arab Republic, Thailand, Tunisia, Turkey, Ukraine, Uruguay, Venezuela (Bolivarian State of), and Zambia.
