My delegation welcomes the 2021 Annual Report and is pleased to note the steady progress made towards our common goal of "inclusive and sustainable industrial development (ISID)" and SDG No.9, namely, "Build resilient infrastructure, promote inclusive and sustainable industrialization, and foster innovation". We view the technological innovations as an effective means to support the ISID and achieve SDG No.9 in the post-pandemic world, and commend UNIDO's efforts to adapt itself to the evolving digital environment as its new motto says, "progress by innovation".

In this regard, the Republic of Korea and UNIDO together have initiated a project on Science, Technology and Innovation framework to support UNIDO creating a policy and research programme. We hope that this project assists UNIDO in better utilizing science, technology and innovation for the achievement of ISID and SDG No.9. The COVID-19 pandemic and the armed conflict in Ukraine have disrupted the global value chains, having an impact on the availability of food, energy and other important commodities. The high inflation would increase the operating cost, affecting the financial situation of UNIDO. To overcome this challenge, the operations by UNIDO should be more predictable and effective. The resources should be allocated to high-priority tasks first, then to low-priority ones. We believe that re-organization of UNIDO under leadership of the Director General would enhance overall efficiency of the organization. In this regard, my delegation encourages Member States to pay their assessed contributions on time and in full in order to improve the Organization's financial situation.

In closing, the Republic of Korea would like to reiterate its strong support and firm commitments to the common goals and objective shared by UNIDO. We are looking forward to continuing the cooperation with the Organization and
