Preparations for the twentieth session of the General Conference

Report by the Director General

The present report provides general information on the organization of the work of the twentieth session of the General Conference, including items proposed for inclusion in the provisional agenda.

I. Introduction

1. The General Conference of UNIDO is the principal organ of the Organization, consisting of representatives of all Members (Articles 7.1 and 8.1 of the Constitution). The main functions of the Conference are stipulated in Article 8.3 of the Constitution. In particular, the Conference should determine the guiding principles and the policies of the Organization. Unless it decides otherwise, the Conference is to hold a regular session every two years, at the seat of the Organization (Article 8.2). The last regular session (nineteenth) of the Conference was held in Vienna, 29 November to 3 December 2021.


II. Background information

A. Date and place of the Conference

2. In line with General Conference decision GC.19/Dec.18, the twentieth session of the General Conference will be held in Vienna from 27 November to 1 December 2023. It is planned that the meetings of the General Conference will take place in a hybrid format, combining in-person attendance in the M-building of the Vienna International Centre with virtual attendance on the interprefy platform.

For reasons of sustainability, this document has not been printed. Delegates are kindly requested to refer to electronic versions of all documents.







B. Budgetary matters

- 3. The Organization's resources available for holding the twentieth session of the Conference, as provided for in the programme and budgets of UNIDO, 2022–2023, total €1,023,300. The budget of the Conference is based on the following:
- (a) The session will last five working days providing for 10 plenary meetings as well as meetings of the main committee and geographical groups;
- (b) The session will be held in a hybrid format, combining in-person attendance with virtual participation;
- (c) Interpretation for plenary and main committee meetings and pre-session documentation will be provided in six languages (Arabic, Chinese, English, French, Russian and Spanish); and
- (d) As per Board decision IDB.46/Dec.3 (e), written summary records will be replaced with digital records for the twentieth session of the Conference.

C. Agenda

- 4. In accordance with Article 9.4 (g) of the Constitution, the Board prepares the provisional agenda for each session of the General Conference. Rule 13 of the rules of procedure of the Conference provides guidelines for the contents of the provisional agenda of a regular session of the Conference. Furthermore, in accordance with rule 12, the Board shall prepare that provisional agenda on the basis of a list of items proposed for inclusion as submitted by the Director General.
- 5. Annotations indicating briefly the history of each item, the proposed documentation, the substance of the matter to be discussed and earlier relevant decisions by the Conference or other organs of the Organization will be issued following the fifty-first session of the Board.
- 6. A list of items proposed for inclusion in the provisional agenda for the twentieth session of the Conference is contained in annex I to the present document, together with an indication of relevant mandates for the items. A provisional schedule of work will be elaborated, taking into account the outcome of the fifty-first session of the Board.

D. Documentation

7. In accordance with rule 23 of the rules of procedure of the Conference, documents required for consideration of items on the provisional agenda will be distributed by the Director General in all languages of the Conference to all recipients of the agenda not later than forty-five days before the opening date of the session.

III. Organization of the work of the Conference

- 8. In keeping with practice of previous sessions of the General Conference, an overarching theme will be developed for the twentieth session.
- 9. As encouraged by the Conference in resolution GC.9/Res.1, a forum on industrial development issues shall be part of the Conference's sessions. Following the adoption of the Lima Declaration at the fifteenth Conference and in line with the successful approach of the last four sessions in 2015, 2017, 2019 and 2021, UNIDO's ISID Forum has been incorporated into the plenary of the Conference as the principal element of the forum on industrial development issues, complemented by the launch of the Industrial Development Report (IDR). At the twentieth session, the ISID Forum is planned for the second plenary meeting, while the launch of IDR is planned for the sixth plenary meeting. The forum events will provide participants with an opportunity

to engage in a high-level dialogue on various aspects of industrial development, communicate their views on selected topics that facilitate thematic and interregional debates, exchange knowledge, forge partnerships, and shape strategies for advancing ISID. In line with resolution GC.9/Res.1, it is suggested that these two events be included in the provisional agenda of the session under the title "Forum on industrial development issues".

- 10. To focus the debate on critical issues, and in line with past practice, a speaking limit is proposed for interventions under general debate of five minutes for Member States and ten minutes for Government Ministers and regional groups. Furthermore, in line with the practice introduced in 2020 for the Programme and Budget Committee and the Industrial Development Board, delegations to the General Conference will be given the opportunity to provide pre-recorded video messages.
- 11. At its previous sessions, the Conference established a main committee to which it allocated a number of agenda items. The Board may wish to recommend to the Conference a similar procedure for its twentieth session, keeping in mind that the possibility of creating additional committees is constrained by the limited resources available (see para. 3 above). Items 7 to 23 of the proposed draft agenda would thus be referred to the main committee for a more focused debate aimed at the preparation of consensus draft decisions and resolutions for submission to the plenary.
- 12. The work of the previous sessions was also facilitated by pre-session informal consultations under the guidance of the President of the Board. Similar informal consultations, composed of representatives of permanent missions to UNIDO in Vienna, were convened prior to previous sessions of the Conference and prepared a report to the Conference containing recommendations that cover most of the items on the agenda, as well as organizational matters.
- 13. Taking into consideration past experiences, the Board may wish to suggest the early commencement of informal consultations chaired by the President of the Board. To facilitate the work of the informal consultations in advance of the General Conference, it is strongly recommended to adopt the successful approach of other organizations in establishing a deadline for the submission of draft decisions and resolutions of three weeks prior to the Conference.

IV. Action required of the Board

- 14. The Board may wish to consider adopting the following draft decision:
