# MONDAY, 27 November 2023

# 1<sup>st</sup> PLENARY MEETING (morning)

# Item 1: Opening of the twentieth session

The Conference was opened by H.E. Mr. Mohamed Mezghani (Tunisia), President of the nineteenth session of the General Conference, who made a statement.

The Conference observed a minute of silence, in accordance with rule 71 of the rules of procedure of the Conference.

# Item 3: Adoption of the agenda

Having suspended rule 42 of the rules of procedure of the Conference for the day, the Conference adopted the agenda as contained in document GC.20/1.

#### Item 1: Election of officers

The request to include Palau amongst the Asian States in List A and South Sudan amongst African States in List A of the Lists of States included in Annex I of the Constitution of UNIDO was adopted without objection.

The new priorities of ending hunger, promoting sustainable supply chains and climate action lie at the heart of the multi-stakeholder dialogue of the Forum, since achieving an inclusive and sustainable industrial development, and by extension the Sustainable Development Goals (SDGs), calls for a broader range of resources than any single development partner can individually provide.

# <u>Industrialization in middle-income countries: A driving force for sustainable development</u>

Many MICs remain in the "middle-income trap" and face issues of poverty and inequality, access to finance, especially concessional finance, human capacity-building, and limited infrastructure and technology. Recent global shocks have further amplified the vulnerabilities of MICs, constraining their progress towards sustained

development. Over the past 50 years, MICs have become the source of almost 50 per cent of global industrial production. However, to further their structural transformation and sustainable development agendas, MICs also need support in moving forward with the green transition. According to the World Bank country classification by income level, 105 UNIDO Member States are MICs. They constitute the largest grouping of countries the Organization assists to accelerate sustainable industrial development.

The session will build on the outcomes of a side event jointly organized by UNIDO and the Like-Minded Group for Middle-Income Countries on the occasion of the in-depth review of SDG 9 during the 2023 high-level political forum on sustainable development, held in New York. It will also build on the momentum of the recent global discussions on development cooperation with MICs held at the SDG Summit, as well as the Eighth Ministerial Meeting of the Like-Minded Group for Middle-Income Countries held on the margins of the seventyeighth session of the United Nations General Assembly.

#### Industrial policy for a fair globalization: Insights from the Industrial Development Report 2024

The Industrial Development Report (IDR) is a bi-annual flagship publication and the major research output of UNIDO. The report covers the latest developments and trends in the area of industrial development in a global context, while each issue also focuses on different relevant aspects of industrial development.

The IDR 2024 addresses the theme of "Turning Challenges into Sustainable Solutions - The New Era of Industrial Policy". Increasing global awareness on industry's fundamental role in tackling key challenges of our time goes hand in hand with a strong resurgence of industrial policy. A resurgence that is primarily driven by the most industrialized countries of the world, which are taking the lead in the implementation of ambitious industrial policy packages and strategies to tackle development challenges. To achieve fair globalization, developing countries should match these efforts to avoid being sidelined in the global industrial landscape, deepening an already alarming global divide. Solidarity and political will are needed to make fair globalization happen.

The IDR 2024 assesses the progress made so far by different developing regions in the achievement of selected SDGs and highlights the role that industry can play in supporting this process. The report also portrays the current industrial policy landscape of each region and identifies areas of opportunity for future industrial policy actions to further accelerate progress. Through this comprehensive approach, the report provides valuable insights and actionable recommendations to catalyse progress toward the SDGs and to harness the transformative power of industrial development in shaping inclusive, resilient and sustainable societies.

During the event, the main findings and messages of the report will be presented and discussed with a panel of prominent global experts and regional leaders. This discussion is expected to contribute to international efforts to accelerate the achievement of the SDGs by advocating for SDG-driven industrial policies.

# Other thematic events

#### Driving a just hydrogen transition: Key enablers for clean hydrogen uptake and de-risking of investments

Clean hydrogen is being promoted as the fuel of the future for being clean, storable and portable. While it can serve as a clean energy carrier and storage option for renewable energy, clean hydrogen also has the potential to substitute fossil fuel to decarbonize hard-to-abate economic activities and creates unique opportunities for a netzero industrial development for developing countries that have abundant renewable power potential. Achieving the 1.5°C scenario will require reaching 518 million tons of clean hydrogen production and usage annually by 2050. A ramp-up in the deployment of financing and technical assistance across the clean hydrogen supply chain is needed for developing countries to attain the full potential of socio-economic and sustainable industrial development.

UNIDO's Global Programme for Hydrogen in Industry supports developing countries and transition economies to fully benefit from the new opportunities that clean hydrogen can contribute to net-zero industrial development and local value addition. It paves the way for job creation, skills upgrading and investment mobilization, and helps drive the development of a diversified and knowledge-based economy.

#### Climate Action: Accelerating the green transition: Critical minerals, metals production and a fair future for all

Climate action and the transition to a net-zero economy will be metal-intensive: the production of minerals such as cobalt, graphite and lithium could increase by 500 per cent by 2050 in response to a growing demand for clean energy technologies. Ensuring responsible metal and mineral supply chains is a major priority in the international agenda and UNIDO has the technical expertise to assume a thought leadership and convening role.

During a Ministerial Roundtable at the second edition of the Future Minerals Forum in 2023, a key initiative for critical mineral and mining organized by the Ministry of Industry and Mineral Resources of Saudi Arabia, the Director General of UNIDO called for the establishment of a Global Alliance for Responsible Minerals. By forging such a multi-stakeholder global alliance, UNIDO would contribute to the advancement of responsible mining for the green transition and a fair future for all.

Responsible mining is aligned with the core objectives of integration and scale-up of UNIDO's medium-term programme framework, 2022–2025. It combines two interconnected focus areas: a) climate-neutral industry and circular economy, and b) digital transformation and innovation. Minerals are the critical resource required for green transition and digitalization. On the production side, minerals are the key inputs. With regard to technology adoption, minerals are essential for the production and procurement of chips required for the deployment of technologies.

# Building resilient supply chains for the energy transition

Promoting green industrialization and establishing sustainable value chains for low-carbon technologies is pivotal in the effort to decarbonize the energy and transportation sectors to advance towards the global net-zero target. The adoption of technologies like solar and storage batteries has surged over the last decade, yet supply chains for these technologies remain largely concentrated in a handful of countries. This dependency is particularly pronounced among lower-middle-income countries and will present a bottleneck to accelerate energy transition.

The participation of developing countries in global supply chains remains relatively limited. For instance, in the solar industry, the International Solar Alliance noted that solar manufacturing in the middle- and low-income countries remains limited and is primarily concentrated in South-East Asia. Data from the Global Wind Energy Council also reveals analogous trends in other critical value chains, such as wind and battery manufacturing, with China and the United States of America leading the production capacities, followed by the European Union member countries, Japan and the Republic of Korea.

UNIDO's Global Alliance on Artificial Intelligence for Industry and Manufacturing (AIM Global) was launched on 6 July 2023 at the World Artificial Intelligence Conference held in Shanghai, China. This pioneering initiative aims to foster the responsible, sustainable and inclusive application of artificial intelligence (AI) in the industrial sector, in accordance with the United Nations Secretary-General's call to establish a Global Digital Compact that upholds shared principles for an open, free and secured digital future for all. AIM Global is a strategic initiative emphasizing the need for collaborative action towards responsible deployment of AI in addressing global challenges, making it a cornerstone to achieve inclusive and sustainable industrial growth in an era of fair globalization.

- 11. Each Government delegation from all UNIDO Member States will be assigned a total of four (4) seats, with two (2) at the table and two (2) in the row behind. Specifically identified seating will be available for other participants in the session of the Conference. Other representations (observers, non-Member States of UNIDO but members of the United Nations, United Nations entities, intergovernmental organizations, and

non-governmental organizations) will be allocated one (1) seat at the table and one (1) in the row behind.

12. Participants are reminded that mobile telephones should be either switched off or switched to "silent" mode during all proceedings.

#### Simultaneous interpretation

- 13. In the proceedings of the plenary and the Main Committee, interventions made in any of the official languages (Arabic, Chinese, English, French, Russian, Spanish) will be interpreted into the other official languages.

Participants attending virtually on the Interprefy platform will be able to select, among the six official languages of UNIDO (Arabic, Chinese, English, French, Russian and Spanish), the language in which they would like to follow the proceedings

#### Speakers in the general debate

16. The list of speakers for the Plenary meetings was opened on 6 November 2023. As of Monday, 27 November 2023, once the Conference has started, delegates attending the session in person wishing to speak in the Plenary and who have not already signed up to the list of speakers, are requested to notify the Secretariat on site or by listofspeakers@unido.org of their intention to be inscribed on the list of speakers. When requesting the floor, delegates are requested to specify either:

When given the floor by the President or Vice-President, speakers intervening virtually are asked to use the "raise hand" function in order for the technicians to enable their stream.

- 19. Time for short statements of representatives of the United Nations, its agencies, intergovernmental and non-governmental organizations may be accommodated, to the extent possible, after the statements of the delegations within the time frame allotted for the general debate.

21. Sound recordings will be made of the meetings of the Plenary and sessional bodies as appropriate and will be made available in all six official languages on the UNIDO Extranet (http://extranet.unido.org).

# **Documents distribution**

22. As part of the Secretariat's efforts to reduce expenditure and support endeavours to limit environmental impact through the digitization of conference materials and publications, documents are only issued electronically. # **Banking services**

32. An Austrian bank (Bank Austria) with multilingual staff offers full banking services at the VIC on the first floor of building C. The bank is open Monday, Tuesday, Wednesday and Friday from 9 a.m. to 3 p.m. and Thursday from 9 a.m. to 5.30 p.m.

International ATM machines are available on the first floor of building C (C0113), and the ground floor of building D (DOE71).

Some banking services are also provided from 9 to 11.15 a.m. and from 12 noon to 5 p.m. by the post office on the first floor of the C-building.

# Language, currency and credit cards

- 33. The official language of Austria is German.
- 34. The currency unit is the euro. The euro is subdivided into cents (100 cents = 1 euro). Most hotels and many restaurants and shops accept internationally recognized credit cards.
- 35. Bank notes and travellers' cheques may be brought into Austria without restriction; however, as not all currencies are in equal demand, some might not be easily convertible. Departing visitors may take with them any foreign and local currency and securities that they brought into the country. It is recommended that visitors keep receipts for major currency exchange transactions in case they need to exchange currency again before leaving the country.

# VIC entry for official cars

- 36. Registered cars of Permanent Missions will be able to park in the VIC garage as usual. Parking facilities for non-registered cars are not available at the VIC.
- 37. Taxis are not permitted to access the premises of the VIC. Participants arriving at the VIC by taxi are advised to be dropped off in the side lane of Wagramer

Strasse, to walk up the stairs or ramp to enter through Gate 1 at the VIC and to walk across the plaza to the entrance of the M-building.

38. Participants without access to authorized cars are advised to use the excellent public transportation system, as the VIC is located directly next to the underground station "Kaisermühlen — Vienna International Centre" on the U1 line. Participants arriving at the VIC by underground transport (U-Bahn) should take line U-1 and get off at the station "Kaisermühlen-Vienna International Centre" and follow the signs to the VIC. A variety of public transport tickets are available. Tickets may be purchased at machines in every U-Bahn station throughout Vienna.

- 40. A pharmacy located next to the clinics (room F0707) is open on weekdays from 10 a.m. to 5 p.m. (extension 21599).
