Introduction

1. The report of the Industrial Development Board on the work of its fiftieth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. As per decision of the Board IDB.46/Dec.3 (e), the Secretariat continues replacing written summary records of the Industrial Development Board and the General Conference with digital records. These are available through the UNIDO Extranet.

I. Organizational and procedural matters

2. The fiftieth session of the Board was held at UNIDO headquarters, Vienna International Centre, from 21 to 23 November 2022 (seven plenary meetings). The session took place in a hybrid format involving in-person participation, as well as virtual attendance on the Interprefy conferencing platform.

Participation

3. The following 48 of the 52 members of the Board¹ were represented at the session: Algeria, Angola, Argentina, Austria, Bangladesh, Brazil, China, Costa Rica, Cyprus, Egypt, Finland, Germany, Ghana, Hungary, India, Indonesia, Italy, Japan, Kenya, Kuwait, Kyrgyzstan, Luxembourg, Mali, Malta, Mexico, Mongolia, Morocco, Namibia, Netherlands, Norway, Pakistan, Panama, Peru, Poland, the Republic of Korea, the Russian Federation, Senegal, Slovenia, South Africa, Spain, Sudan, Sweden, Switzerland, Thailand, Tunisia, Türkiye, Uruguay and Venezuela (Bolivarian Republic of).

4. The following 46 Member States of UNIDO also participated in the session: Afghanistan, Albania, Armenia, Azerbaijan, Barbados, Bolivia (Plurinational State of), Bulgaria, Burkina Faso, Chad, Chile, Colombia, Côte d'Ivoire, Croatia, Cuba, the Democratic People's Republic of Korea, the Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Iran (Islamic Republic of), Iraq, Israel, Jordan, Kazakhstan, the Lao People's Democratic Republic, Lebanon, Libya, Malaysia, Montenegro, Myanmar, Nicaragua, Oman, the State of Palestine, Philippines, Qatar, the Republic of Moldova, Saudi Arabia, Sri Lanka, the Syrian Arab Republic, Togo, Ukraine, the United Republic of Tanzania, Viet Nam, Yemen and Zimbabwe.

5. The Holy See and the Sovereign Order of Malta participated as observers.

6. The following United Nations bodies were represented: the Economic Commission for Latin America and the Caribbean (ECLAC) and the United Nations Development Programme (UNDP).

7. The following specialized agencies and related organizations were represented: the International Atomic Energy Agency (IAEA), the International Fund for Agricultural Development (IFAD) and the United Nations Educational, Scientific and Cultural Organization (UNESCO).

8. The following other intergovernmental organizations were represented: the Arab Industrial Development, Standardization and Mining Organization (AIDSMO), the Asian African Legal Consultative Organization (AALCO), the Comunidad Andina (CAN), the European Union (EU), the Gulf Cooperation Council (GCC), the International Bamboo and Rattan Organisation (INBAR), the International Centre for Genetic Engineering and Biotechnology (ICGEB), the Organisation For Economic

Co-operation and Development (OECD) and the Standards and Metrology Institute for Islamic Countries (SMIIC).

9. Opening of the session

10. The fiftieth session of the Board was declared open by the President of the forty-ninth session, H.E. Ms. Dominika Krois (Poland).

Officers of the session

11. In accordance with rule 23 of its rules of procedure, the Board elected by acclamation H.E. Mr. Alejandro Edmundo Solano Ortiz (Costa Rica) as President, H.E. Ms. Mary Mugwanja (Kenya), H.E. Mr. Andreas Raphael Nägeli (Switzerland) and Mr. Gyanveer Singh (India) as Vice-Presidents, and Mr. Henryk Czubek (Poland) as Rapporteur.

13. The Board adopted a proposal by the President to ensure the maximum utilization of available conference-servicing resources (see annex I, decision IDB.50/Dec.1), waiving its twenty-four hour notice period for the suspension of rules.

14. The Board decided to set up informal in-session consultations with the aim of facilitating the drafting of decisions and entrusted Vice-Presidents H.E. Mr. Andreas Raphael Nägeli (Switzerland) and Mr. Gyanveer Singh (India) to chair those consultations. The Board furthermore set the deadline for the receipt of draft decisions at 5.15 p.m. on 21 November 2022, and decided to close the list of speakers at 3 p.m. on 22 November 2022.

58. The Board considered a draft decision submitted by the President (IDB.50/L.9) and adopted decision IDB.50/Dec.6 (see annex I).

XVI. UNIDO's operational strategy and implementation plan for LDCs 2022–2031 (item 13)

59. Under item 13, the Board had before it a report by the Director General providing an update on the preparation process of the UNIDO operational strategy for the least developed countries 2022-2031 (IDB.50/20) and a note by the Director General on the UNIDO operational strategy for the least developed countries 2022-2031 (IDB.50/CRP.8).

60. At the proposal of the President, the Board took note of the documentation provided.

XVII. Matters related to intergovernmental, non-governmental, governmental and other organizations (item 18)

Annex I

Decisions adopted by the Board at its fiftieth session

Decision IDB.50/Dec.1 Utilization of available conference-servicing resources

The Industrial Development Board, with the aim of utilizing the available conference-servicing resources to the maximum extent possible, decided to suspend with immediate effect rule 32 of its rules of procedure relating to the quorum, for the meetings of its fiftieth session only, provided no substantive decisions were taken at those meetings.

1st plenary meeting 21 November 2022

Decision IDB.50/Dec.2 Report of the External Auditor for 2021

The Industrial Development Board:

(a) Took note of the report of the External Auditor on the accounts of the United Nations Industrial Development Organization for the financial period 1 January to 31 December 2021 as contained in document IDB.50/3;

(b) Also took note of the statements of the Director General and the External Auditor made at the thirty-eighth session of the Programme and Budget Committee;

(c) Recognized the relevance and important contribution the External Auditors' recommendations make to the improvement of UNIDO's operational performance, including those in the recent report IDB.50/3;

(d) Requested the Director General to continue implementing the recommendations, including those of prior years, and to report on the follow-up of their implementation to the Industrial Development Board at its fifty-first session.

7th plenary meeting 23 November 2022

Decision IDB.50/Dec.3 Financial situation of UNIDO

The Industrial Development Board:

(a) Took note of the information contained in document IDB.50/4;

(b) Urged those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years' arrears, to do so without delay;

(c) Requested the Director General to pursue his efforts and contacts with Member States and former Member States to effect the collection of arrears.

7th plenary meeting 23 November 2022

Decision IDB.50/Dec.4 Mobilization of financial resources

The Industrial Development Board:

(a) Took note of the information contained in document IDB.50/7/Rev.1;

(b) Decided to delegate to the Director General the authority to approve projects for financing, previously selected by UNIDO and the donor, under the Industrial Development Fund in 2022 and 2023 in accordance with the priorities defined in the medium-term programme framework 2022–2025 (IDB.49/8);

(c) Encouraged Member States and other funding partners to increase their voluntary contributions to UNIDO, including for the Partnership Trust Fund as well

as the Special Account of Voluntary Contributions for Core Activities (SAVCCA) and the Major Capital Investment Fund (MCIF);

(d) Also encouraged all funding partners to consider contributing programmable funds, specifically to enable UNIDO to respond rapidly to requests for assistance and develop and implement its programmatic activities in a prompt and coordinated manner;

(e) Requested Member States to consider contributing to UNIDO to enable the Organization to work with funding sources requiring co-funding, either through contributing to the dedicated trust funds or by special purpose funding at country or global level;

(f) Encouraged governments of recipient countries to play an active role in sharing with UNIDO the responsibility for mobilizing funds for jointly agreed priority activities, and specifically to take the lead in identifying and accessing funds available at the country level, including local cost-sharing opportunities, and funds from bilateral funding partners, multi-donor trust funds, the World Bank as well as other development finance institutions;

(g) Strongly recommended that Member States cooperate with and support the Organization in its efforts to develop and promote its programmes and initiatives in the international development context, and especially through international conferences and other forms of dialogue, in order to ensure that these initiatives are well known, their relevance for international development targets are recognized, and resources are made available.

7th plenary meeting 23 November 2022

Decision IDB.50/Dec.5 UNIDO strategy in response to climate change

The Industrial Development Board:

(a) Recalled resolution GC.19/Res.2, in which the Director General was requested to develop a draft strategy in response to climate change in consultation with Member States, for consideration by the Industrial Development Board at its fiftieth session;

(b) Took note of the report by the Director General on UNIDO's strategy in response to climate change;

(c) Requested the Director General to continue consultations with Member States on the development of the draft strategy based on the document IDB.50/16 in order to ensure its objective as identified in resolution GC.19/Res.2;

(d) Further requested the Director General to develop, in consultation with Member States, an action plan to implement the strategy, within the mandate and available resources of UNIDO, after the above strategy is formulated;

(e) Welcomed the outcomes of 27th session of the Conference of the Parties of the United Nations Framework Convention on Climate Change (COP27), held in Sharm El-Sheikh, Egypt, from 6 to 20 November 2022 and took note of UNIDO's participation in the conference;

(f) Recommended that the strategy and the action plan shall take into account UNIDO's potential role in the implementation of the outcomes and initiatives of COP27 relevant to the mandate of UNIDO, explore the prospects of utilizing climate finance funds in implementing the strategy as well as give due consideration to the special needs of the most vulnerable developing countries to climate change, noting the importance for some of the concept of "climate justice";

(g) Decided to further consider the UNIDO Climate Change Strategy and its action plan at the fifty-first session of the Board.

7th plenary meeting 23 November 2022

Decision IDB.50/Dec.6 Inclusive and sustainable industrial development in middle-income countries

The Industrial Development Board:

(a) Took note of the report by the Director General (IDB.50/19) and the updated UNIDO workplan for partnering with middle-income countries as contained in document IDB.50/CRP.7;

(b) Requested the Director General to:

(i) Operationalize the UNIDO workplan for partnering with middle-income countries ensuring its effective and efficient implementation in 2022–2025;

(ii) Introduce through the integrated results and performance framework specific results and indicators related to the impact achieved by UNIDO in MICs and undertake further efforts to improve results-based management of the Organization's projects, programmes and activities in MICs;

(iii) Hold consultations with Member States on the implementation of the UNIDO workplan for partnering with middle-income countries;

(iv) Consider establishing an internal coordination mechanism within UNIDO to identify priorities and actions to accelerate inclusive and sustainable industrial development in middle-income countries, and report accordantly on its conclusions;

(v) Organize, within existing resources and in close collaboration with Member States, a side event on the margins of the 2023 High-Level Political Forum under the auspices of ECOSOC to highlight the UNIDO's efforts to support the attainment of SDG 9 on industry, innovation and infrastructure and its targets in MICs;

(vi) Report regularly to the Board on the implementation of the Strategic framework for partnering with middle-income countries (GC.18/Res.9) and its related workplan with possible future updates.

7th plenary meeting 23 November 2022

Decision IDB.50/Dec.7 Membership of the Independent Oversight Advisory Committee

The Industrial Development Board:

(a) Took note of document IDB.50/24 on the membership of the Independent Oversight Advisory Committee;
