

## GC.12/Res.1 REGIONAL PROGRAMME FOR LATIN AMERICA AND THE CARIBBEAN

The General Conference,

Recalling resolution GC.11/Res.1, entitled "Regional programme for Latin America and the Caribbean", in which the Director-General was requested to establish a regional programme for Latin America and the Caribbean,

Recognizing the joint work that has been carried out to date by Member States and the Secretariat with the aim of defining that regional programme and, in particular, the conclusions set out in the adopted document of the Latin America and the Caribbean Second Expert Group Meeting, held in Vienna from 28 to 30 November 2007,

Considering that resolution GC.11/Res.1 requested inter alia the Secretariat of UNIDO to identify and mobilize financial resources which would permit the implementation of the regional programme for Latin America and the Caribbean,

### *Requests* the Director-General:

- (a) To adopt the necessary measures so that the activities in execution of the regional programme for Latin America and the Caribbean are duly reflected in the medium-term programme framework, 2008-2011, in order to sustain the work initiated;
- (b) To continue his efforts, in consultation with the Member States of the region, to identify and mobilize additional voluntary financial resources required for its full implementation, at the same time calling upon the international community to provide financial support to the programme;
- (c) To keep the governing bodies of UNIDO regularly informed of action taken in pursuance of the present resolution.

*Taking note* of the Ministerial Conference of the Least Developed Countries convened in Vienna on 29 and 30 November 2007.

Also taking note of the Vienna Ministerial Declaration of the Least Developed Countries adopted by the Ministerial Conference and contained in the annex to the present resolution,

*Invites* the Director-General, in implementing the medium-term programme framework, 2008-2011, to take special account of the needs of the least developed countries.

#### Annex

### Vienna Ministerial Declaration of the Least Developed Countries

We, the Ministers and Heads of Delegation of the least developed countries participating in the Ministerial Conference held in Vienna, Austria on 29-30 November 2007, reiterating our commitment to strengthen the role of the United Nations Industrial Development Organization in promoting the industrial development of the least developed countries as a means to accelerate their development and integration into the multilateral trading system, particularly in the context of the new opportunities being created by Aid for Trade and the Enhanced Integrated Framework,

Recalling the Declaration and Programme of Action for the Least Developed Countries for the Decade 2001-2010, adopted in Brussels in 2001,

Appreciating the particular focus by UNIDO, within its mandate, on two essential commitments of the Brussels Programme of Action:

"Commitment 4: Building productive capacities

to make globalization work for

LDCs;

Commitment 5: Enhancing the role of trade in

development".

Being aware of the importance that foreign trade can play in the industrialization and economic development of a least developed country, and also aware that trade is an opportunity and not a guarantee, and therefore requires policy intervention to be successful.

Recalling that within the framework of the Millennium Development Goal (MDG) 8, Indicator 40 is aimed at increasing the proportion of Official Development Assistance provided to help build trade capacity,

Recalling also that the Sixth World Trade Organization Ministerial Conference, held in Hong Kong in 2005, called for the expansion of Aid for Trade to help developing countries, particularly least developed countries, to benefit from WTO agreements, expand their trade and enhance their ability to take full advantage of new trade opportunities,

Recognizing that new opportunities are being created by Aid for Trade and the Enhanced Integrated Framework,

Deeply appreciating the efforts of the United Nations Industrial Development Organization to assist the least developed countries to take the path to sustainable economic development, using manufacturing as a dynamic force, and to export more value added products complying with international standards,

### **Declare that:**

- 1. The Millennium Development Goals, as well as the other internationally agreed development goals, can most effectively be achieved in the least developed countries through a process that also emphasizes industrial growth, diversification and export of manufactured products.
- 2. The least developed countries have the primary responsibility for their own development; however, the international community and multilateral institutions can play a vital supportive role by providing them with adequate resources and technical assistance to enhance their productive capacities.
- 3. The commitments made in the 2005 World Summit to address the special needs of the least developed countries should be implemented fully. In this regard, all countries, the United Nations system, the Bretton Woods institutions and other organizations should make concerted efforts and adopt speedy measures to meet in a timely manner the goals and targets of the Brussels Programme of Action and the World Summit.

- 4. The beneficial and meaningful integration of the least developed countries into the multilateral trading system is an important objective of the Doha Development Agenda and the 2005 Sixth Ministerial Conference of the World Trade Organization. It is vital that the LDCs be able to enter the global value chains with manufactured products and processed foods, apart from other contributions in services, with the aid of targeted technical assistance from UNIDO.
- 5. In order to enable the least developed countries to benefit from the opportunities of the multilateral trading system, their manufacturing supply-side needs must be addressed. This requires the enhancement of their productive capacity, as stated in Commitment 4 of the Brussels Programme of Action. This will enable the least developed countries to enhance the role of trade in their development (Commitment 5).
- Considering the limited opportunities available to least developed countries, we call upon UNIDO to play a pioneering role in developing industrial productive capacity in those countries in a manner that ensures that products conform to acceptable international standards. Depending on the needs of specific LDCs this may, inter alia, entail efforts to develop entrepreneurship, creating an enabling business environment, developing domestic research capacity, investment facilitation, development of agro business, along with delivery of targeted technical assistance and capacity-building for developing standards, testing, certification and accreditation capabilities accepted in international markets, and integration of the local with the global value chains, lending support in finding markets.
- 7. Given the increasing importance of the South as a destination for least developed country exports and the potential for these countries to benefit from their increasing collaboration with the South, UNIDO should promote mutually beneficial least developed countries-South cooperation in areas within its mandate.
- 8. UNIDO should help least developed countries with commodity-specific interventions, wherever required by those countries, including in the development of technology, enhancing research, moving up the value chain and improving the welfare of those employed in, or dependent on, those commodities in the least developed countries. This is particularly needed for cotton.
- 9. The emergence of Aid for Trade, to assist least developed countries in developing their trade-related productive capacity and for meeting other trade-related needs, is a landmark development. The Enhanced Integrated Framework is a promising tool for analysis

and identification of needs in the area of trade capacitybuilding, and for implementation of projects identified.

- 10. UNIDO's core mandate is to support industrial development, including in least developed countries. Aid for Trade and the Enhanced Integrated Framework emphasize development of supply capacity and traderelated infrastructure. We call upon UNIDO to work closely with countries engaged in the Framework process and, wherever possible, to act as an implementing agency, particularly concentrating in developing industrial capacity and standards and conformity related infrastructure.
- 11. In enhancing productive capacity, donors should also utilize the services of UNIDO. We call upon UNIDO to create a special Trust Fund for least developed countries, and urge donors to contribute generously to the Fund.
- 12. UNIDO is hosting an LDC Ministerial Conference after more than a decade. Given the importance of building productive capacity, particularly manufacturing capacity which is within the mandate of UNIDO, we urge that the LDC Ministerial Conference be held at regular intervals, preferably UNIDO should consider holding it each year.

The Ministers and Heads of Delegation of the least developed countries are deeply grateful to UNIDO for hosting the Ministerial Conference and for the excellent arrangements made for it. We thank the G-77 and China for co-sponsoring this event. We also take this opportunity to thank all those who, through their participation or input, have contributed to its success.

## GC.12/Res.3 RESULTS-BASED MANAGEMENT

The General Conference,

Recalling the Director-General's commitment to enhancing organizational excellence and strengthening delivery capacity both at UNIDO Headquarters and in the field,

*Welcoming* the introduction of results-based management principles and practices at UNIDO,

Further welcoming the establishment of the Results-based Management Steering Committee at UNIDO to carry out a baseline self-assessment of the status of results-based management implementation in UNIDO, draft a conceptual framework for further development of results-based management in the Organization, and define a time-bound results-based management implementation strategy with milestones,

Cognizant of the need to further refine and harmonize results-based management within the United Nations system,

### Requests the Director-General:

- (a) To continue to give priority to the comprehensive adoption of results-based management principles by UNIDO, and the full integration of results-based management approaches and methods in all spheres of its activities;
- (b) To continue to provide the governing bodies with regular updates on the implementation of results-based management in UNIDO;
- (c) To ensure that UNIDO continues to work with other organizations within the United Nations system to harmonize its approach to results-based management.

- 1. Expresses its appreciation to Member States and UNIDO for providing the funds needed to carry out the pilot phase of the programme;
- 2. Emphasizes the need to continue implementing in full the next phase of the programme;

- 3. Encourages Member States to contribute funding to the next phase of the programme;
- 4. Requests the Director-General to keep Member States informed of the achievements in this regard.

### **Mano River Union Round Table**

Towards sustainable peace: Empowering youth to strengthen economic resilience and human security

### Joint Communiqué

The Mano River Union Round Table "Towards sustainable peace: Empowering youth to strengthen economic resilience and human security" was convened in Vienna, Austria, on 4 December 2007, in the context of the twelfth session of the General Conference of UNIDO.

The Round Table brought together the Heads of State and Government and Senior Ministers of the Mano River Union countries and Côte d'Ivoire, dignitaries and senior officials from other African countries, representatives of the donor community, the private sector and civil society.

The Heads of State and Government and Senior Ministers of the Mano River Union countries and Côte d'Ivoire, and other Governments present at the Round Table, unanimously agreed that youth employment presents a major challenge and emphasized its implications for the political security of the subregion.

Progress towards political and economic stability has been achieved in the Mano River Union region (Guinea, Sierra Leone and Liberia) and Côte d'Ivoire.

In the wake of political stabilization and economic recovery of the region, further measures are needed to strengthen its economic, environmental and social resilience. That effort to building resilience will inevitably have to address the issue of youth employment as an explicit area for action. Even if the private sector were to attain a healthy growth rate, it would not be able to generate sufficient jobs to mop up the large pool of unemployed youth. Self-employment and youth entrepreneurship and empowerment through profitable youth-led initiatives as well as special considerations for young women will need to be accompanied by additional financial schemes to complement national youth employment schemes.

Governments in the subregion have made progress towards creating the enabling environment for addressing the issue of youth employment by way of national policies, action plans and programmes for job creation. Meeting this challenge requires concerted efforts by Governments, the international community, the private sector, youth themselves and other relevant stakeholders to generate prospects that afford a better future for young people. Those efforts need to be innovative and creative, learning from both the successes and failures of the past, and at the same time developing new approaches that unveil new opportunities.

The multi-stakeholder programme on productive and decent work for youth in the Mano River Union region was welcomed as an initial response to increasing calls for viewing youth as a potential social and economic resource for peacebuilding and stability and as an immediate strategy for addressing poor youth needs through direct programme action.

The commitment of United Nations agencies to "deliver as one" was seen as a positive initiative and the hope was expressed that the programme for youth employment in Mano River Union countries and Côte d'Ivoire could serve as an example to be extended to other countries of the West African region as well as other parts of Africa facing similar threats.

The donor community was called upon to support the multi-stakeholder programme on productive and decent work for youth in the Mano River Union and Côte d'Ivoire, which has been initiated by UNIDO, in collaboration with other United Nations agencies.

## GC.12/Res.6 UNIDO'S PARTICIPATION IN UNITED NATIONS SYSTEM-WIDE COHERENCE

The General Conference,

Recalling decision IDB.31/Dec.3,

Noting the ongoing discussions on United Nations system-wide coherence and its impact in terms of enhancing UNIDO's role in helping developing countries, particularly least developed countries, as well as countries with economies in transition,

Taking into account the United Nations reform event to be hosted by UNIDO in Vienna in March 2008,

### Requests the Director-General:

- (a) To continue the coordination and promotion of UNIDO activities in relation to the ongoing discussions on United Nations system-wide coherence at the global, regional and country levels;
- (b) To inform the governing bodies of UNIDO on the results of discussions on United Nations system-wide coherence and its implications for UNIDO;
- (c) To include an item on United Nations system-wide coherence in the provisional agenda of the thirty-fourth session of the Industrial Development Board.
