The General Conference:

- (a) Recalled Industrial Development Board decision IDB.11/Dec.30;
- (b) Took note of the report of the Director-General on the financial situation of UNIDO (GC.5/26) containing information concerning the status of assessed contributions, advances to the Working Capital Fund, cash flow analyses for the years 1993 and 1994, the regular budget performance report and the revised appropriations for 1992-1993;
- (c) Urged those Member States that had not yet paid their assessed regular budget contributions, including advances to the Working Capital Fund, for the bienniums 1986-1987 to 1992-1993 to do so without delay;
- (d) Decided to approve the adjustments to the 1992-1993 scale of assessments as described in paragraphs 9 to 13 of document IDB.11/6, to be further adjusted if necessary in conformity with related decisions to be taken by the United Nations General Assembly at its forty-eighth session;
- (e) Also decided to approve the temporary suspension of financial regulations 4.2(b) and 4.2(c), with respect to the 1990-1991 biennium so as to allow the non-budgetary (temporary) allocation of the unutilized balances of \$8,746,822 as reported in document PBC.9/7, statement II.B, to strengthen the statutory cash resource base of the Organization, it being understood that that did not constitute a precedent.

GC.5/Dec.15 FINANCIAL REGULATIONS

The General Conference:

- (a) Recalled its resolution GC.4/Res.23 and Industrial Development Board decision IDB.10/Dec.10;
- (b) Took note of the report submitted by the External Auditor to the Programme and Budget Committee (PBC.8/14) on the proposed paragraphs (d) and (e) of financial regulation 4.1 and in particular his conclusion that the actual implementation of any new operational budget expenditure flexibility system should best be postponed until the evolving new situation in respect of the successor arrangements of the

United Nations Development Programme could be assessed more accurately in all its aspects;

- (c) Requested the Director-General to keep the matter under review and, if deemed necessary, report on developments through the Programme and Budget Committee and the Industrial Development Board to the General Conference;
- (d) Accordingly decided to delete the proposed paragraphs (d) and (e) of financial regulation 4.1 referred to in its resolution GC.4/Res.23.

GC.5/Dec.16 WORKING CAPITAL FUND

The General Conference:

- (a) Took note of Industrial Development Board decision IDB.11/Dec.26;
- (b) Decided that the level of the Working Capital Fund and the authorized purposes of the Fund for the 1994-1995 biennium should remain the same as those for the 1992-1993 biennium, i.e. as stipulated in Conference decision GC.2/Dec.27, paragraph (b);
- (c) Urged Member States to pay their outstanding assessed contributions as soon as possible to facilitate reimbursement to the Working Capital Fund.

The General Conference decided to appoint the President of the Federal Court of Audit of Germany as the External Auditor for UNIDO for a period of two years beginning on 1 July 1994, under the terms of reference specified in article XI (and annex) of the Financial Regulations of UNIDO. The travel and costs related to the work of the External Auditor are to be borne by the UNIDO regular budget.

Bearing in mind the low level of industrial development in Africa and recognizing the important role which UNIDO can play in the process of its rapid industrialization,

1. Requests the Director-General:

- (a) To provide African countries assistance in formulating industrial sector policies with a view to creating an enabling environment for increased industrial investment, and in the formulation of policies, procedures and guidelines for enhancement of initiatives for private sector development;
- (b) In cooperation with the Executive Secretary of the Economic Commission for Africa, to give high priority to the development of the African private sector and facilitate its involvement in the implementation of the programme for the Second IDDA;
- (c) To ensure appropriate staffing for the implementation of the programme for the Second IDDA;
- 2. <u>Urges</u> multilateral development finance and bilateral aid institutions to give high priority to increased investment in the industrial sector as a means of encouraging foreign private investment in the industrial sectors in Africa;
- 3. <u>Decides</u> to give full support to all parts of the programme for the Second IDDA, and in doing so, give particular attention:
- (a) To programme and project identification, preparation, implementation and monitoring;
- (b) To preparation, evaluation and negotiation of bids and contracts;
- (c) To production, marketing and distribution in relation to key consumer, intermediate and capital goods, especially in the subregional and regional context;
- (d) To procurement, adaptation and development of technology, plant management and consultancy services;
- (e) To industrial strategies and policies and setting up of institutional support, including development of sustainable institutional capability for industrial services and support to local enterprises in cooperation with local chambers of commerce and representatives of industry groups and associations;
- (f) To comprehensive development of smalland medium-scale industries;
- (g) To the assessment and determination of appropriate interrelationships between environmental and ecological needs and industrial growth and priorities in African countries;
- 4. <u>Further requests</u> the Director-General, in cooperation with the Executive Secretary of the Economic Commission for Africa and the Secretary-General of the Organization of African Unity:
- (a) To continue to give high priority to the mobilization of external financial resources for the execution of programmes for the Second IDDA;
- (b) To continue to intensify their cooperation in providing to African intergovernmental organizations the necessary assistance in strengthening the role of the industrial sector in the implementation of the subregional component of IDDA within the framework of the African Economic Community;

5. <u>Requests</u> the Director-General to present to the General Conference at its sixth session a report on the measures called for in the present resolution, through the Industrial Development Board.

Recognizing the emerging needs of the Arab region to enhance its industrial capacities and develop its human resources with a view to promoting industrial development, particularly in the least developed Arab countries, as well as to strengthen industrial regional cooperation,

Emphasizing the role of UNIDO in the attainment of these objectives and the mobilization of the required resources and expressing its appreciation for the achievements of UNIDO in this regard,

- 1. <u>Requests</u> the Director-General to orient the Special Programme activities in the Arab countries towards the following priority areas:
 - (a) Human resource development;
- (b) Development of national and regional technological capacities;
- (c) Upgrading the competitiveness of industrial products;
 - (d) Standardization and quality control;
 - (e) Industrial management information;
- (f) Food security through the development of agro-industries;
- (g) Promotion of the private sector, industrial rehabilitation and investment activities;
- (h) Sustainable industrial development through energy conservation and environment protection;
 - 2. Also requests the Director-General:
- (a) To secure, in addition to the allocations in the regular budget, the funds necessary for the Special Programme;
- (b) To enhance the management and capabilities of the Arab countries programme, in particular through appropriate staffing of the unit administering the Programme;
- (c) To strengthen cooperation with the specialized Arab organizations in planning activities of the Special Programme for Industrial Development in the Arab Countries;
- (d) To extend his assistance to the forthcoming meeting of the Arab Ministers of

Industry, to be held at Rabat, Morocco, in June 1994;

3. <u>Further requests</u> the Director-General to report on the implementation of the present resolution to the General Conference at its sixth session through the Industrial Development Board.

GC.5/Res.14 SPECIAL PROGRAMME FOR THE INDUSTRIAL DEVELOPMENT OF ASIA AND THE PACIFIC

The General Conference,

Recalling its decision GC.4/Dec.12 and Industrial Development Board decisions IDB.9/Dec.5 and IDB.11/Dec.10,

Taking note of the Tehran Declaration on Strengthening Regional Cooperation for Technology-led Industrialization in Asia and the Pacific, adopted by the Sixth Regional Meeting of Ministers of Industry and Technology of Asia and the Pacific (Tehran, 28-29 June 1992),

Further taking note of the report of the Director-General on the implementation of the Special Programme as contained in document GC.5/10,

- 1. <u>Urges</u> Member States to support programmes and projects that are regional or subregional in character through voluntary contributions within the Industrial Development Fund, trust funds and other sources;
- 2. Requests the Director-General, in the implementation of the Special Programme:
- (a) To cooperate with the countries concerned in the formulation of new programmes and projects that enhance intercountry cooperation in the areas set out in General Conference resolution GC.3/Res.18 and decision GC.4/Dec.12, bearing in mind that the aspect of economic and technical cooperation among developing countries as well as the special needs of the least developed countries in the region are duly incorporated;
- (b) To continue to secure sufficient funds from all possible sources for the effective implementation of ongoing programmes and projects as well as new ones to be formulated in accordance with subparagraph (a) above;
- (c) To strengthen the management and capabilities of the Special Programme, <u>inter alia</u>, through appropriate staffing of the corresponding unit;
- (d) To increase efforts to promote investment in the industrial sector in countries of the region, taking into account the measures adopted by those countries to facilitate and promote investment;
- (e) To strengthen contacts and coordination with multilateral and bilateral development institutions in the implementation of the Programme;
- (f) To organize, within available resources, in cooperation with the Economic and Social Commission for Asia and the Pacific and interested regional organizations and Governments, a regional

meeting in 1995 to consider UNIDO activities and measures to promote industrialization in the region;

3. <u>Further requests</u> the Director-General to report on the implementation of the present resolution to the General Conference at its sixth session through the Industrial Development Board.

GC.5/Res.15 REGIONAL COOPERATION PROGRAMME FOR THE INDUSTRIAL RECOVERY OF LATIN AMERICA AND THE CARIBBEAN

The General Conference,

Recalling its resolution GC.4/Res.6 and Industrial Development Board decision IDB.11/Dec.11,

Underlining the high priority given to regional industrialization by the Latin American Economic System (SELA) during the regional consultation and coordination meeting held at Caracas from 6 to 8 October 1993, previous to the fifth session of the General Conference of UNIDO,

Stressing the particular need of the Regional Programme to promote industrial development in the Central American, Caribbean and other economically less developed countries in the region,

1. Requests the Director-General:

- (a) To make fully effective the implementation of the Regional Programme with the first five approved projects and to continue its work on additional projects to be agreed upon between Member States of the region and UNIDO;
- (b) To enhance the quality of the projects identified and formulated under the Regional Programme, <u>inter alia</u>, through appropriate staffing of the corresponding unit;
- (c) To keep the countries of the region fully informed, through the Permanent Missions, on the status of implementation of the Programme and projects, including the financing requirements and other actions needed for their execution;
- (d) To organize, in the 1994-1995 biennium from existing resources in the Programme, a regional meeting with national counterparts, and to report at that meeting on the progress made in the Regional Programme and to present his proposals for future reorientation;
- 2. <u>Also requests</u> the Director-General to submit to the General Conference at its sixth session through the Industrial Development Board a report on the implementation of the present resolution.

The General Conference,

<u>Recalling</u> the Paris Declaration and Programme of Action of the Second United Nations Conference on the Least Developed Countries,

Further recalling its resolutions GC.4/Res.9 and GC.4/Res.10 and Industrial Development Board decision IDB.11/Dec.13,

Noting with deep concern the lack of progress in the industrialization of the least developed countries, particularly in Africa,

Taking note of the conclusions of the Second Ministerial Symposium on the Industrialization of the Least Developed Countries held at Yaoundé, from 3 to 10 December 1993 (annexed to the present resolution),

- 1. <u>Urges</u> Member States to make new or increase their financial contributions to the Industrial Development Fund for the implementation of the Industrial Action Programme for the Least Developed Countries (PI/114);
- 2. Appeals to the international community, especially the developed countries, regional and international financial institutions and direct private investors, to strengthen their financial and technological support for the development of the priority sectors included in the Industrial Action Programme for the Least Developed Countries;
- 3. Requests the Director-General, within the framework of the overall revitalization of UNIDO and its prioritization and structural reform as contained in document GC.5/23, to continue to accord highest priority to the UNIDO least developed countries programme, including the use of funds from the Special Industrial Services programme, the Industrial Development Fund and other sources available to UNIDO in order to assist in the implementation of the Industrial Action Programme for the Least Developed Countries;
- 4. <u>Further requests</u> the Director-General to take appropriate measures to implement the conclusions and recommendations of the Second Ministerial Symposium on the Industrialization of the Least Developed Countries (Yaoundé, 3-10 December 1993);
- 5. Also requests the Director-General to present a report on the implementation of the present resolution to the General Conference at its sixth session through the Industrial Development Board.

CONCLUSIONS OF THE SECOND MINISTERIAL SYMPOSIUM ON THE INDUSTRIALIZATION OF THE LEAST DEVELOPED COUNTRIES

1. The symposium considered the working paper prepared by the UNIDO Secretariat, Financing the Industrial Action Programme for the LDCs: A Challenge for the 1990s (PPD.254(SPEC.)), and found it to be comprehensive and relevant. The delegates considered the major findings in the paper to be in conformity with the experiences of the least developed countries with respect to industrialization. In view of the crucial role of industry, the delegates expressed concern at the stagnation of the industrial sector over the past decade when its contribution to gross domestic product remained constant at approximately 8 per cent and they also expressed concern at the declining share of the sector in the official development assistance of bilateral and multilateral institutions.

- 2. It was stressed that the 47 least developed countries (29 in Africa, 4 in Arab States, 13 in Asia and the Pacific, and 1 in Latin America and the Caribbean) comprised 500 million people who constitute a formidable number of producers and consumers, having the potential to increase global gross domestic product substantially. It was in the interest of the world economy that industrialization efforts in the least developed countries be vigorously promoted.
- 3. It was pointed out that the least developed countries were implementing major structural adjustment programmes which involved, among others, reducing the size of the public sector, rationalizing the trade regime, and promoting the private sector. These changes, while auguring well for the future, entailed extreme difficulties in the short term, particularly in respect of rehabilitation of existing industries, development of new industries because of lack of adequate funding, inadequate infrastructure development resulting from competing demand for limited resources, and the collapse of many industries now facing competition after many years of protection.
- 4. The delegates emphasized that it is of utmost importance that support for industry, particularly adequate resource allocation, be reinforced by national, regional, and international bodies.
- 5. The delegates noted that the first Ministerial Symposium on the Industrialization of the Least Developed Countries, held in Vienna in November 1991, had laid down the foundation of the strategy for industrialization in the least developed countries and reaffirmed their commitment to the Industrial Action Programme for the Least Developed Countries (Pl/114). They were of the opinion that the paper presented in the second Symposium addressed the crucial issue of financing industrialization in the least developed countries and endorsed the conclusions and recommendations of the working paper as a basis for the formulation of national and international strategies in the field of financing for industry.
- 6. The participating countries presented statements on their national strategies for industrial financing and also expressed their appreciation of the participation of financing institutions, particularly the African Development Bank and the Organization of Petroleum Exporting Countries Fund for International Development.

The Symposium:

- (a) Noted with grave concern the diminishing share of financial resources directed to the industrial sector in the least developed countries;
- (b) Recognized the vacuum created by the deterioration of national development finance institutions in many of the least developed countries;
- (c) Stressed the continuing need for national development finance institutions with new operating modalities, whilst acknowledging the inadequacies of these institutions in the past;
- (d) Recognized the potential for improved mobilization of domestic savings;
- (e) Emphasized the need for adequate access by the least developed countries to the international capital markets and official development finance of multilateral and bilateral institutions and for ensuring the continuous

inflow of resources from these institutions to the least developed countries;

- (f) Emphasized the urgent need for implementation of the recommendations as contained in the Paris Declaration and the Programme of Action for the least developed countries for the 1990s adopted by the Second United Nations Conference on the Least Developed Countries held in Paris in September 1990;
- (g) Suggested removal of existing obstacles to the flow of financial resources to the least developed countries;
- (h) Suggested that appropriate mechanisms be developed to ease the debt burden including giving high priority to debt cancellation;
- (i) Emphasized the importance of enhanced industrial competitiveness, as a condition for integrating the economies of the least developed countries into the world manufacturing system;
- (j) Reaffirmed the paramount importance of small- and medium-scale industries as a major component in the industrial development of their countries;
- (k) Expressed concern about the severity of conditionality required by creditors, considering that this is a major factor in restricting the access of small- and medium-scale industries to credit;
- Recognized the particular need for improving national capacities in project identification, formulation, monitoring, and implementation;
- (m) Further recognized the necessity of formulating and implementing industrial policies that create an enabling environment for private sector development;
- (n) Recognized the need to take measures with a view to encouraging subregional and regional economic integration;
- (o) Emphasized the importance of adequate access to credit for women entrepreneurs, particularly in view of the major role played by them in the small- and medium-sized industries sector;
- (p) Recognized the particular capability of UNIDO to provide complementary services to both lenders and borrowers of finance for industry;
- (q) Called for UNIDO to increase further its cooperation with financing institutions at national, regional and international levels;
- (r) Urged UNIDO to intensify its efforts in building national capacities, particularly as regards human resource development and technological development for industry;
- (s) Requested UNIDO to continue and expand its activities in the field of industrial information systems in order to provide the appropriate technical, economic and commercial intelligence for the least developed countries;
- (t) Appreciated the efforts of the Director-General of UNIDO to reorient the activities and structure of the Organization in the light of changes in the world economy and, in particular, to respond to the demands of the least developed countries in their industrialization efforts.

GC.5/Res.17 CONTRIBUTION TO INTERNATIONAL EFFORTS TO MITIGATE THE CONSEQUENCES OF THE CHERNOBYL ACCIDENT

The General Conference,

Recalling General Assembly resolution 45/190 on international cooperation to address and mitigate the consequences of the accident at the Chernobyl nuclear power plant,

Also recalling its resolution GC.4/Res.1 on UNIDO participation in international cooperation for Chernobyl that requested the Director-General to continue to take appropriate measures on the implementation of General Assembly resolution 45/190 within the mandate of UNIDO, and in cooperation with the United Nations Coordinator of International Cooperation for Chernobyl,

Taking note with appreciation of the activities of the United Nations Coordinator of International Cooperation for Chernobyl and the Inter-Agency Task Force, as well as welcoming the efforts of the Governments of Belarus, the Russian Federation and Ukraine to coordinate efforts in this field,

Also taking note with concern that the United Nations joint plan for Chernobyl could not yet be fully implemented due to the scarcity of financial resources,

Further taking note of the report of the Director-General on participation of UNIDO in international cooperation to study and mitigate the consequences of the Chernobyl accident, underlining the importance of UNIDO's efforts to mobilize resources for the preparation of the industrial survey of Belarus, the Russian Federation and Ukraine affected by the Chernobyl accident,

- 1. Appeals to the Member States as well as international and financial institutions to give support to the international cooperation for Chernobyl, including the provision of financial resources for implementation of the priority projects defined in the report of the Director-General;
- 2. <u>Requests</u> the Director-General to continue to take appropriate measures in accordance with General Conference resolution GC.4/Res.1 and to reflect the progress made in the implementation of the present resolution in the Annual Report.

The General Conference

Adopts the following Declaration:

We, the Member States of the United Nations Industrial Development Organization,

Having met at Yaoundé from 6 to 9 December 1993 for the fifth session of the General Conference of the United Nations Industrial Development Organization,

Having considered the challenges and opportunities arising from the recent changes in the world situation particularly the strong trends

towards deregulation and restructuring which require appropriate responses in the field of industrial development,

Having concluded that UNIDO urgently needs to improve its capacity to make optimal use of available resources,

- 1. Unanimously approve a far-reaching reform programme to enable the Organization to better realize its objectives and strengthen its role as the central coordinating agency in the United Nations system for the promotion of the industrialization of developing countries;
- 2. Affirm that a reformed UNIDO should enhance the impact of its activities, ensure greater economy and efficiency, improve the quality of its programmes and performance and respond more effectively to specific demands of Member States;
- 3. Appreciate in this regard, the determination of the Director-General to bring about major changes in UNIDO's management and structure, including the introduction of improved measures for management and evaluation, on the basis of the principles of balance and efficiency, and encourage him further in this task;
- 4. Reiterate that the major means of achieving UNIDO's objectives of environmentally sustainable and equitable industrial development remain investment promotion, technology transfer, development of human resources and the creation of an enabling environment, both nationally and internationally, for industrial growth and competitiveness;
- 5. Emphasize that UNIDO should:
- (a) Give special attention to the industrialization of the least developed countries, which face particular constraints in their resources and infrastructure;
- (b) Accord high priority to the industrialization of Africa and to the realization of the objectives of the Second Industrial Development Decade for Africa;

- (c) Strengthen its capabilities to promote the restructuring, rehabilitation and privatization of industries, including those of economies in transition without prejudice to the needs of developing countries;
- (d) Also strengthen its efforts to promote economic and technical cooperation among developing countries, increased participation of women in industrialization, and the development of small and medium enterprises;
- (e) Continue to improve cooperation and coordination with other international organizations and financial institutions, particularly with a view to mobilizing additional resources for industrial development;
- 6. Hereby firmly commit ourselves in the light of the above to renewing our political and financial support to the revitalized UNIDO and call upon Member States which are in a position to do so and the international community to provide additional resources to support the reformed UNIDO, thereby contributing to an increased impact of the Organization's activities in recipient countries.
