CONTRACT FOR APPOINTMENT OF THE DIRECTOR-GENERAL

THIS CONTRACT is made

between the United Nations Industrial Development Organization (hereinafter called the Organization) for the one part

and Mr. Domingo L. Siazon, Jr. (hereinafter called the Director-General) for the other part.

WHEREAS

The Director-General, upon recommendation of the Board, has been duly appointed by the Conference at the second plenary meeting of its third regular session held on 20 November 1989 (GC.3/Dec.7).

IT IS HEREBY AGREED AS FOLLOWS:

1. Term of Office

The Director-General shall be appointed for a period of four years from the first day of December nineteen hundred eighty-nine (1989), or until the Director-General appointed at the fifth regular session of the General Conference assumes office, whichever is later.

2. Official Duty Station

The official duty station for the Director-General shall be Vienna, Austria.

3. Official Duties

In accordance with Article 11 of the Constitution of the Organization, the Director-General shall be the chief administrative officer of the Organization.

4. Privileges and Immunities

The Director-General shall enjoy all the privileges and immunities in keeping with his office as determined by the Constitution of the Organization, Article 21, and any relevant legal instruments already in force or to be concluded in the future.

5. Staff Regulations

The Director-General shall be subject to the Staff Regulations of the Organization, together with such amendments as may be made thereto, in so far as they are applicable to him.

6. Assessable Salary and Allowances

- (a) The Director-General shall receive an annual gross salary of US dollars one hundred and fifty-nine thousand one hundred and fifteen (159,115) corresponding to an annual net base salary equivalent to US dollars seventy-eight thousand four hundred and thirty (78,430) (dependency rate) or US dollars sixty-nine thousand three hundred and thirty-four (69,334) (single rate) respectively;
- (b) He shall receive post adjustment, allowances and benefits, including social security benefits, for which a staff member in the Professional category of the UNIDO Secretariat would be eligible under the Staff Regulations and Staff Rules of the Organization, provided the purpose of such emolument, allowance or benefit has not already been met by other provisions of the present contract:
- (c) The Director-General shall receive a representation allowance of Austrian schillings two hundred sixty-five thousand five hundred (265,500) per annum, adjusted for the budgeted annual inflation rate, to meet his share of the obligations which the Organization incurs in the form of representation and hospitality expenditure;
- (d) He shall receive a housing allowance amounting to Austrian schillings four hundred seven thousand one hundred (407,100) per annum, adjusted for the budgeted annual inflation rate;
- (e) The above assessable salary, allowances and benefits to which the Director-General is entitled under this agreement shall be subject to adjustment by the Board, after consultations with the Director-General, to keep them in line with those of the executive heads of other specialized agencies within the common system of the United Nations or of members of the staff of UNIDO in the Professional category, as the case may be.

7. Notice of Resignation

The Director-General may at any time give six months' notice of resignation in writing to the Board, which is authorized to accept his resignation on behalf of the General Conference, in which case, upon expiration of such period of notice, he shall cease to be Director-General of the Organization and this contract shall terminate.

8. Entry into force

This contract shall enter into force with retroactive effect to the first day of December 1989

- Takes note with appreciation of the recommendations and the plan of implementation proposed by the Director-General in document GC.3/20;
- 2. <u>Decides</u> that it is necessary to strengthen the means by which UNIDO is to give support and facilitate contacts, consultations and negotiations between developed and developing countries and between the latter to increase their industrialization:
- 3. Reaffirms that the selection of subjects for the System of Consultations is a prerogative of Member States, and decides that the selection process will be done on the basis of consultations between the Secretariat and Member States through the Industrial Development Board at the beginning of the preceding biennium;
- 4. <u>Decides</u> that in selecting the subjects of Consultations, the main criteria to be followed would be the priority interests of developing countries in the context of the medium-term plan;

- 8. <u>Decides</u> that the Senior Industrial Development Field Advisers, after being duly requested to do so, shall give support and advice to the host countries on the follow-up activities;
- 9. Resolves that the activities related to the System of Consultations, including preparatory, follow-up and monitoring, should be financed as much as possible from the regular budget.

- 2. <u>Emphasizes</u> that any new concepts and aproaches for industrial co-operation adopted by UNIDO should pay particular attention to:
- (a) Enhancing the role of indigenous agents of production from both the private and the public and co-operative sectors;
- (b) Developing domestic factor inputs for industry and other economic sectors;
- (c) Strengthening capacities for the identification, preparation, negotiation and implementation of industrial projects;
- (d) Improving the nature of contractual relationships not only between developed and developing countries but also between developing countries themselves, with respect to such aspects as training, profitability of industrial units and quality of manufactured goods;
- (e) Narrowing the technological gap between developed and developing countries;
- (f) Increasing and enhancing the responsiveness of UNIDO to specific problems and challenges in the industrial sector; and
- (g) Strengthening capacities for the preparation of studies and implementation of subregional and regional industrial projects;
- Requests the Director-General to continue to include the activities contained in document GC.3/27 and mentioned in paragraph 2 above, in the updated medium-term plan 1992-1997;
- 4. Also requests the Director-General, taking into consideration the opinions and views of Member States, to submit proposals on the new concepts and approaches for consideration and approval of UNIDO governing bodies;

GC.3/Res.5 MOBILIZATION OF FINANCIAL RESOURCES FOR INDUSTRIAL DEVELOPMENT

The General Conference,

Recalling its resolution GC.2/Res.10 and decision IDB.5/Dec.15 of the Industrial Development Board,

Reaffirming that economic and social development is a fundamental priority for the developing countries and that the general mandate of UNIDO is to promote and accelerate the process of industrialization in the developing countries,

Reaffirming furthermore that the mobilization of additional external and local financial resources is decisive for the industrialization process in developing countries,

- Takes note of the report of the Director-General contained in document GC.3/3/Rev.1;
- 2. Requests the Director-General to pursue and reinforce his activities concerning the mandate of its resolution GC.2/Res.10, paragraph 1, with special emphasis on the effective promotion of direct mobilization of financial resources for the industrialization of developing countries, in the improvement of methods and systems to attract and obtain resources for co-operation within developing countries and to strengthen the Investment Promotion Programme;
- 3. Also requests the Director-General to ensure that in the planning, formulation and implementation of UNIDO activities related to the mobilization of financial resources, these activities are in conformity with the priorities of developing countries as set out in the medium-term plan, 1990-1995 (GC.3/17), and to develop a mechanism for the monitoring and evaluation of these activities within UNIDO;
- 4. <u>Further requests</u> the Director-General, within this concept, to identify regional programmes for implementation by UNIDO, and to identify possible financial resources for their implementation;

- 5. <u>Invites</u> all countries, in particular the developed ones, to increase their contributions to the financial support of technical co-operation activities of UNIDO, especially those aimed at strengthening the industrial infrastructure of developing countries;
- 6. Requests the Director-General to report to the General Conference, through the Industrial Development Board, on all the joint promotion activities which UNIDO is carrying out with international financial institutions to deepen the analysis of the means to improve promotion activities of UNIDO, in the matter referred to in paragraph 37 of document GC.3/3/Rev.1;
- 7. Also requests the Director-General to report on the implementation of the present resolution, through the Industrial Development Board, to the General Conference at its fourth session.

GC.3/Res.6 EXTERNAL DEBT AND INDUSTRIAL DEVELOPMENT

The General Conference,

Recalling its resolution GC.2/Res.11, where it is recognized that the response to the external debt crisis of many poor and/or highly indebted countries should continue to evolve within the framework of a growth-oriented strategy through continuous dialogue and shared responsibility, and that such a strategy should be implemented in a flexible manner in an environment of strengthened international co-operation,

Recalling further decisions IDB.4/Dec.47 and IDB.5/Dec.16 of the Industrial Development Board in which the Board noted with great concern that the burden of external debt of the developing countries and the severe effects of the external debt servicing on their economies constitute serious obstacles to the industrial development of these countries,

Appreciating the decision of a number of developed countries to alleviate the official debts of many developing countries bearing in mind the impact of external debt on the industrial development of these countries,

Taking note of the role of the international financial institutions in the search for a solution to the debt problem of developing countries through reduction of the debt burden and new financing for economic development,

Recalling that Industry and Development:
Global Report 1988/89 (ID/360), in examining the characteristics of the external debt crisis, calls attention upon the consequences of a possible new global recession that might involve both developed and developing countries,

Expressing the wish that through adequate national economic efforts and further close international co-operation, sustained growth and accelerated development can be promoted and debt problems be alleviated,

Cognizant of and recognizing the importance of the efforts made by developing countries to promote efficiency in their economic management, especially in the industrial sector,

Bearing in mind UNIDO's role as an instrument which can contribute to the alleviation of the negative effects of external debt,

- 1. Takes note with appreciation of documents GC.3/4, GC.3/4Add.1 and Corr.1 and GC.3/23;
 - 2. Urges the Director-General:
- (a) To reinforce and broaden, in developing countries, the activities of UNIDO outlined in chapter II of document GC.3/4/Add.1 and to ensure that its technical co-operation activities take fully into account the need to alleviate the debt burden of the developing countries, especially with regard to pre-investment activities, contract negotiations and financing of industrial projects;
- (b) To submit to the Industrial Development Board, on the basis of chapter III of the study contained in document GC.3/23, proposals for the adoption of specific measures and mechanisms, within UNIDO's mandate, where UNIDO can contribute to the reinforcement of the industrial capabilities of developing countries;
- (c) To promote co-operation arrangements between UNIDO and financing institutions for development, in order to concretize a co-operation programme in joint projects for promotion, rehabilitation and restructuring of industries in the developing countries;
- (d) To keep in mind in the development of UNIDO's technical co-operation activities the references to the alleviation of the debt problem included in the medium-term plan, 1990-1995 (GC.3/17);
- (e) To co-operate with multilateral financial and other relevant institutions to develop innovative approaches and specific proposals geared to the alleviation of the adverse impact of external debt;
- (f) To assist, on request, within existing financial resources or from voluntary contributions, the developing countries in analysing the implications of the external debt for the industrial sector in general, and for the industrial projects in particular;
- (g) To promote additional financial contributions to the Industrial Development Fund to support the basic industries of developing countries that are affected by the debt problem;
- 3. <u>Invites</u> Member States and multilateral financial institutions to increase financing for technical co-operation, in order to facilitate the development of the industrial sector of developing countries;
- 4. Appeals to the international community to continue their efforts to bring about a substantial reduction in the external debt of the developing countries, particularly writing off the debt of the least developed among them;
- 5. <u>Urges</u> all developed countries and multilateral financial institutions to continue to provide financial assistance to the industrial sector in the developing countries to contribute to the alleviation of the debt problem;
- 6. Requests the Director-General to broaden the scope of the study contained in document GC.3/23 to include all developing countries and to deepen and update the contents of documents GC.3/3/Rev.1,

GC.3/4 and GC.3/4/Add.1 and Corr.1, in order to ensure the necessary coherence between industrial development programmes and the evolution of the debt problem;

7. Also requests the Director-General to submit the above reports on the implementation of the measures called for in the present resolution to both the Industrial Development Board at its seventh session and the General Conference at its fourth session.

Requests UNIDO to initiate, in consultation with the regional commissions and other relevant United Nations organizations and agencies, measures with a view to establishing regional associations of small-scale industrial enterprises and regional data banks and thus providing a forum for the exchange of information on various aspects of the development of entrepreneurial capabilities;

Realizing that the Lima Declaration and Plan of Action target of the developing countries contributing 25 per cent of total world industrial output is far from reached,

- Takes note with appreciation of document GC.3/24 and the measures being undertaken by UNIDO to strengthen its ECDC/TCDC activities;
- 2. Requests the Director-General to establish a regulatory framework for the ECDC/TCDC components of UNIDO programmes, special attention being given to priority activities in the medium-term plan, 1990-1995 (GC.3/17);
- Also requests the Director-General to substantially increase funds for the ECDC/TCDC components of UNIDO programmes;
- 4. <u>Urges</u> the Director-General to continue to strengthen co-operation with the United Nations Development Programme (UNDP) in order to ensure that a better flow of information on programmes for upgrading industrial capability, based on the services of the TCDC Information Referral System (INRES) of the United Nations Development Programme, is available to developing countries;
- 5. <u>Invites</u> donor countries to increase the financial support to the ECDC/TCDC components of UNIDO programmes through extrabudgetary contributions:
- 6. Requests the Director-General to increase the use of experts, services and equipment from developing countries in the technical co-operation projects of UNIDO and to expedite the implementation of decision IDB.4/Dec.15 that the share of developing countries in the total contracts value and equipment purchases by the Organization should not be less than 25 per cent;
- 7. Further requests the Director-General to submit to the General Conference at its

The General Conference,

Having considered decision IDB.5/Dec.7 of the Industrial Development Board on the Industrial Development Decade for Africa (IDDA) which, inter alia, recommended to the General Conference at its third session the approval of a second Industrial Development Decade for Africa,

Noting resolution AHG/Res.180(XXV) of 26 July 1989 by the Assembly of Heads of State and Government of the Organization of African - Unity (OAU) on the proclamation of a second IDDA which declares the years 1991-2000 as the second IDDA for the purpose of accelerating further the industrialization of Africa,

Recalling Economic and Social Council resolution 1989/115 of 28 July 1989 on the proclamation of a second IDDA,

Taking note of the report of the independent mid-term evaluation of IDDA, especially the recommendations of the team to improve the planning, implementation and follow-up of a programme for the second IDDA,

Taking further note of resolution 2(IX), paragraph 8, of the ninth meeting of the Conference of African Ministers of Industry that established a working group of governmental experts from relevant African and United Nations organizations and institutions to undertake a review and preparation of the preliminary programme for a second IDDA, taking full account of the timetable approved by the Conference,

- Decides to have a second Industrial Development Decade for Africa for the period 1991-2000:
- 2. Requests the General Assembly of the United Nations to proclaim, during its forty-fourth session, a second IDDA (1991-2000) for the purpose of accelerating, through the programme and activities of other United Nations organs and agencies, the industrialization of Africa that was initiated during the First IDDA;
- 3. <u>Decides</u> to allocate the sum of \$8.6 million for the Second IDDA in the programme and budgets for the biennium 1990-1991 and to take into account the preparatory activities for the formulation of a programme for the Second IDDA;
- 4. Requests the Director-General, in co-operation with the Executive Secretary of the Economic Commission for Africa and the Secretary-General of OAU as well as the relevant international and African regional and subregional organizations to provide the necessary assistance to African countries in the formulation and implementation of their IDDA programmes and activities in collaboration with the working group of governmental experts;
- 5. Further requests the Director-General to strengthen and rationalize within the UNIDO

Secretariat the mechanism for the co-ordination, monitoring and evaluation of the implementation of the Second IDDA, with a view to remedying the shortcomings of the First IDDA pointed out in the mid-term evaluation report while keeping the special identity of the programme and its unit within the Area Programmes Division;

- 6. Requests the Director-General to take all necessary steps, including the mobilization of financial resources, in order to render fuller and more effective assistance to all African countries and organizations in the formulation and implementation of their programmes for the Second IDDA;
- 7. <u>Further requests</u> the Director-General to ensure that the objectives, strategies and programme of the Second IDDA are fully reflected in the next review of the medium-term plan of UNIDO;
- 8. Also requests the Director-General to report on the implementation of the present resolution through the Industrial Development Board to the General Conference at its fourth session;
- 9. Appeals to the international community, especially the developed countries, multilateral financial institutions and direct private investors, to increase their financial and technological support to African countries for the implementation of programmes and projects under the Second IDDA.

Noting with deep concern the lack of progress in the industrialization of the least developed countries during the 1980s and the adverse impact of global economic difficulties on those countries,

- 1. Takes note of the report by the Director-General on the progress of industrialization of the least developed countries (GC.3/15 and Corr.1);
- 2. <u>Calls upon</u> UNIDO to intensify its technical assistance to the least developed countries in their industrialization efforts and to continue to accord high priority to them, including the appointment of Senior Industrial Development Field Advisers in those countries;

Requests the Director-General to continue to accord highest priority to the least developed countries in the technical co-operation and all other programmes of the Organization, including, in particular, the use of funds from the Special Industrial Services (SIS) programme, the Industrial Development Fund (IDF) and other resources available to UNIDO;

to take, at the request of and in consultation with the least developed country concerned, immediate and effective steps for industrial rehabilitation and reconstruction necessary in the wake of natural disasters visiting the said least developed country, bearing in mind particularly the role of SIS projects as appropriate;

- 5. <u>Further requests</u> the Director-General, while preparing the UNIDO contribution to the preparation for the international development strategy for the fourth United Nations development decade, to take into account the particular situation, features and resource endowments of the least developed countries:
- 6. <u>Urges</u> donor countries to increase their financial contributions, <u>inter alia</u>, to the Industrial Development Fund for technical assistance to the least developed countries in the field of industrial development;

Reaffirming also the need for developed countries and the appropriate organs and organizations of the United Nations system to strengthen technical co-operation with the developing countries to enable them to develop and strengthen their capacity for identifying, analysing, monitoring, managing or preventing environmental problems in the field of industry in accordance with their national development plans, priorities and objectives,

Recognizing the importance of international co-operation in the research and development of environmentally sound technology and recognizing the need for an international exchange of experience and knowledge as well as the promotion of the transfer of technology for the protection and enhancement of the environment, especially in developing countries, in accordance with national laws, regulations and policies,

- 1. Takes note with appreciation of the proposed UNIDO environment programme contained in document GC.3/32;
- 2. <u>Calls on</u> the Director-General to take account of the opinions expressed at the third session of the General Conference with a view to achieving a more balanced and comprehensive perspective on environmental problems and sustainable development and to resubmit the proposed environment programme to the Industrial Development Board at its sixth session;
- 3. Requests the Director-General to proceed without delay with the implementation of those parts of the programme that aim at enhancing in-house awareness and capacity as well as strengthening the advisory role of UNIDO in the field of environment, bearing in mind the need to integrate environmental aspects into all UNIDO projects, activities and appraisals as appropriate;
- Appeals to Member States to make available the maximum possible financial contribution to the UNIDO environment programme;
- 5. <u>Urges</u> Member States to strengthen and support the development of international mechanisms and appropriate decision-making procedures to respond to environmental protection needs which will include assisting developing countries to obtain access to and to transfer needed environmental technologies for industrial development;
- 6. Requests the Director-General to ensure co-ordination between UNIDO and the United Nations Environment Programme (UNEP) as well as other relevant United Nations bodies taking into account the United Nations system-wide medium-term environment programme 1990-1995;
- 7. Also requests the Director-General to report regularly to the Industrial Development Board in the annual report on the progress made towards the implementation of the UNIDO environment programme as well as co-ordination with UNEP and other relevant United Nations bodies, as well as to the General Conference at its fourth session;
- 8. <u>Further requests</u> the Director-General to co-operate closely with the parties concerned as to UNIDO participation and contribution to the United Nations Conference on Environment and

Development, particularly with regard to recommendations to be considered by that Conference.

GC.3/Res.17 REGIONAL CO-OPERATION PROGRAMME FOR THE INDUSTRIAL RECOVERY OF LATIN AMERICA AND THE CARIBBEAN

The General Conference,

Recalling its resolution GC.2/Res.1 on strengthening of economic and technical co-operation among developing countries, in particular paragraph 2,

Recalling also its resolution GC.2/Res.ll and Industrial Development Board decisions IDB.4/Dec.47 and IDB.5/Dec.16 on external debt and industrial development,

Taking note of conclusion 1989/16 of the Programme and Budget Committee and of document PBC.5/CRP.16, on the action plan for the industrial recovery of Latin America and the Caribbean,

Having considered the progress report on the Regional Programme, contained in document GC.3/28,

Underlining the high priority given to regional industrialization by the Latin American Economic System (SELA) and reaffirmed by the interest in the convening of the Conference on New Industrialization Policies to be held in 1990.

- 1. Approves the Regional Co-operation Programme for the Industrial Recovery of Latin America and the Caribbean in accordance with decision IDB.5/25 of the Industrial Development Board;
 - 2. Requests the Director-General:
- (a) To hasten and to make effective the implementation of the Regional Programme with the first five ongoing projects and additional projects to be agreed upon between member States of the region and UNIDO in the priority areas;
- (b) To take into account in the implementation of the Regional Programme the recommendations of the Regional Conference on New Industrialization Policies to be organized by SELA in 1990;
- (c) To ensure full participation of the national counterparts in the regional meetings to be held in the biennium 1990-1991, in accordance with document GC.3/10 and Corr.1;
- (d) To establish, within available resources and in accordance with decision IDB.5/25 of the Industrial Development Board, the administrative mechanism and co-ordination of the Regional Programme, attributing specific responsibilities in the Secretariat to develop and follow up the operational phase of the Regional Programme, with clear and defined allocation of tasks and resources;
- (e) To include in the draft medium-term plan the activities of UNIDO in support of the Regional Programme;
- (f) To finance, during the biennium 1990-1991, the pre-operational phase of the Regional Programme, through internal redeployment of resources allotted to activities of the regular programme of technical

co-operation and to include in the next draft budget a specific allocation for the Regional Programme;

- (g) To prepare a document on the Regional Programme, including biennial programming activities by project, identification of existing and potential financing sources and the allocation of the resources obtained, in order to review and widen the portfolio of projects, in accordance with document IDB.5/CRP.12;
- 3. Requests also the Director-General to submit to the Industrial Development Board at its sixth session, the programme of activities to be implemented during the 1990-1991 biennium; and to submit to the General Conference at its fourth session, through the Industrial Development Board, a comprehensive report on the Regional Co-operation Programme for the Industrial Recovery of Latin America and the Caribbean.

GC.3/Res.18 SPECIAL PROGRAMME FOR THE
INDUSTRIAL DEVELOPMENT OF ASIA
AND THE PACIFIC

The General Conference,

 $\underline{\mathtt{Taking}}$ note of decision IDB.5/Dec.23 of the Industrial Development Board,

Noting the fact that over half the population of the Member States of UNIDO reside in Asia and the Pacific, and that as many as 13 least developed countries form part of the region,

Observing with concern the conditions of acute poverty afflicting many countries of the region due to lack of, and uneven, industrial growth,

- Takes note of the progress report on the Special Programme for the Industrial Development of Asia and the Pacific (GC.3/34);
- 2. <u>Decides</u> to approve the Special Programme for the Industrial Development of Asia and the Pacific, with its respective regional and subregional projects, geared to a rapid industrial growth of the developing countries of the region with special emphasis on the least developed countries, taking fully into account available natural and manpower resources based on the strengthening of existing programmes in UNIDO. The aim of the Programme will be to facilitate the process of development of indigenous and relevant technologies wherever possible and to assist, where this is not possible, in organizing the transfer of technologies for the development of industries in the region;
- 3. Requests the Director-General to strengthen the existing programmes of UNIDO and additional priority programmes to be agreed upon between member States of the region and UNIDO, in the following priority areas:
- (a) Development of manufactured exports industries;
- (b) Strengthening the industrial structure and sectoral interlinkages;
 - (c) Development of small-scale industries;
- (d) Development of agro-based and allied industries;

- (e) Development of national capability in design technology of plants, engineering and fabrication of machineries as well as the acquisition and development of main systems in electronic industry;
- (f) Development of human resources with special emphasis on the training of industrial managers and entrepreneurs;
- (g) Development of new frontier technologies and development of easy access to environmentfriendly technologies;
- 4. <u>Decides</u> to establish a special account within the Industrial Development Fund (IDF) for the above purpose and for the financing of technical co-operation projects and programmes for the industrial development of the least developed countries of the region;
- 5. Also decides to set up a suitable mechanism from available resources within the regular budget for the development and monitoring of the Special Programme for the Industrial Development of Asia and the Pacific;
- 6. <u>Decides</u> to finance, during 1990-1991, the pre-operational phase of the regional co-operation programme for the Special Programme for the Industrial Development of Asia and the Pacific, through internal redeployment of resources allotted to activities of the regular programme of technical co-operation and to include in the next draft budget a specific allocation for the regional programme,
- 7. Requests the Director-General, in implementing the programme of work contained in the regular budget for 1990-1991, to take into account the preparatory phase of the Special Programme;
- 8. <u>Urges Member States to support the Special Programme through voluntary contributions within IDF</u>, trust funds and other sources of funds.

GC.3/Res.19 INDUSTRIAL INVESTMENT PROMOTION

The General Conference,

Stressing the increasing importance of UNIDO's industrial investment activities for the mobilization of financial and other resources for the developing countries,

Taking note that Industry and Development: Global Report 1988/89 (ID/360) underlines the decreasing trend of the capital flow towards the developing countries,

Reiterating that the principal objective of UNIDO industrial investment activities is to bring about international co-operation to establish new production facilities or rehabilitate/expand existing ones,

1. <u>Takes note</u> of the report by the Director-General on Investment Promotion Services (GC.3/13), and decides to approve the guidelines for the functioning of the Investment Promotion Services described in chapter II, paragraphs 6 to 13 of document GC.3/13, with the following amendments:

New paragraph 9 should read as follows:

"(b) IPSs in developing and IPF-recipient countries

IPS offices in these countries shall promote industrial investment to other developing countries, as well as industrial investment from abroad to the host country."

New paragraph 11 should read as follows:

*Funding arrangements for IPSs

IPSs shall be fully financed by their host countries, who shall make voluntary contributions to UNIDO adequate to meet the costs to the Organization. The funding for all expenditures including the charge for programme support services (overhead charge) shall be provided in convertible currencies, except that in countries with non-convertible currencies funding for expenditures of IPSs in local currency may be provided in such local currency, while the funding for all other expenditures including the charge for programme support services (overhead charge) shall be provided in convertible currency. A procedures and operations manual for the IPSs shall be prepared.

When requested by an interested country referred to in paragraph 9 above, UNIDO shall try to arrange extrabudgetary financing for the instalment and operating expenses of IPS offices established in developing countries."

- 2. Requests the Director-General to:
- (a) Continue and enhance assistance to the developing countries through the Industrial Investment Division in expanding industrial production through all forms of joint industrial ventures between sponsors of industrial investment projects and foreign partners;
- (b) Mobilize financial, technical, managerial and other resources required for the implementation of such projects;
- (c) Strengthen the capability of UNIDO for identifying, formulating and promoting investment projects for which potential local investors are seeking inputs from foreign partners;
- (d) Make available to interested Member States, in co-operation with other international organizations, analytical information on investment trends, disaggregated by sector and subsector;
- (e) Ensure that the <u>Global Report</u> contains information relating to <u>disaggregated</u> investment flows to the developing countries;
- (f) Promote investment flows to the developing countries by helping them establish new, and strengthen existing, national institutions assigned to the task. Such assistance should include the provision of experts, the training of staff from these institutions in the identification and formulation of industrial investment projects, preparation of pre-investment studies, and the participation by representatives of these institutions in investment promotion orientation programmes;

- (g) Ensure that the implementation of UNIDO activities in the field of industrial investment be in accordance with national priorities and UNIDO priorities as set out in the medium-term plan, 1990-1995 (GC.3/17);
- 3. <u>Invites</u> the Director-General to submit a study on the possibilities and different operational modalities of fostering regional investment promotion activities to the Industrial Development Board at its sixth session:
- 4. Requests the Director-General, in complying with paragraph (c) of decision IDB.5/Dec.9, to bear in mind the conclusions of the in-depth evaluation of the industrial investment activities currently being undertaken by the Secretariat, as determined by IDB.5/Dec.12, paragraph (c);
- 5. While supporting the programme of identification, formulation and promotion of industrial investment projects, including the organization of meetings by UNIDO in developing countries, urges UNIDO to put more emphasis on the quality of these programmes;
- 6. Requests the Director-General to submit a progress report on the implementation of the actions called for in the present resolution to the Industrial Development Board at its sixth session.

GC.3/Res.20 ORGANIZATIONAL AND STAFF STRUCTURE OF UNIDO

The General Conference,

Recalling its decision GC.2/Dec.22, paragraph (h), which indicates the objectives of the rationalization process of the organizational structure of UNIDO,

Stressing that an efficient and streamlined staff structure of UNIDO is crucial to proper functioning of the Organization and the carrying out of its mandate,

Recognizing that the Director-General, as the chief administrative officer of the Organization, has the overall responsibility and authority to direct the work of the Organization, and is responsible for the appointment, organization and functioning of the staff, under the authority of and subject to the control of the Industrial Development Board,

Taking note of the management review of the organizational and staff structure of UNIDO (IDB.5/9), as well as the findings and recommendations of the Director-General on the management review (IDB.5/9/Add.1 and Corr.1) and the report of the Director-General on organizational and staff structure of UNIDO (GC.3/33),

- 1. <u>Invites</u> the Director-General to pursue his in-depth study on the appropriate organizational structure of UNIDO in accordance with the criteria set out in paragraph (h) of General Conference decision GC.2/Dec.22;
- Requests the Director-General to present to the General Conference at its fourth session, through the Industrial Development Board, a report on his overall vision of the appropriate organizational and staff structure of UNIDO,

including clear terms of reference and functions for the different departments and divisions, taking into account the medium-term plan;

3. <u>Further requests</u> the Director-General to continue to consult, as appropriate, with Member States and, at the request of the President of the Industrial Development Board, to initiate further informal exchanges of views and studies of options for the long-term reform process and optimum staff structure, especially after presentation of the report referred to in paragraph 2 above.

GC.3/Res.21 MEDIUM-TERM PLAN, 1990-1995

The General Conference,

Considering the need of improving the programme and budget planning process of UNIDO,

Considering also the need to update and periodically improve the draft of the medium-term plan, with close attachment to the principles established in General Conference decision GC.2/Dec.23 on the programme and budget planning process,

Taking note with appreciation of the report by the Director-General on new concepts and approaches for co-operation in respect to industrial development, in conformity with Article 2 (c) of the Constitution (GC.3/27),

- 1. $\underline{\text{Decides}}$ to approve the medium-term plan, 1990-1995 as contained in document GC.3/17, subject to biennial review;
- 2. Requests the Director-General to attribute specific responsibilities in the Secretariat for the programming of the measures established in the medium-term plan (GC.3/17) with a clear and defined allocation of tasks and resources, and to present a report accordingly to the Programme and Budget Committee and the Industrial Development Board in 1990:
- 3. Requests the Programme and Budget Committee and the Industrial Development Board to focus in the review of the medium-term plan on the translation of the five priority problem areas and thematic programmes into the programme and budgets, 1992-1993, in such a way that policy objectives, areas of concentration and programme instruments are taken into account:
- 4. <u>Further requests</u> the Director-General to support this review by taking into consideration the following programmes and measures:
- (a) The comprehensive policy framework of human resources development and the environmental programme resubmitted to the Industrial Development Board:
- (b) To improve, in the development and transfer of technology priority problem area, the regional co-operation, especially through the establishment and improvement in the developing countries of national scientific and technological development institutions oriented towards industrialization;
- (c) In the small- and medium-scale industries priority problem area, to promote, on the basis of

improvement of the application of the programme instruments contained in the medium-term plan, the effective co-operation of the regional and subregional institutions on this matter;

- (d) With regard to the mobilization of financial resources for industrial development, to identify industrial development projects, at the regional and subregional level, and the sources for their financing;
- (e) In respect of economic co-operation among developing countries, to define and identify, in an objective way, the possible effective alternatives for regional and subregional co-operation;
- (f) To include specifically among the programme instruments, the pilot and demonstration plants for accelerating industrialization in particular sectors, in conformity with Article 2 (m) of the Constitution;
- 5. <u>Welcomes</u> the better transparency in the above-mentioned process by incorporating in the present budget document a costed list of activities at the programme element level that explicitly address the priority problem areas and thematic programmes in the medium-term plan as contained in conference room paper GC.3/CRP.1;
- 6. <u>Further requests</u> the Director-General to submit to the Industrial Development Board, through the Programme and Budget Committee, the draft

updated medium-term plan 1992-1997, taking into account the present resolution.
