# **Review of the consultative status of non-governmental organizations**

#### **Report by the Secretariat**

In line with Board decision IDB.46/Dec.7, the present report provides information on the consultative status of non-governmental organizations.

#### I. Background

1. The Industrial Development Board may accord consultative status to international and national non-governmental organizations (NGOs) in accordance with Article 19.1(b) of the Constitution and the provisions of the Guidelines for the relationship of UNIDO with intergovernmental, governmental, non-governmental and other organizations, issued by the General Conference at its first session through decision GC.1/Dec.41. The Guidelines set out the criteria and procedure for granting consultative status to NGOs and provide for a periodic review of consultative relations in paragraph 20.

2. Decision IDB.46/Dec.7 "recommended that the Board should review at least every four years the list of NGOs holding consultative status, in line with GC.1/Dec.41, annex B, paragraph 20 (a)".


#### II. Review by the Secretariat

3. In April 2024, the Secretariat circulated a questionnaire to all NGOs currently in consultative status with UNIDO to assess the status of cooperation over the last four years (2020–2023). The NGOs were asked to return the completed questionnaire by end of May 2024.

4. The accompanying letter recalled the provisions of the Guidelines, quoting paragraph 20 (b), by which "the Board may in reviewing the list conclude that an organization in consultative status, which has not shown interest and goodwill in cooperating with UNIDO during a period of three years, may be deemed not to have sufficient interest to warrant the continuance of such a relationship". It also informed NGOs that, should the Secretariat not receive a response indicating the organization's interest in pursuing its cooperation with UNIDO, the Board, upon recommendation of the Director General, may decide to suspend the consultative status or withdraw such status on the basis that the organization no longer lives up to the criteria applied in the establishment of participating relations, or that such action is appropriate in the light of a change in the activities or programmes of UNIDO (GC.1/Dec.41, para. 21).

5. Of the 40 NGOs currently in consultative status, 38 either returned the completed questionnaire or replied by letter or email, confirming their wish to work with UNIDO and maintain their consultative status. The two remaining NGOs that failed to respond were either found to be inactive or could no longer be traced.

### III. Action required of the Board

6. In accordance with decision GC.1/Dec.41, annex B, paragraph 20 (b) and 21, the Board may wish to consider discontinuing the consultative status of those two NGOs listed in annex I of the present document. The status of the remaining 38 NGOs, listed in annex II, would be maintained.

7. Accordingly, the Board may wish to consider the adoption of the following draft decision:

"The Industrial Development Board:

(a) Takes note of the information contained in document IDB.52/30;

(b) Taking into consideration GC.1/Dec.41, annex B, paragraph 21, decides to discontinue the consultative status for those organizations listed in annex I to document IDB.52/30 that have not demonstrated sufficient interest in cooperating with UNIDO in the past four years."
