## Introduction

1. The report of the Industrial Development Board on the work of its fifty-second session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. As per decision of the Board IDB.46/Dec.3 (e), the Secretariat continues replacing written summary records of the Industrial Development Board and the General Conference with digital records. These are available through the UNIDO Extranet.

# I. Organizational and procedural matters

3. The fifty-second session of the Board was held at UNIDO headquarters, Vienna International Centre, from 25 to 27 November 2024 (six plenary meetings). The session took place in person, with the proceedings of the plenary also being available in all six languages of UNIDO through the United Nations' official streaming platform, UN Web TV.

### Participation

4. The following 50 of the 52 members of the Board<sup>1</sup> were represented at the session: Algeria, Angola, Argentina, Austria, Bangladesh, Belarus, Brazil, Burkina Faso, China, Colombia, Costa Rica, Côte d'Ivoire, Cyprus, Egypt, Finland, Germany, Ghana, Hungary, India, Ireland, Italy, Japan, Kenya, Luxembourg, Malta, Mexico, Mongolia, Morocco, Namibia, Netherlands (Kingdom of the), Norway, Pakistan, Panama, Peru, Philippines, Poland, Qatar, Republic of Korea, Russian Federation, Slovenia, South Africa, Spain, Sweden, Switzerland, Thailand, Tunisia, Türkiye, United Arab Emirates, Uruguay and Venezuela (Bolivarian Republic of).

5. The following 48 Member States of UNIDO also participated in the session: Afghanistan, Albania, Armenia, Azerbaijan, Bosnia and Herzegovina, Bulgaria, Chile, Croatia, Cuba, Czechia, Democratic People's Republic of Korea, Dominican Republic, Ecuador, El Salvador, Ethiopia, Guatemala, Honduras, Indonesia, Iran (Islamic Republic of), Iraq, Israel, Jordan, Kazakhstan, Kuwait, Lao People's Democratic Republic, Lebanon, Libya, Malaysia, Montenegro, Myanmar, Nepal, Nicaragua, Niger, Oman, Paraguay, Romania, Saudi Arabia, Senegal, Serbia, Sri Lanka, State of Palestine, Sudan, Syrian Arab Republic, Tajikistan, Ukraine, United Republic of Tanzania, Viet Nam and Yemen.

6. The Holy See and the Sovereign Order of Malta participated as observers.

7. The following United Nations bodies were represented: the Economic Commission for Latin America and the Caribbean (ECLAC) and the United Nations International Computing Centre (UNICC).

9. The following other intergovernmental organizations were represented: the African Intellectual Property Organization (OAPI), the Asian Forest Cooperation Organization (AFoCO), the Asian-African Legal Consultative Organization (AALCO), the European Union (EU), the League of Arab States (LAS), the Parliamentary Assembly of the Mediterranean (PAM) and the Standards and Metrology Institute for Islamic Countries (SMIIC).

10. The following non-governmental organizations were represented: the Center for Global Dialogue and Cooperation (CGDC), the China Council for the Promotion of International Trade (CCPIT), the European Business Council for Africa and the Mediterranean (EBCAM), the ISEKI-Food Association (IFA) and the World Federation of Engineering Organizations (WFEO).

### **Opening of the session**

11. The fifty-second session of the Board was declared open by the President of the fifty-first session, H.E. Mr. Magdi Ahmed Mofadal Elnour (Sudan).

### Officers of the session

12. In accordance with rule 23 of its rules of procedure, the Board elected by acclamation H.E. Ms. Gabriela Sellner (Austria) as President, H.E. Ms. Evangelina Lourdes Bernas (Philippines), Mr. Jorge Luis Hidalgo Castellanos (Mexico) and Mr. Michał Andrukonis (Poland) as Vice-Presidents, and Mr. Khaled Boudhane (Algeria) as Rapporteur.

14. The Board adopted a proposal by the President to ensure the maximum utilization of available conference-servicing resources (see annex I, decision IDB.52/Dec.1), waiving its twenty-four hour notice period for the suspension of rules.

15. The Board decided to set up informal in-session consultations with the aim of facilitating the drafting of decisions and entrusted Vice-Presidents Mr. Jorge Luis Hidalgo Castellanos (Mexico) and Mr. Michał Andrukonis (Poland) to chair those consultations. The Board furthermore set the deadline for the receipt of draft decisions at 5.15 p.m. on 25 November 2024, and decided to close the list of speakers at 3.30 p.m. on 26 November 2024.

### C. Budget implementation flexibility (item 4 (c))

25. Under sub-item 4 (c), the Board had before it conclusion 2024/2 of the Programme and Budget Committee, a note by the Secretariat on budget implementation flexibility (IDB.52/6) and a report by the Director General on the application of budget implementation flexibility (IDB.52/32).

### Decision IDB.52/Dec.2 Governance of UNIDO

The Industrial Development Board:

- (a) Took note of the Annual Report of UNIDO 2023 (IDB.52/2-PBC.40/2);
- (b) Requested the Director General to:

(i) Hold consultations with Member States, within the informal working group on Programme and Budget Committee-related issues, regarding UNIDO's organizational vision and strategy, and the new medium-term programme framework;

(ii) Improve the current UNIDO Open Data Platform to ensure that appropriate outcome indicators are published and updated on a regular basis to measure the impact achieved in the Organization's projects, programmes and activities, including global and regional programmes, in line with UNIDO's mandate;

(iii) Report to the next session of the Industrial Development Board and the General Conference of actions taken to pursue the present decision.

6th plenary meeting 27 November 2024

#### Decision IDB.52/Dec.3 Financial situation of UNIDO

The Industrial Development Board:

(a) Took note of the information contained in document IDB.52/5-PBC.40/5;

(b) Urged those Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years' arrears, to do so without delay and requested the Director General to continue to accord priority to his efforts to contact Member States in this regard;

(c) Also requested the Secretariat to continue assisting those Member States who are facing economic, financial and other challenges in meeting their financial obligations with payment plans and other available options;

(d) Further requested the Director General to redouble his efforts for collection of arrears from former Member States and in this regard provide a comprehensive report on his efforts at the fifty-third session of the Industrial Development Board.

6th plenary meeting 27 November 2024

#### Decision IDB.52/Dec.4 Budget implementation flexibility

The Industrial Development Board:

(a) Took note of decision GC.20/Dec.14;

(b) Requested Member States to continue negotiating through the forty-first session of the Programme and Budget Committee and the fifty-third session of the Industrial Development Board, to allow the Director General, on a time-bound basis for a period to be agreed upon, to make, within the amounts approved by the General Conference for the regular budget, transfers between the major objects of expenditure within result areas up to 10 per cent of the initially appropriated regular budget amounts from which the transfers are made.

6th plenary meeting 27 November 2024

#### Decision IDB.52/Dec.5 Mobilization of financial resources

The Industrial Development Board:

(a) Took note of the information contained in document IDB.52/8-PBC.40/8;

(b) Decided to delegate to the Director General the authority to approve in an equitable and transparent manner projects for financing, previously prepared and agreed by the UNIDO Secretariat and the concerned parties and donors, under the Industrial Development Fund in 2024 and 2025 in accordance with the priorities defined in the medium-term programme framework 2022–2025 (IDB.49/8-PBC.37/8);

(c) Encouraged Member States and other funding partners to increase their voluntary contributions to UNIDO, including for the Partnership Trust Fund as well as the UNIDO Innovation and Transformation Fund (ITF) and the Major Capital Investment Fund (MCIF);

(d) Also encouraged all funding partners to consider contributing programmable funds, specifically to enable UNIDO to respond rapidly to requests for assistance and develop and implement its programmatic activities in a prompt and coordinated manner;

(e) Requested Member States to consider contributing to UNIDO to enable the Organization to work with funding sources requiring co-funding, either through contributing to the dedicated trust funds or by special purpose funding at the country or global level; (f) Encouraged Governments of recipient countries to play an active role in sharing with UNIDO the responsibility for mobilizing funds for jointly agreed priority activities, and specifically to take the lead in identifying and accessing funds available at the country level, including local cost-sharing opportunities, and funds from bilateral funding partners, multi-donor trust funds, the World Bank as well as other development finance institutions;

(g) Strongly recommended that Member States cooperate with and support the Organization in its efforts to develop and promote its programmes and initiatives in the international development context, and especially through international conferences and other forms of dialogue, in order to ensure that these initiatives are well known, their relevance for international development targets are recognized, and resources are made available.

# Decision IDB.52/Dec.6 Strengthening UNIDO's role in agro-industrialization and food security

The Industrial Development Board:

(a) Reaffirmed that the eradication of hunger and poverty are overarching goals of the 2030 Agenda for Sustainable Development and emphasized the need for urgent and sustained attention to these crucial issues;

(b) Recognized that achieving these goals requires targeted interventions that enhance value addition in agribusiness, facilitate food systems transformation and promote sustainable and inclusive agro-industrialization, in alignment with UNIDO's mandate;

(c) Welcomed UNIDO's engagement in the Global Alliance against Hunger and Poverty on 18 November 2024, in Rio de Janeiro, Brazil, of which UNIDO is a founding member;

(d) Took note of the efforts aimed at highlighting the food security agenda in the Vienna-based International Organizations, such as the establishment of the Group of Friends of Food Security in Vienna, as an informal mechanism to support the efforts of Vienna-based Organizations and their Member States in this key area, which is deemed crucial for advancing the Sustainable Development Goals (SDGs), in particular SDG 2 "Zero hunger";

(e) Took note of the outcomes of the World Without Hunger Conference, held in Addis Ababa from 5 to 7 November 2024, and co-organized by UNIDO, the African Union Commission, the Government of Ethiopia, with technical assistance from the Food and Agriculture Organization of the United Nations;

(f) Took note of the Global Call 2024, which was held under the theme of "Foodtech Innovation and ISID" in Seoul on 21 November 2024, hosted by the UNIDO Investment and Technology Promotion Office Korea;

(g) Requested the Secretariat to hold consultations with Member States for the implementation of the outcomes of the World Without Hunger Conference, as appropriate, in cooperation with other relevant United Nations organizations, including by further developing and promoting the public-private sector cooperation initiative titled "A World Without Hunger is Possible!", and to report back on these developments to the fifty-third session of the Board.

(f) Acknowledged the global and regional donor community's activities in Latin America and the Caribbean and appreciated the activities of Latin American and Caribbean countries in sharing their knowledge and experience within the region;

(g) Recalled resolution GC.11/Res.1 that established the "Regional Programme for Latin America and the Caribbean" in 2005, the UNIDO Regional Approach for Latin America and the Caribbean 2020–2021, and the six priority thematic areas and their workplan, identified and agreed to in the framework of the regional conferences convened by UNIDO and held in Panama City and Bogota in 2022 and 2023, respectively;

(h) Requested the Secretariat of UNIDO to update the regional programme for Latin America and the Caribbean and to resume activities to identify and mobilize financial resources, without affecting the resources assigned to other regions;

(i) Further requested the Director General to inform Member States periodically on the implementation of this decision.
