

MANUF ACTURE OF BRONZE CUTLERY, ETC.

I. THE PROJECT

It is proposed to establish a new and modern factory for the manufacture of nickel bronzeware cutlery, fift items, mostly for household use. The total estimated investment is USS \geq million. The products will conform with international standards and qualities.

II. ECONOMIC ASPECTS

The project will, through exports, contribute to foreign exchange earnings, create new jobs, facilitate the use of local skills and utilization of resources as well as contribute to the diversification of the economy.

III. COMMERCIAL ASPECTS

Bronzeware cutlery and **gi**ft items are already being exported. The production is based on dated methods without proper standardization and quality control. The domestic sales of these products are mainly limited to tourists. The rise in the standard of living may, in future, create some demand on the local market.

At present, exports to Europe, USA, Australia and Japan are valued at about US\$ 2 million per annum. Exports can be expected to increase with greater efficiency in production, quality and more aggressive marketing methods.

IV. PHYSICAL ASPECTS

Land and Building

Two acres of land will have to be acquired for the factory and a building will have to be constructed.

Raw Materials

Copper, brass and iron ore are locally available and there are small quantities of local nickel.

Labour

The plant will employ about 252 persons in different categories and various skills and grades.

Infrastructure and Utilities

All these will provide no problems. Gas, electricity and water are available.

V. FINANCIAL ASPECTS

Total Estimated Investment

It is tentatively estimated that the total investment, including working capital will be US\$ 2 million. The various items involved in the investment will be worked out dith potential paramets at a later stage.

Financial Plan

This will be negotiated with potential partners.

VI. OTHER RELEVANT INFORMATION

The proponent is: The Gems of Siam Cc., Ltd. 103 Superhighway Bangkok 10, Thailand

The company is currently engaged in the export/import business, manufacturing and investment and business consultancy. For the implementation of this project, the proponents are willing to establish a joint venture with forcign partners. They are already manufacturing bronzeware items.
