It was so decided.

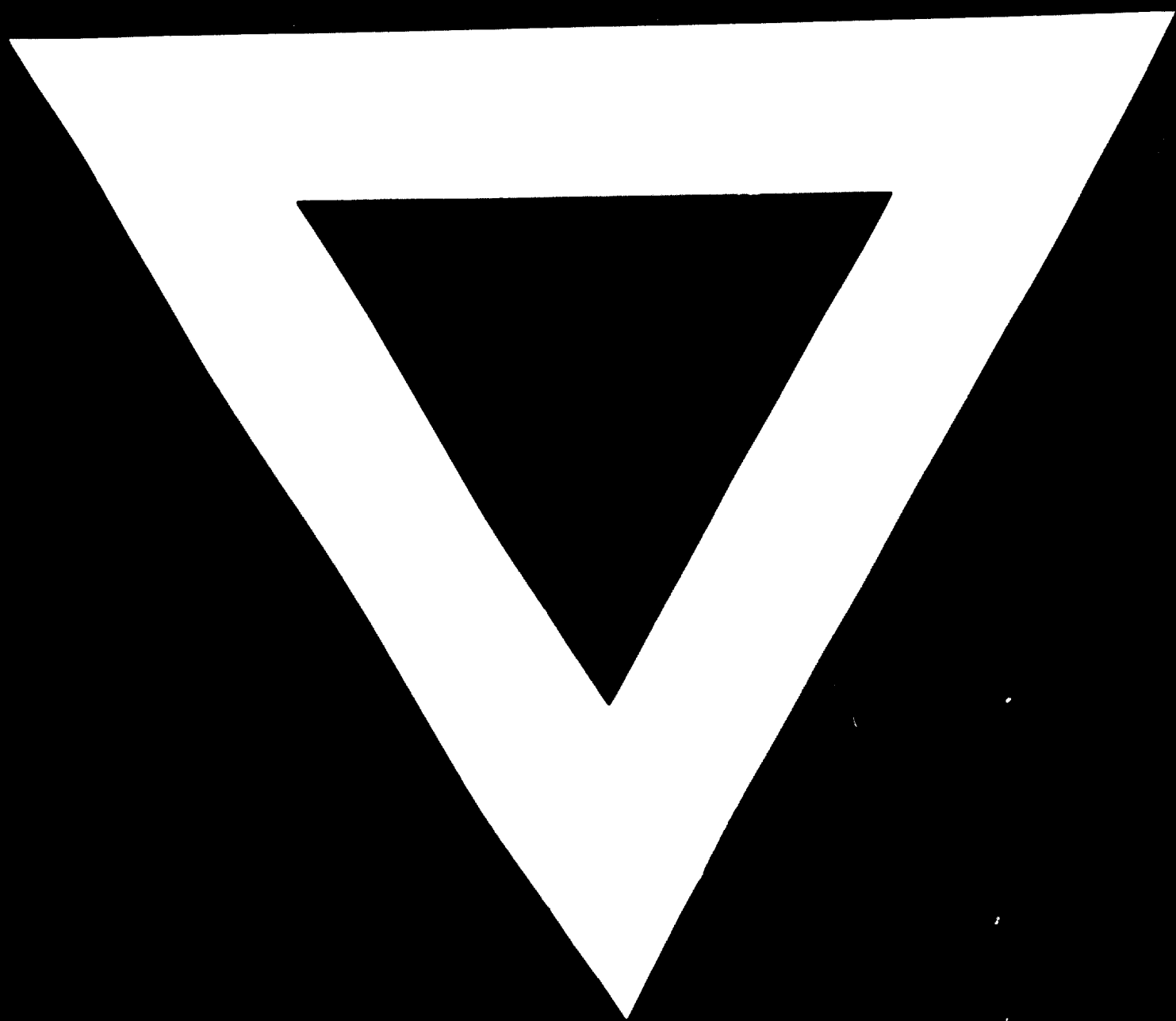
The meeting was suspended at 11 a.m. and resumed at 12.20 p.m.
