"The future world production of petrochemicals up to the year 2000 and the location of new production capacities to achieve the developing countries' share in accordance with the Lima Declaration and Plan of Action on Industrial Development and Co-operation.

The actions needed from Government and industry in developed and developing countries in order to achieve the above through co-operation in the following areas:

#### A. <u>Marketing</u>

1. Access to existing markets:

Action to remove barriers to international trade such as (a) tariffs, (b) quantitative restrictions, (c) hidden barriers to trade, and (d) restrictive business practices.

2. Adjustments in production:

Action to be taken by developed countries to adjust their petrochemical sector to facilitate the development of the petrochemical industry in developing countries and the absorption of petrochemical products from developing countries.

3. Promotion and expansion of markets:

Co-operation between countries to promote and expand the market for petrochemicals.

4. Joint ventures:

The extension of co-operation in the field of marketing in the framework of joint venture arrangements based on fair and equitable terms.

- B. Transfer of technology
  - 1. The principles on which a model contract oovering the licensing of process and know-how should be based and guidelines for its preparation by UNIDO".
