PREFACE

UNIDO has been engaged in activities relating to industrial and technological information, the latest development of which is the establishment of an industrial and Technological information Bank (INTIB), under a broad mandate to operate as a clearing house for industrial information for the benefit of developing countries, in particular to provide a greater flow of information permitting a better choice of advanced and other appropriate technologies.

The development of such a programme from UNIDO's base in Vienna has also been associated with a technical assistance activity aiming at the establishment or the adaptation of industrial information facilities in developing countries, to provide information and advice for industrial planning and operation in the countries, as correspondents to international information and advisory structures such as those offered by UNIDO. The orientation advocated for such national information and advisory structures is to include extension and advisory services, rendered by engineers with a broad technical and economic experience drawn from professional experience in industry.

The United Nations are engaged in a process of interlinkage and "networking" between information systems and services provided by the various organizations making up the United Nations "family" of organizations, and those specialized information centres in all countries that are their correspondents. This is the reason why the inter-Organization Board for Organization Systems issued in 1978 a Directory of United Nations information Systems and Services, including under the heading of UNIDO some details of the operation of its pre-existing industrial information activities under the acronym INDIS and of the operation of the industrial and Technological information Bank under the acronym INTIB. Under the headings of each member of the United Nations, the name of one industrial information center or facility within some institution at the service of industry is indicated with no further details than its name and address, as being the correspondent of UNIDO.

To follow up on this, and with a specific interest in providing more information on those centers dedicated to the provision of information and advice to industry, a questionnaire was sent out by UNIDO for the purpose of identifying as many such centers as possible and obtaining from them detailed information on their capability. The purpose is similar to that for which UNIDO has been publishing Guides to information Sources relevant to 31 sectors of industry to date, namely to facilitate those interested in developing their own international linkages.

The present Directory of Information Systems and Services for industry is offered herewith as a draft in a simple presentation with a request to those who will receive it, kindly to comment on the usefulness of turning it into a formal publication for distribution through the sales channels of the United Nations, and also to comment on contents, in particular as to entries concerning their own organization, as well as in respect of institutions known to them that should be included in new issues.

INTRODUCTION

Hapid industrialization throughout the world and the increasing acceptance of the need for the promotion of industry among the developing countries has led to co-operation among nations in various geographical areas with a view to promoting industrial development and productivity. Co-operation includes the exchange of information on all activities pertaining to industries, through government organizations, research centres, information centres, etc. Often the channels of information are know to nations of a particular region but not to those outside. This Directory is intended to enable the identification of these centres.

The entries are alphabetically arranged by countries and are designed to provide the essential information for initial inquiries. The large-scale computerized data banks, however, have not been included. The nature and scope of the services provided to industry by the organizations listed vary. It is by no means complete, and the information on the different centres is still being received. These would be included in the final publication.

We welcome proposals for corrections, additions and improvements which would assist in exchange of information between countries.

We acknowledge the co-operation extended to us, by the different organizations of the countries.

The objective of the UNIDO industrial information Service (INDIS) is to assist developing countries with the provision of industrial information; to serve the needs of industrial planners, managers and engineers with information relating to all the technological, managerial, and economic aspects of industrial development through the operations of an industrial inquiry service, the dissemination of printed information material and access to knowledge contained in documents generated in UNIDO or obtained from various sources, as summarized in the computerized industrial development abstracts; to assist in the development of facilities and media for industrial and technological information and to supplement the capacity of existing industrial and technological information services at a national, regional and international level to serve the information needs of industry.

Provides coverage for information on engineering and technology in English, French and Spanish. Information sources include monographs, serials, reports, standards, dissertations, proceedings, trade catalogues, audio-visual material, laws and regulations, unpublished documents. 7,400 abstracts available to system; 1,200 added in last year. The aim of the FiD/II is to establish an international professional forum for gathering, evaluating and exchanging ideas, methods and means on how to identify and how to meet effectively the needs for technological information of the end-users in enterprises within the private and the public sector.

The primary objectives of INPADOC are the identification of patent documents (PFG) as being connected by a common priority claim under the Paris Convention, the identification of patent documents connected by a common symbol of the International Patent Classification (IPC).

Patent document is used to designate published patents, inventor's certificates and utility certificates on a world-wide scale. Coverage is provided for inputs from Argentina, Australia, Austria, Belgium, Bulgaria, Canada, Cuba, Cyprus, Czechoslovakia, Denmark, Egypt, Finland, France, German Democratic Republic, Federal Republic of Germany, Hungary, Ireland, Israel, Italy, Japan, Kenya, Luxembourg, Malawi, Monaco, the Netherlands, Norway, the Philippines, Poland, Portugal, Romania, South Africa, the Soviet Union, Spain, Sweden, Switzerland, U.K., U.S.A., Yugoslavia, and Zambia.

The services provided by INPADOC are:

- (a) Patent Family Service the service identifying patent documents connected by a common priority claim under the Paris Convention. This enables the identification and retrieval of patents from different countries which belong to the same 'family'. The Patent Classification System (PCS) which identifies patents connected by a common symbol of the international Patent Classification (IPC).
- (b) The Patent Applicant Service (PAS) where the patents of a selected number of countries are identified as being connected by a common applicant or owner listed according to the name of the owner.
- c) The Numerial Data Base Service (NDB) the service identifying patent documents by their document number, listed according to the country of publication and document number.
- (d) Individual Requests for Family Service (IRF) on the basis of a certain number of bibliographic data supplied by the user, information is provided on countries in which the same application for a patent has been filed.
- (e) INPADOC also offers a patent document copy service.

Publishes the INPADOC Patent Gazette (IPG). Has published a microfiche containing SNS (Selected Numerial Service, the SCS (Selected Classification Service) and SAS (Selected Applicant Service)

The Committee was established in 196). The objective of WFEO/CE1 is to improve the techniques of communicating engineering information, to identify deficiencies in the communication and provides means for remedying these.
