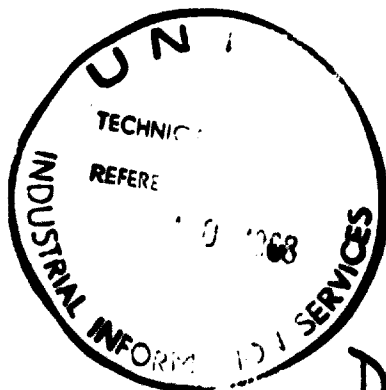

QUESTIONS OF NON-GOVERNMENTAL ORGANIZATIONS

(b) Consideration of applications of international non-governmental organizations (ID/B/32) (continued)

1. The PRESIDENT stated that the ad hoc Committee for the consideration of applications submitted by non-governmental organizations had held two meetings that day.
2. The ad hoc Committee proposed that the Board should admit as observers, in accordance with rule 76 of the Rules of Procedure, the International Federation of Christian Trade Unions, the International Christian Union of Business Executives, and the European Centre for Overseas Industrial Development. Particulars of those organizations were contained in document ID/B/32.
3. Concerning the International Association of Crafts and Small and Medium-sized Enterprises and the International Association for the Protection of Industrial Property, the ad hoc Committee had not yet been able to come to a decision because they had not submitted their applications in time. Their representatives could if they wished appear before the ad hoc Committee, which would then make its recommendations to the Board before the end of the session. The ad hoc Committee therefore proposed that the Board should defer decision on those two organizations.
4. If there were no objections, the International Federation of Christian Trade Unions, the International Christian Union of Business Executives and the European Centre for Overseas Industrial Development might designate observers according to rule 76 of the Rules of Procedure.
5. It was so decided.

REPORT OF THE BOARD ON THE WORK OF THE SECOND SESSION

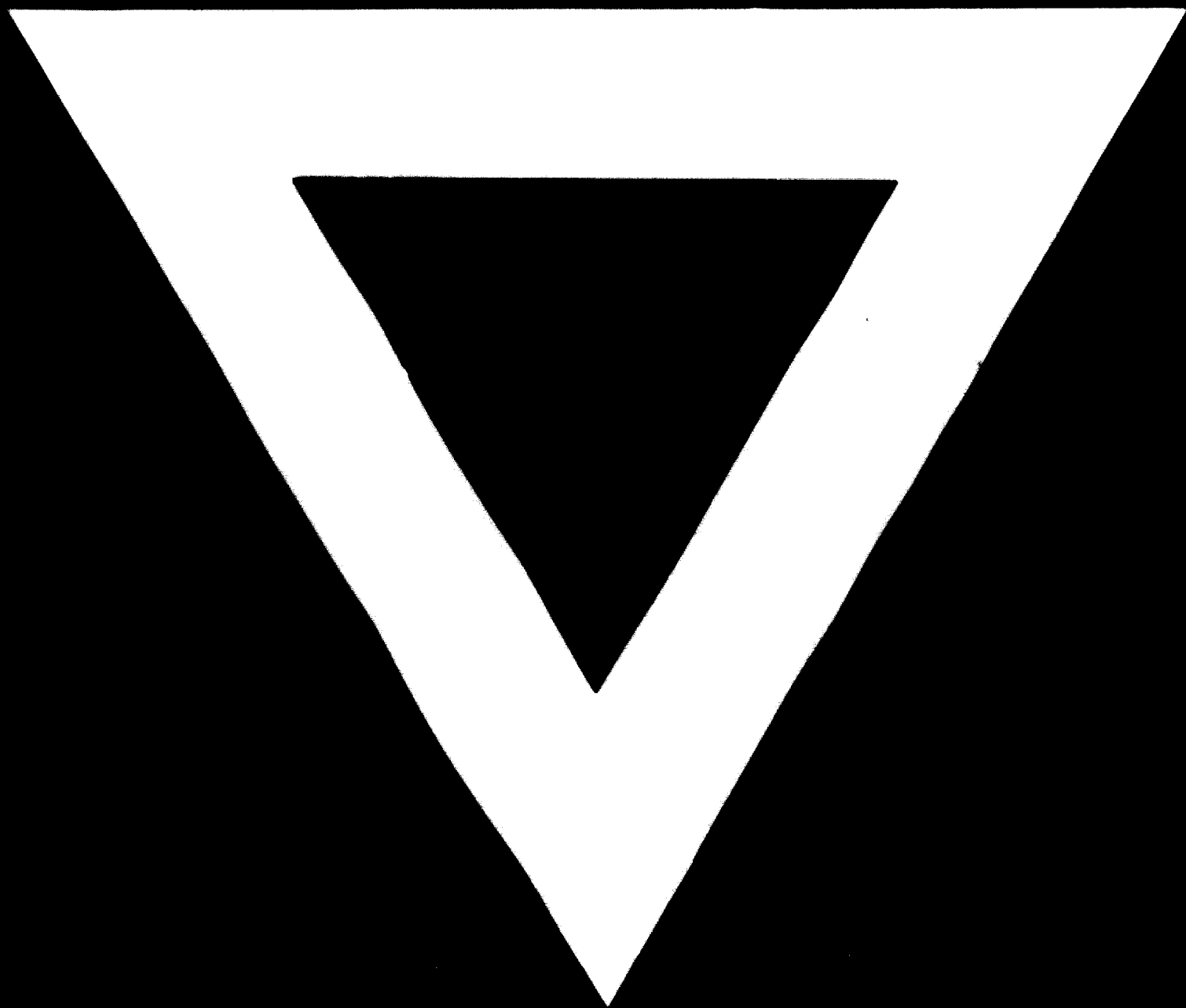
6. Mr. ACHASSI (Iran), Rapporteur, set out the plan he proposed to follow in preparing his report. After the introduction and a summary of the general discussion he would review successively the activities of UNIDO in 1967, the

programmes for 1968 and 1969, financial and organizational matters, questions of co-ordination and co-operation with specialized agencies and other international organizations, and questions relating to inter-governmental and non-governmental organizations. At the end he would reproduce the Board's recommendations and resolutions.
