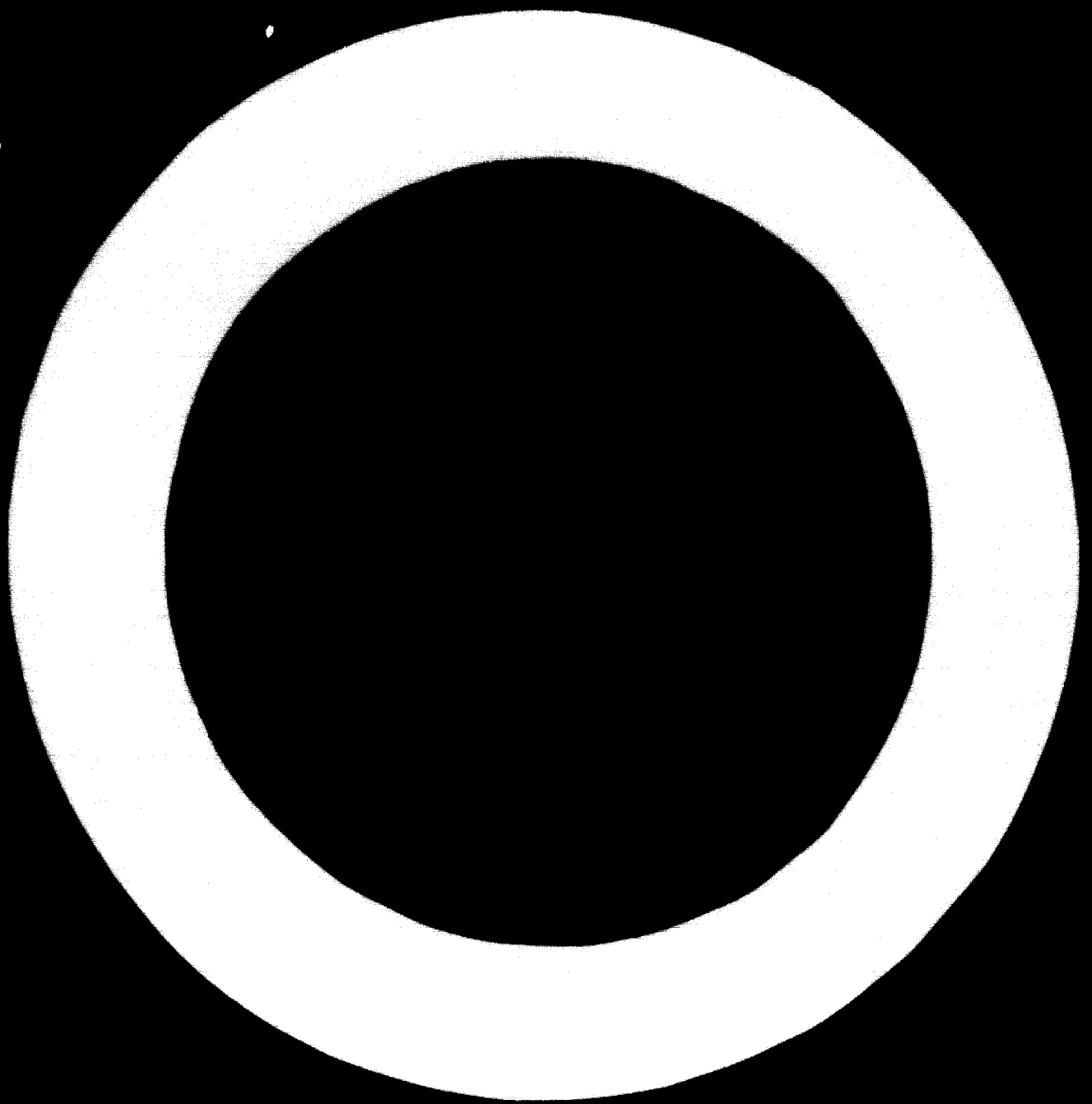

Note by the Executive Director

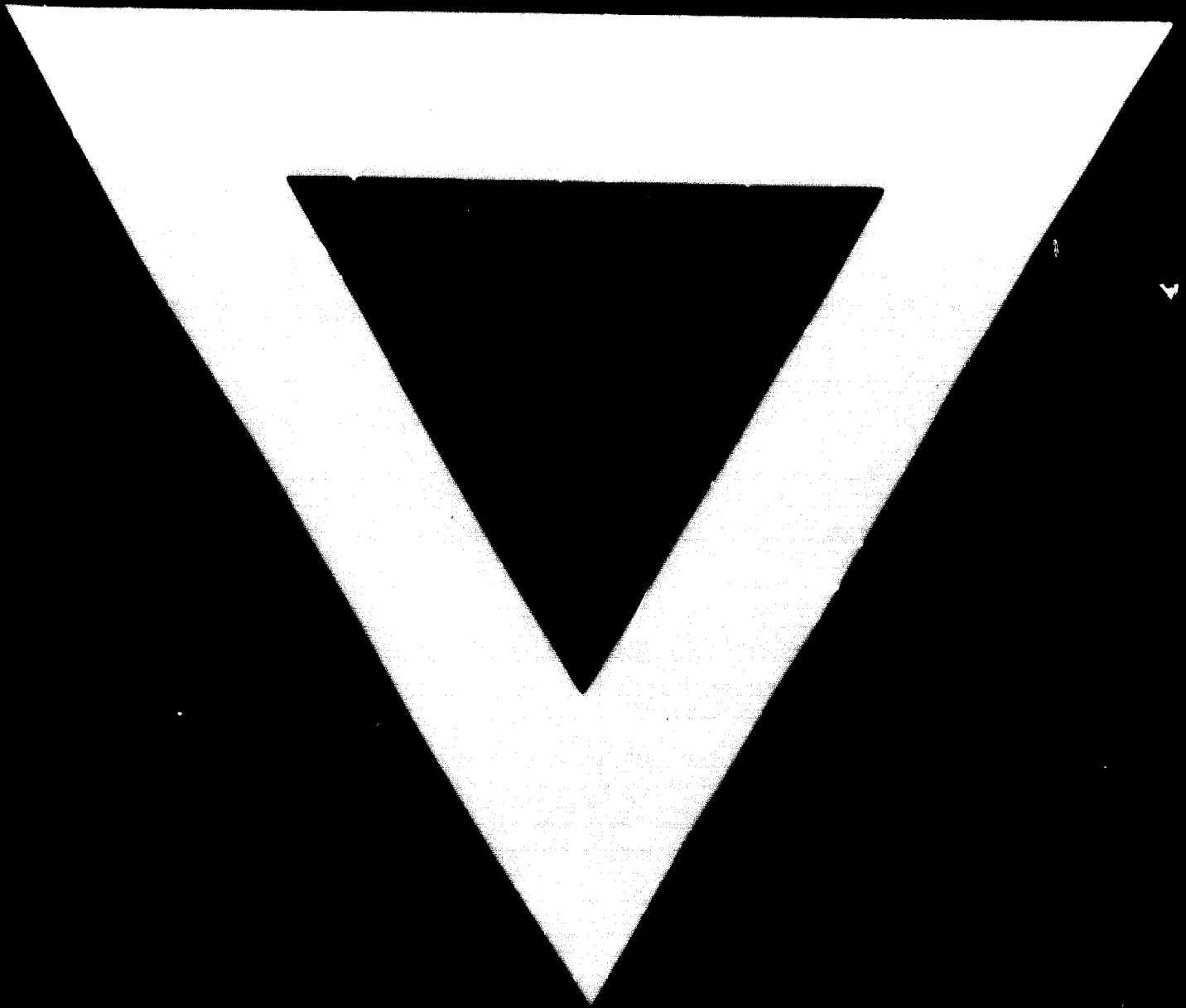
1. In operative paragraph 3 of its resolution 19 (III) on the utilization of computers and computer techniques for industrial development, the Industrial Development Board at its third session requested the Executive Director "to arrange for the report of the Secretary-General to be submitted to the Industrial Development Board at its fourth session, if possible, in order to enable it to consider those portions of the report which may be relevant to the competence and responsibilities of the United Nations Industrial Development Organization, together with any recommendations for appropriate action by the organization in this field as part of its work programme".
2. The secretariat indicates in this connexion that the report of the Secretary-General on "The application of computer technology for development", as referred to above, has been submitted to the forty-ninth session of the Economic and Social Council as document E/4800. As this document was issued on 20 May 1970, it could not be made available in time to the Industrial Development Board at its fourth session.
