

## RESOLUTION ADOPTED BY THE INDUSTRIAL DEVELOPMENT BOARD

3 (II) Establishment of a working group on programme and co-ordination

# The Industrial Development Board,

Recalling General Assembly resolution 2152 (XXI) under which the UNIDO was established;

Recalling the provisions of its resolution 1 (I) on the best possible implementation of its functions;

Bearing in mind that the principal functions and powers of the Board include:

consideration and approval of the programme of activities,

reviewing and facilitating the co-ordination of activities within the United Nations system in the field of industrial development and keeping the activities of the Organization under review;

<u>Recognizing</u> the fact that consideration by the Board of the work programme and its financial implications and co-ordination questions in the industrial field is a complex and time-consuming matter;

Expressing the wish to facilitate the task of the Board and to improve the quality of its work;

<u>Considering</u> that the Board mecording to Rule 62 of its rules of procedure may establish such subsidiary organs as may be necessary for expediting the effective discharge of its functions;

<u>Requests</u> the Executive Director to convene a Working Group of government representatives open to all members of the Boarl;

<u>Decides</u> that the functions of the Working Group which shall elect its own officers shall be to consider the documentation, prepared for the Board Session with a view to:

- a) examining the report on the post activities, the current programme and the proposed UNIDO work programme;
- b) assessing the financial implications thereof;
- c) identifying and commenting on problems of co-ordination in the industrial development field;

<u>Decides</u> that beginning in 1969 the Working Group would meet at the sect of the Organization about two weeks prior to each annual session of the Board and should report its findings to the Poard for its consideration.

<u>Further decides</u> to review the composition of the Working Group of its third session in the light of experience gained.
