NOTE ON THE ORGANIZATION OF THE WORK OF THE THIRD SESSION OF THE INDUSTRIAL DEVELOPMENT BOARD

1. According to the functions assigned to it in paragraph 2 of resolution 3(II) adopted by the Board at its second session, the Working Group has considered the following items:

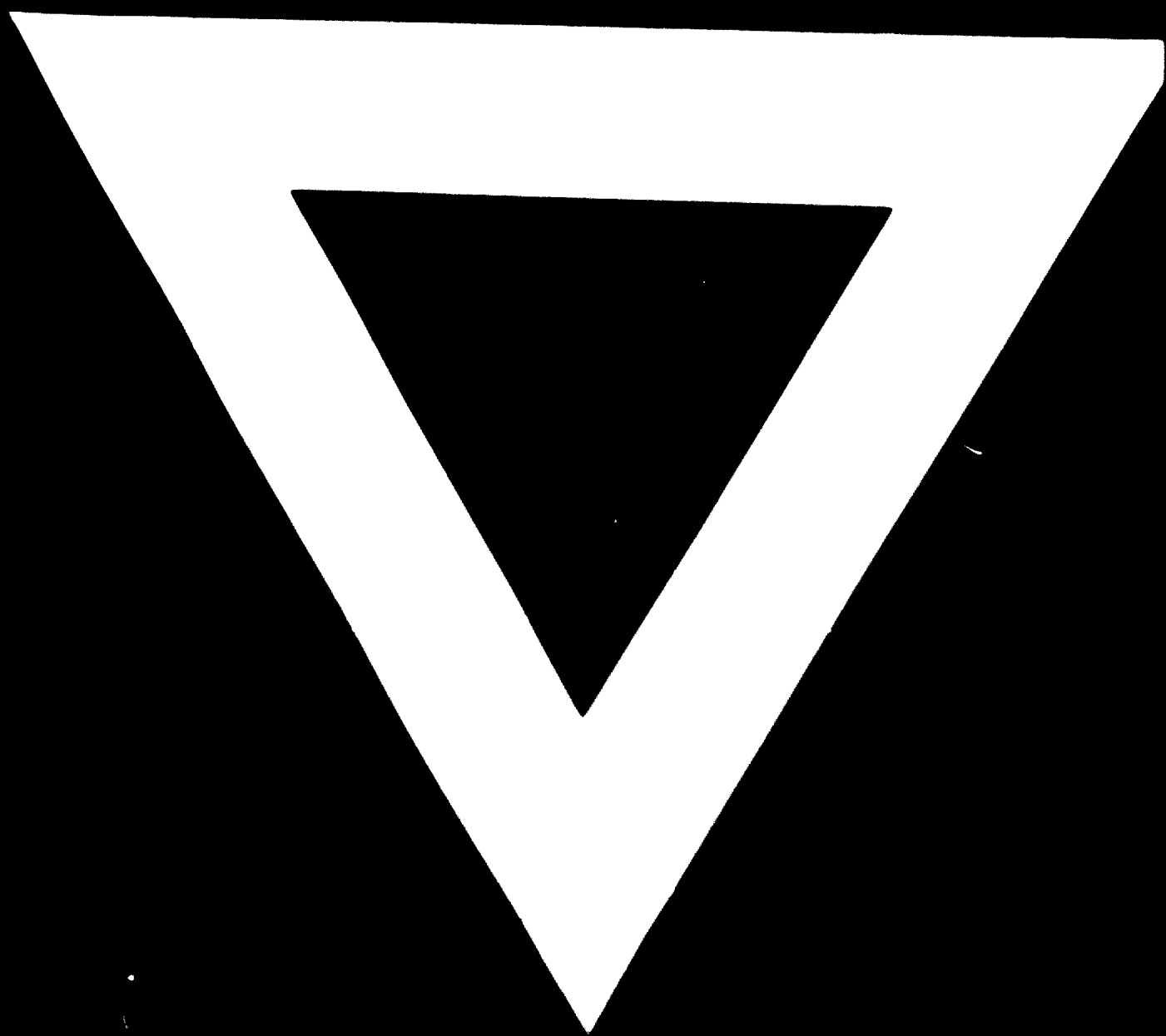
2. The results of the discussions of the Working Group on the above items are contained in its report which will be submitted to the Board as document ID/B/WGPC/2 and Add.1.
