NOTE FOR PARTICIPANTS

INPORTANT: ALL PARTICIPANTS ARE REQUESTED TO CAREFULLY STUDY THIS NOTE. THIS NOTE HIGHLIGHTS THE TECHNICAL AND ADMINISTRATIVE ASPECTS COMMECTED WITH THE EXPERT GROUP MEETING, AND ALSO OUTLINES GUIDELINES THAT ARE TO BE FOLLOWED BY ALL PARTICIPANTS

1. OBJECTIVE OF THE EXPERT GROUP MEETING:

The International Rice Research Institute (IRRI), Philippines, has developed a number of agricultural implements and machinery suited to rice oultivation. IRRI is also engaged in promotion of selected equipment thus developed in a number of developing countries. The United Nations Industrial Development Organisation (UNIDO) is engaged in sesisting the developing countries in the process of industrialisation. Local manufacture of suitable agricultural machinery and implements is one of the areas of activities of UNIDO. The UNIDO mission on Rice Mechanisation Machinery and Implements Manufacture in selected nine countries of Asia and the Par East region in 1972 has highlighted manufacturing opportunities as well as investment promotion possibilities in specific terms.

At the 1973 UNIDO-IRRI Expert Group Meeting, all participants in general and those from the developing countries in particular are expected to accomplish the following:

- (a) Identification of specific machinery developed by lRRI, which may have a market potential in the home country.
- (b) Identification of manufacturing units in the home country which may take up local manufacture of such selected specific machinery and equipment.
- (c) Formulation of co-operative UTDO-IRRI-homo country programmes for promotion of local manufacture of such machinery and equipment.
- (d) Investigation of the possibilities of investment prometion of selected agricultural machinery and implements in the home country.

2. PRELIMINARY WORK TO BE CARRIED OUT BY PARTICIPALITS:

The participants, from the developing countries, prior to the participation in the Expert Group Meeting, are requested to:

- (a) Carefully study the enclosed selected background papers and provisional agenda.
- (b) Discuss with national agricultural machinery research and development institutions, selected manufacturers and relevant Government officials on the possible line of specific actions to be taken for the promotion of selected agricultural machinery with reference to the objectives of the Expert Group Meeting mentioned above.
- (c) Formulate preliminary proposals on possible UNIDO-IRRI- home country co-operative programmes regarding prototypes and designs and technical information procurement, local pilot manufacturing activities and promotion of local manufacture with reference to IRRI developed products, possible commercial investment promotion projects and expected role of UNIDO through technical assistance towards the realization of these objectives.

3. TRAVEL AND FINANCIAL ARRANGEMENTS:

- (a) Participants, whose travel and living expenses are borne by UNIDO:
 - (i) Flights will be arranged by UNIDO by 5 March 1973 through "Wagons Lits/Cook" Vienna and their offices or agents in the country of the participant, to follow the most economical direct route to Manila International Airport and return.

Participants should not purchase their own tickets and rhould wait for the formal travel authorization and notification that their tickets are issued.

- (ii) An "out of pocket allowance" of US" 5.00 (five) per day for 5 days (12 to 15 March 1973) plus an allowance of US\$ 17.00 (seventeen) for three days to cover travel time and miscellaneous expenses. Thus a total of US\$ 75.00 will be paid by UNID: through a cheque to the participants on 12 March 1973.
- (iii)Free lodging and boarding to the participants will be provided by IRRI from Sunday, 11 March 1973 to Friday, 16 March 1973, at Los Baños, Philippines.
- (b) Participants invited to attend at their own expenses:
 - (i) Participants are requested to make their own travel arrangements in advance.
 - (ii) Lodging and boarding at a nominal cost will be provided by IRRI from Sunday, 11 March 1973 to Friday, 16 March 1973, at Los Baños, the Philippines

4. TRAVEL SCHEDULE AND CONNUNICATIONS : ALL PARTICIPANTS

(a) All participants are requested to arrive at Manila air port by noon of Sunday, 11 March 1973. Ho hotel arrangements will be made by UNIDO for participants' stay at Manila City.

(b) It is recommended that all participants <u>provisionally</u> check the possible flight schedule and arrival time at Manila, and inform Dr. A.U. Khan of IRRI at the following address at an early date.

(d) IRRI will provide transport from Manila air port to Los Baños, Laguna, The Philippines, on Sunday, 11 Farch 1973, and return to the air port on evening of Friday, 15 March and Saturday, 17 March 1973.
(e) No hotel arrangements will be made by UFIDO at Manila City for participants who wish to stay on 17 March 1973 or onward.

5. VISA AND HEALTH REQUIREMENTS:

All participants are requested to secure the necessary visa to the Philippines and to secure relevant international health certificates in advance.

6. OTHER DOCUMENTS:

Technical papers and other documents not enclosed will be distributed to the participants at the Expert Group Meeting. All participants are requested to bring with them, so far received, all documents to the Expert Group Meeting.

7. PARTICIPATION IN THE DISCUSSIONS:

(a) In order to facilitate active participation in the technical discussions at the Expert Group Meeting, all participants in general and those from the developing countries in particular are recessed to prepare in advance short notes based upon the agenda and technical document enclosed, and supplement the same at the Expert Group Meeting through mutual discussions.

(b) All participants representing manufacturing organizations in industrialized as well as developing countries are recommended to take the opportunity at the Expert Group Meeting regarding information dissemination and investment promotion. It is recommended that about 40 sets of sales literature, technical brochures and information material on their product lines may be distributed to the participants at the Meeting.
