Date and place

1. The First Consultation Meeting on the Agricultural Machinery Industry will open on Monday, 15 October, at 9 a.m. It will be held in the Congress Centre, Stresa. The sessions will be held from 9.30 to 12.30 a.m. and from 2.30 to 5.30 p.m. daily. The attention of the participants is also drawn to the fact that it is envisaged to convene, as to be agreed by the Consultation Meeting, two working groups.

List of participants

2. A provisional list of participants will be made available on Monday, 15 October, to all participants. Only names which are communicated to the Secretariat by 10 October at the latest can be included in this provisional list. The final list of participants will be issued before the conclusion of the meeting.

Registration of participants

3. Registration will open on Sunday, 14 October, from 3 p.m. to 6 p.m. and will continue on Monday 15 October from 8.30 a.m. Participants will be directed to the registration desk in the Congress Centre.

Identification badges

4. Participants will be given identification badges bearing their names and country or organization when they register. For security reasons, the display of the badge issued by the conference secretariat is necessary for admittance to the conference area and the meeting rooms.

Documents

5. Participants are invited to bring the documents they have received for the meeting through advance despatching. A limited number of documents will be available at the documents distribution centre in the Congress Centre on Sunday, 14 October from 3 p.m. to 6 p.m. and on subsequent days from 9 a.m. to 6 p.m. or to the closure of the daily session.

Plant visit

9. For those participants wishing to visit the FTAT installation in Turin provision has been made to do so on 19 October. Further information on this subject will be available at a reception desk in the Congress Centre.


12. A telex circuit will be available for those participants wishing to utilize this service; the telex number is 200.396 Palturi.
