Final Report

Introduction:

In June 2002 (June 18 – June 20) a study tour to Lower Austria for participants from Slovakia, dealing in their regions with the problems of regional development, has been carried out. The whole tour was prepared by Benjamin Kuscher of Eco Plus. The main idea of this trip was the transfer of know-how about the different ways of regional development.

Aim:

The main task of this study trip was getting knowledge in investment service, industrial parks, business incubator and last but not least in cluster-management.

Participants:

This study trip was organised within the UNIDO project SLO/01/002. Thus most of the participants had their expertise in the field of regional development in Slovakia. The participants where employees of RDA's (Regional Development Agencies), City councils, ministries, governmental offices or investment agencies¹. The number of participants was together with Eco Plus and UNIDO 20.

The first day of the study tour concentrated on the subjects:

- Organisation of RDA's
- Industrial Parks and
- Cluster Management

During the first day the Slovak delegation had the chance to learn from presentations of Eco Plus departments "investor services" and "EU-Enlargement". Since Eco Plus co-operates very closely with the Vienna Business Agency, also a special presentation have been prepared by this development agency.

After these presentations in the Eco Plus Headquarter in Vienna best practice examples of business parks and industrial parks (Wiener Neudorf) have been shown to the Slovak delegation. Of special interest were the presentations about the organisation of industrial parks and cluster management.

The second day concentrated on the subjects:

- Cluster experience and
- Technology Centres

This day started with a visit to a small sized enterprise, which participates in the Automotive Cluster of Eco Plus. There the participants got informed about advantages and disadvantages of clusters for a SME.

In the afternoon the trip concentrated on the organisation of technology centres. In the headquarter of the RDA of Burgenland the participants were offered presentations about other practical examples as the Business and Innovation Centre (BIC) Burgenland in Eisenstadt and numerous technology centres in the concerning region. Of special interest was the short history of this RDA, which showed some similarities to the agencies in Slovakia.

The third day concentrated on the subjects:

- Technology and Research Centres and
- Business Incubators

This day started with a very practical example, how a RDA in close co-operation with a city council is able to base numerous research institutions in a backward region. The second event of this day was placed in a business incubator where the participants got informed about different strategies to support start up companies.

A plenary session with a discussion about further activities marked the end of the study tour.
