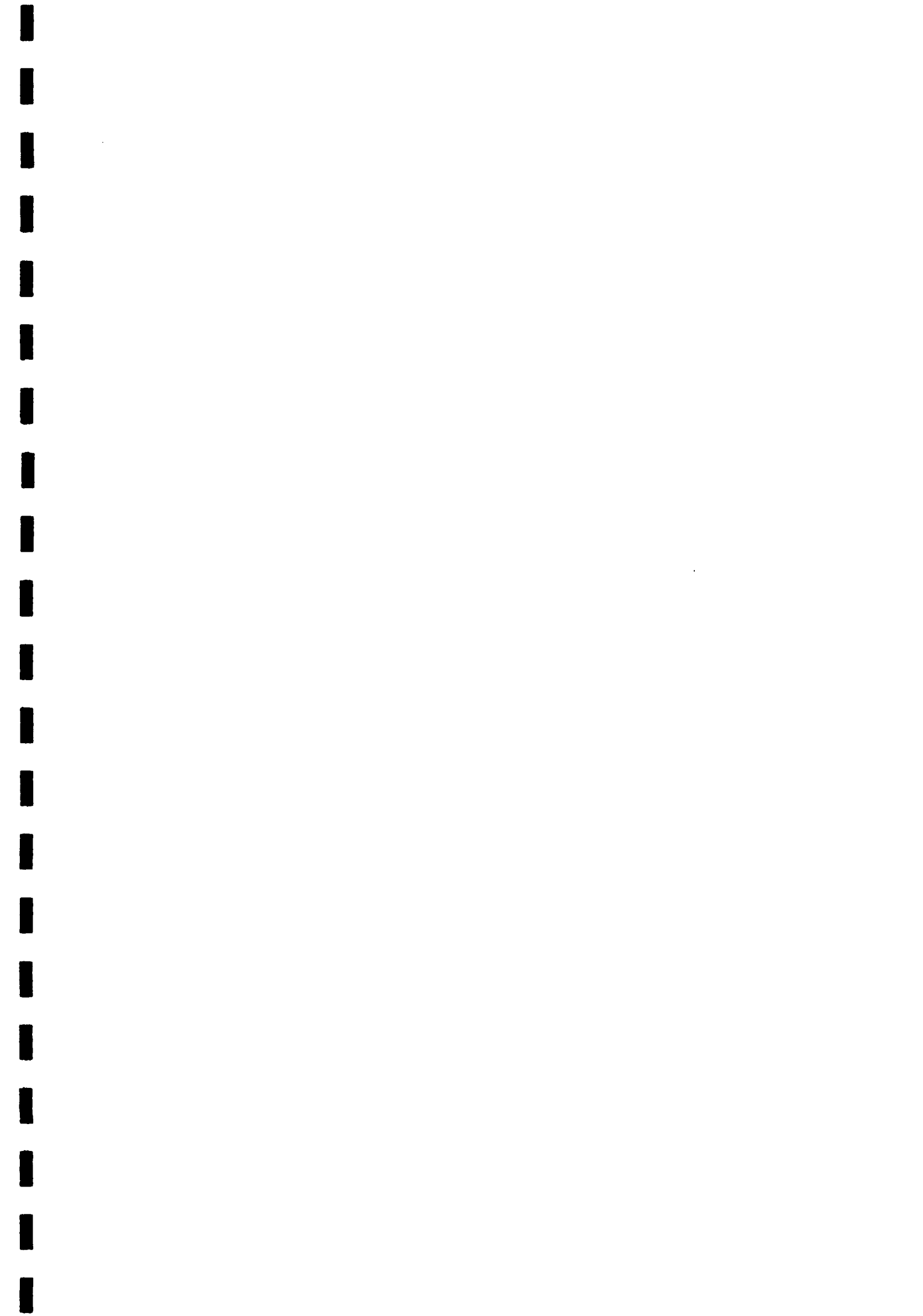

# I . Ghana

## 1. General Information

### 1.1 Diplomatic history

- o Formed diplomatic ties in November 1977.
- o Established embassy in Accra May 1978.
- o First Korean Ambassador to Ghana in September 1978.
- o Ghana-Korea friendship association established in June 1980.
- o Ghana embassy established in Seoul Korea November 1999.
- o Over 25 minister level officials visited Korea since 1981 and 10 minister level visits to Ghana in the same period.

### 1.2 Major agreements

- o Cultural Exchange Agreement : May 1987
- o Economic Cooperation and Trade Promotion Agreement : July 1990
- o Medical Cooperation Agreement : December 1993

### 1.3 Cooperations

- o Even before formal diplomatic ties, Korea sent medical, technical and sports instructors to Ghana from 1972.
- o Since 1980, Korea has participated in over 3.2 billion dollars worth of large economic projects.
- o Nearly 200 Ghana students came to Korea to study and to train in industrial and agricultural technology since 1982.
- o About 700 Koreans are living in Ghana as of June 2002. Over 300 of them are sailors. 250 people hold permanent residence status. Most of them live in Accra.

## 3. Overview of the Trade

### 3.2 Significance

Korea is one of the largest trading partner in Asia along with Japan and Thailand. While imports from Ghana is relatively meek, Korea is the largest exporter of machinery and automobile related products from Asia.

Even before the mid 90's, Korea has been actively trading

with Ghana from the early 1970's. Although Korea and Ghana is not a major trading partner as in terms of total trading value, both countries have remained important economic ally linking East Asia and West Africa.

### 3.3 Trends and prospect

A major transition is taking place in the main export products from Korea to Ghana.

Traditionally strong heavy machinery, automobile and its parts are now making way for fabrics, fishing net and cement products.

Until 1999, major exporting goods were machinery, automobile and its parts, engines, tires, TV sets, Motorcycle, electronic cables. Last year and again this year, major items have shifted to fabric, cement, fishing nets, electronic cables and other houseware goods.

This is mainly due to the economic situation in Ghana. Where fluctuation of the currency, 'Cedi' is unstable. Thus making traders, especially importers extremely difficult to speculate on the future of its economy.

Ghana still remains an unventured market for importing from Korea. Main imports are agricultural products such as Cacao beans/paste, wood, marine products and rubber. Some diamond dust and minerals are on the increase from year 2000.

Accept for the case of Cacao beans, we can only expect minimum growth in the import of agricultural products due to the distant location of two countries. Similar products from South Eastern Asia and China makes Ghana's products extremely difficult to access Korean market.

Processed marine products and natural mineral finds better chance than natural products. As chocolate gains popularity in Korea, Cacao is still regarded as a definite 'Ghana' product. Even a local confectionary named its major chocolate brand 'Ghana'.

Currently, Korea is keenly reviewing West Africa in terms of alternative location for overseas investment. The success story of a well known joint-venture company in Ghana, the 'AFKO' group is already luring many Korean prospective investors to Ghana.

This is a good news to future trade and investment relationship of Ghana and Korea. More Koreans will look to

Ghana for their logistic and industrial base for penetrating European and other West African countries.

## 5. Potentials and future

Most of the Korean companies trading with Ghana are positive about the future. The top 10 exporters and importers trading with Ghana reported no case of damage claim or compensation request.

Some of the top quality products like Cacao and Manganese ore are highly valued by Korean companies, where the importers won't seek other alternative business connection.

Trade pattern did not vary from other financially well established countries. Letter of Credit and Telegraphic transfer was normally accepted for payment by either side.

Although trade is slow for this year, such stability and security is the potential and base for prospective future and expansion of economic cooperation between the two countries.

With the success of AFKO, increasing number of Korean companies are expected to invest in Ghana to re-install their industrial base targeting neighboring countries or Europe, North America.

## II. COTE D'IVOIRE

### 1. General Information

#### 1.1 Diplomatic history

- o Formed diplomatic ties in July 1961.
- o Established embassy in Abidjan June 1966.
- o COTE D'IVOIRE embassy established in Seoul Korea 1997.
- o Prime Minister Duncan visits Korea December 1996.
- o Foreign Minister Hong, S. Y. visits Abidjan in January 1999.
- o Over 9 minister level visits from COTE D'IVOIRE and 6 visits from Korea since 1980.

#### 1.2 Cooperations

- o Number of Koreans residing in COTE D'IVOIRE is around 1,000. Less than 100 Ivorians live in Korea. Most of them are students and industrial trainees.
- o Direct investment from Korea(4 companies) reached 72 million dollars as of August 2002. Six companies have branch offices in the capital Abidjan, Nina Ivoire Sarl, Samsung Electronics, Amigo Shipping, LG Electronics, Korea Battery and Kim Plastic.
- o SK Group is currently participating in the multi-national oil refinery business in Ghana.

## 3. Overview of the Trade

### 3.1 Significance

Although COTE D'IVOIRE is far more an economic center in the West Africa region than any other neighboring countries, trade and investment activities with Korea is still insignificant.

In 2001, total export was 20,778 thousand dollars and import amounted to just 882 thousand dollars. Total volume

of trade increased 7.9% compared to the previous year(2000), but general trade amount has steadily decreased since 1997.

Korea is the 4th largest trading partner from Asia after Japan, India, Indonesia and Thailand.

Korea's major import commodities from the region, which are Cacao, wood products and marine products seemed to be concentrated more from Ghana or Senegal. Although COTE D'IVOIRE is the largest Cacao producer in the world, Korea imports only a fraction of its needs. This year, cacao imported halted completely.

This is due to number of reasons. Besides geographical factor, unstable political situation hampers Korean companies to venture into large business deals. According to local sources, credit based transactions are nearly impossible this year due to economic and political complications.

### 3.2 Trends and Prospect

Total trade volume until September this year is 20,586 thousand dollars and 1,318 thousand dollars. Compared with the same period, export increased more than 36%, but import decreased over 50%. With the current crisis in the country, stagnation in the trade is expected.

Major trading commodities remain nearly the same for the last 5 years. As Chinese and other African countries start to provide more and more goods to these region, Korean influence in the market is gradually decreasing.

Nevertheless, COTE D'IVOIRE relies heavily on second-hand automobiles, related parts and accessories from Korea. Major corporations like LG and Samsung is gaining ground in the market making Korean made electrical appliances very prospective. As of year 2000, 30% of Television sets, 25% of Air conditioners, 15% of Refrigerators are imported from Korea.

With the development of local canneries and food processing plants, introduction of Ivorian products to Korean market is still prospective.

## 5. Potentials and future

Unless the political and economic situation in COTE D'IVOIRE improve drastically in the near future, trade between the two countries will decrease even deeper. Only six Korean companies actually imported from COTE D'IVOIRE this year. None of the companies have actually visited the country.

Quality control of the traded products are conducted by a third party or brokers also residing in other countries. However, claim cases are rare.

Cacao, wood and cotton is in constant demand by many companies in Korea. Local manufacturers monitor the price change of these products daily through internet and other Value added service providers.



A monthly evaluation is performed in the internet KOTIS site(<http://www.kotis.net/country/>) on the prospective Ivorian products. Currently, 3 items, cacao, wood and cotton is posted.

Interestingly, all of the top 10 exporters from Korea are major trading house or conglomerate. Activities of small and medium size companies are rather difficult to find.

Payment is usually confirmed by a third bank in Europe or U.S. Direct transfer or DA/DP is seldom accepted for claim concerns.

Dramatic promotional measures such as exchanging trade missions or holding seminars on the industry in both countries is urgently needed. With the current crisis in the region, prejudice is amounting.
