(I) Summary

SIPC Background

ITPO Shanghai ("SIPC") was found in September 2001 based on an agreement between UNIDO, Shanghai Municipal Government and PRC. In April 2011, the agreement was renewed for another three years, as the third phase of cooperation.

The main objective of the project is to promote the inflow of foreign capital to Shanghai as well as the outflow of Chinese investments to other developing countries and countries with economics in transitions.

Working Summary in 2012

After SIPC completed the agreement renewal process and recruitment of new staff in Sep 2011, SIPC has been working closely with UNIDO global networks, Shanghai Municipality Government and Shanghai Foreign Investment Development Board ("InvestSH"), and established an extensive working network to promote investment and technology transfer between Yangtze River Delta in China and developing countries.

SIPC aimed to enhance local brand visibility; investment & technology project promotion and strengthen capacity of IPAs and Chinese enterprises, especially through the UNIDO global networks and local resources.

Following is the outcome in 2012:

- I Number of the outward investment projects concluded: 21
- I Total contractual amount of outward investment promoted by the Office: around USD64.19million
- Number of presentations/speeches on investment/technology transfer by the Office staff: 16
- Number of meeting with investment promotion delegations from other countries: 157
- Number of advising/consulting services (problem solving), to the potential companies/organizations that requested for assistance: 91
- I Number of investment promotion activities to be organized: 17



I Number of the investment projects for outward under negotiation: 12

(II) Working Strategy

The goals and objectives of SIPC are in line with the donor and counterpart in accordance with UNIDO priorities.

In 2012, priority attention was paid by SIPC to Africa, Latin America, South East Asia and EU countries to promote outward investment and technology transfer from China. From the figures for concluded projects, it can be reflected that, the contractual amount of concluded overseas investment projects has been increased around 15%, and more than 60% flowed to South East Asia regions, esp. Hong Kong SAR.

Technology transfer among developing countries and countries in economy transition is another working focus. In April 2012, SIPC, Shanghai Co-way Co. Ltd., together with UNIDO Moscow ITPO signed a 3-party MOU to a commitment of technology transfer collaboration between two countries. However, till now no commercial technology transfer case was concluded. Some technologies were promoted to the stage that potential partner in developing countries was interested in technology and feasibility studies are under work.

Being part of UNIDO investment and technology promotion network, cooperation with UNIDO HQs, other ITPO field offices and other international organizations distinguished us from other local Investment Promotion Agency ("IPA"s). SIPC recorded more than 10 cooperation activities with UNIDO HQs or other field offices within ITPO network, which is related to facilitation on UNIDO HQ missions and participation in global forums. Through building up a closer relation with the global family, Chinese enterprises can be more accessible to the resources and project information.

(III) Investment and Technology Promotion Program

SIPC developed a working plan and strategy to implement more effective outward investment and technology transfer promotion.

In 2012, SIPC engaged in a vast array of information dissemination, matchmaking and follow-up consultancy assistance to private sector entrepreneurs. Intense cooperation and networking of SIPC with Shanghai Municipality Commission of Commerce (SCOFCOM), InvestSH and local IPAs has been conducted, which achieved satisfactory results.

SIPC performed various activities such as country presentation seminars, professional service workshop, roundtable meeting, newsletters and mission visits with global ITPO's and IPA's network.

Major Activities

55 weekly investment and technology promotion newsletters of UNIDO SIPC in Chinese have been circulated since Sep 2011 to the stakeholders including Shanghai Municipal Government, InvestSH and private companies, with the



features of international investment environment news, special coverage, project information and investment data analysis, which were welcomed by the government and private companies for policy and decision making.

17 overseas investment promotion seminars and workshops with 1030 participants have been organized, co-organized or supported by SIPC in 2012, including the themes of country presentations, professional service, cross-regional theme forums and UNIDO Green Industry Platform. Most of the country presentations or professional service workshops were co-organized with municipal government authorities, regional departments of InvestSH, Chamber of Commerce, foreign investment promotion agencies and commercial sections of Consulate Generals in Shanghai.

SIPC was distinguished itself as an important agency in Shanghai's international cooperation and was expected to represent both UNIDO and Shanghai with the arm of InvestSH in Yangtze River Delta Region. SIPC is now playing an increasing role in jointly implementing cross-regional economy cooperation initiative with other key stakeholder countries and international organization. To highlight that, SIPC jointly organized BRICS investment and trade forum in Shanghai in Oct 2012 with China International Centre for Economic and Technical Exchanges (CICETE) and Brazilian, Russian, Indian and South African Consulate Generals in Shanghai. SIPC also worked with Multinational Investment Guarantee Agency (MIGA) for a workshop to Chinese entrepreneurs to increase their awareness of overseas investment risks mitigation.

SIPC promoted UNIDO brand in Yangtze River Delta regions by actively participating investment promotion events like investment seminars, exhibitions, and conferences as UNIDO field office. In 2012, SIPC participated in 43 investment promotion activities/forums and held 157 meetings/discussions with IPAs like government agencies, foreign Consulate Generals and chambers in Shanghai. In particular, SIPC became a founding member of Shanghai Investment Promotion Partnership, which was launched in May 2012 by local authority to promote two-way investment by strengthening cooperation and communication among local and overseas investment-facilitating institutions.


4 cross-regional cooperation initiatives have been promoted to strengthen investment and trade ties in municipality government or district government levels. Taking the advantage of respective industries clusters in Shanghai and Rhône-Alpes in France, a cooperative MOU between InvestSH and Enterprise Rhône-Alpes International was signed in Feb 2012, with the support of SIPC. Similar cooperative MOU in aerospace sector has been signed between Shanghai Zhuqiao District and Paris CDG region and MOU in two-way investment promotion between SCOFCOM and Pro Ecuador in June 2012.

š SIPC is now increasingly focused on technology transfer promotion since the starting of the third phase of cooperation. SIPC has developed an extensive network with technology transfer partners based in Yangtze River Delta. In Dec 2011, Shanghai International Technology Exchange Center (SITEC) was established by Chinese Ministry of Commerce and Shanghai Municipal Government, aiming at the city strategy of constructing international technology exchange and transaction platform and developing trade in technology. By utilizing the resources and support from UNIDO HQ, SIPC jointly with SITEC and Shanghai Institute of Foreign Trade have arranged 12 workshops/lectures on technology promotion skills development and 1st China



(Shanghai) international technology fair to be held in May 2013.

(IV) Capacity Building

Since the beginning of Phase III, SIPC has carried out a series of investment and technology transfer programme to SIPC, IPAs staff and Chinese companies to enhance staff capabilities, institutional capacity of IPAs, private sector companies and government officials in developing countries.

SIPC played an important role as the connection between Chinese business communities and UNIDO investment and technology resources from UNIDO global ITPO networks, tools and programmes.

Through attending ITPO head meetings and visiting ITPO offices, SIPC staffs have exchanges of experience among ITPOs on best practices for technology promotion and transfer of technology. In cooperation with Paris ITPO, SIPC has assigned a reverse-delegate in May to promote the project between Shanghai Zhuqiao and Paris CDG region.

Delegate Programme

As invited by ITPO Paris, our National Expert- Ms. Lu Ping participated in Delegate Programme from 7-14 May, 2012.

The purpose of the mission is to promote the cooperation project between Shanghai Zhuqiao and Paris CDG region, share the investment and technology promotion experience of ITPO offices, and meet Sino-France companies' representatives for any of potential business cooperation. In June 2012, the bilateral investment and trade promotion MOU in aerospace sector between Shanghai Zhuqiao District and Paris CDG region was signed in Shanghai.

Developing Countries Government Officials Training Workshops

In corporation with SCOFCOM, Training Center of the Ministry of Commerce China-aid training programs and Chinese Embassies in developing countries, SIPC has held 4 training sessions for government officials from developing countries on Shanghai investment promotion mechanism, industrial development zones operation, technology transfer skills and etc.

109 government officials from developing countries have attended training sessions organized by SIPC in 2012.
