## **Main changes in relation to the ODG/EVA Work Programme and Budget 2010/2011**

The present document incorporates the following changes:

1. Postponement of the evaluation of UNIDO's Climate change initiative to 2012/13
2. Inclusion of country evaluations in Nigeria and South Africa and deletion of the country evaluation in Mexico. A subsequent increase of the 2011 budget by euro 34,000.
3. Inclusion of evaluations of two Indian centres: International Centre for Advancement of Manufacturing Technology (ICAMT) and the UNIDO Centre for South-South Industrial Cooperation (UCSSIC) in the 2011 Work Programme.

The changes are conformant to Executive Board decisions of 5 March 2010 and 14 December 2010 and of 31 January 2011, as well as a subsequent decision taken by the DDG after consultation with Executive Board members.

## 1. Background and purpose

At its meeting of 5 March 2010, the Executive Board (EB) approved the ODG/EVA Work Programme for 2010/2011, agreed to allocate evaluation funds for 2010/2011 “... at the same level as the overall budget approved for the previous biennium” (euro 573,000) and released the first tranche for 2010 (euro 286,500). At its meeting of 14 December 2010, the EB released the second tranche of euro 286,500 for 2011.

The initial funding request for 2010/2011 amounted to euro 630.000 and the EB “agreed to review a request for an increase in the requested budget at a future meeting”.

The purpose of this revised Work Programme is to report on the ODG/EVA activities and outputs in 2010, to present a revised draft Work Programme for 2011 and to substantiate the request for additional funding.

## 2. Implementation of the 2010 Work Programme

In 2010, ODG/EVA initiated/conducted 26 evaluations in accordance with the approved Work Programme:

- Five country evaluations: Burundi, United Republic of Tanzania, Mozambique, India and China (two of them in One UN pilot countries, i.e., Mozambique and the United Republic of Tanzania). Field work for the China evaluation took place in January 2011.
- Three thematic evaluations: Enterprise upgrading initiatives, POPs projects and UNIDO Field Offices. These evaluations will be finalized in 2011.
- Evaluation of COMFAR and a meta desk evaluation of Integrated Programme (IP) evaluations conducted in 2008/09.
- 14 stand-alone project evaluations financed from the budgets of the respective projects.
- For two project evaluations (Multi-stakeholder Programme for Productive and Decent Work for Youth in the Manu River Union (MRU) and Construction of the CENAME laboratory building in Guatemala) no evaluation funds were available from the respective project budgets, although the projects, by their sizes, required mandatory independent evaluations. Therefore, the AMC Chairman agreed that these evaluations could be financed from the 2010/11 ODG/EVA Work Programme budget. In order to accommodate this change, the scope and budget of the evaluation of the UNIDO online procurement training was reduced.
- ODG/EVA also contributed to two evaluations conducted by donors.

In addition, several evaluations launched under the 2008/2009 Work Plan were finalized in 2010. The evaluation of the IP Sudan, the thematic evaluations of post crisis projects and of UNIDO's International Technology Centres as well as the evaluation of UNIDO-ICHET belong to this category.

Moreover, ODG/EVA, in collaboration with the Agro-Industry Branch carried out a thematic review of Agro-industry projects. Last but not least, the second phase of an overriding desk review, “*What has UNIDO done to reduce poverty – Evidences from UNIDO evaluations 2008 and 2009*”, was finalized and the review report was issued.

A full list of the evaluations initiated and conducted in 2010 is provided in annex A. The amount of the euro 286,500, approved by the Executive Board for 2010, was entirely obligated. Detailed information about allotments, expenditures and balances of individual ODG/EVA TC projects implemented in 2010 is given in annex B.

### 3. Work Programme for 2011

The large majority of the evaluations to be finalized or conducted in 2011 were included in the already approved Work Programme and budget for 2010/2011. One country evaluation; Mexico has been deleted and two country evaluations have been added, i.e., Nigeria and South Africa. Table 1 below provides the list of the planned **2011 country evaluations**.

Three **thematic evaluations** launched in 2010 will be continued in 2011 (UNIDO's enterprise upgrading initiatives, UNIDO POPs projects and UNIDO Field Offices) and two additional thematic evaluations will be launched (UNIDO's contribution to One UN mechanisms and UNIDO's contribution to MDGs). Budget information is provided in Table 2 below. Annex C provides details on the individual projects included in the thematic evaluations.

#### *Thematic evaluation of upgrading initiatives*

The draft TORs for this evaluation were developed and circulated in 2010. Based on the feed-back received, the scope of the evaluation and the projects to be included are currently under discussion.

#### *Thematic evaluation on UNIDO POPs projects*

This thematic evaluation will be conducted to generate recommendations to and lessons for UNIDO, its implementation partners, including the GEF, and, to provide information on the relevance, effectiveness, efficiency, sustainability and progress towards impact of UNIDO POPs interventions. Several evaluations/reviews of individual projects will be a key source of information for the thematic evaluation. Furthermore, the evaluation will include a review of the UNIDO POPs portfolio and an analysis of UNIDO capacities at HQ and field levels with regard to design implementation, monitoring and evaluation of projects.

#### *Thematic evaluation of UNIDO's contribution to One UN mechanisms*

Findings from four country evaluations will feed into this thematic evaluation, which will also include an assessment of a project on resource efficiency and cleaner production and of the promotion of growth and economic opportunities component of the One UN Programme in Cape Verde, for which UNIDO is the lead agency.

#### *Thematic evaluation of field offices*

A field office assessment framework, a matrix and self-evaluation questionnaires were developed during 2010 and will be used in the 2010/11 country evaluations. A thematic report, synthesizing findings from the 2010/11 country evaluations, will be prepared towards the end of 2011.

#### *Thematic evaluation of UNIDO's contribution to MDGs*

At its 13th session, the General Conference adopted resolution GC.13/Res.6 – The crucial role of the productive sectors in supporting the achievements of the Millennium Development Goals - and requested the Director-General to report on specific means through which UNIDO can further contribute to the achievement of the MDGs to the 37th session of the Industrial Development Board. ODG/EVA has taken note of this request and will mainstream contributions to MDGs as one evaluation criteria in all its evaluations and in particular for strategic evaluations and country evaluations.

In 2011 ODG/EVA will thus continue its efforts to mainstream over-arching issues and MDGs in all its evaluations and, towards the end of 2011, develop an over-arching lessons-learned document with the working title “*UNIDO's contribution to MDGs*”.

In addition to an assessment on actual contributions, ODG/EVA will provide recommendations as to how UNIDO's monitoring and reporting on contributions to MDGs could be strengthened.

14 individual **project evaluations** are scheduled for 2011, many of which will feed into the country evaluations and the thematic evaluations. In 2011 ODG/EVA will also continue to be involved in evaluations carried out by donors of UNIDO executed projects. During the recent country evaluation of India and subsequent discussions with the Indian donor and the counterpart ministry, it was decided that independent

project evaluations of the International Centre for Advancement of Manufacturing Technology (ICAMT) and the UNIDO Centre for South-South Industrial Cooperation (UCSSIC) are to be conducted in 2011 and that evaluation funds would have to be released from the respective project budgets. These project evaluations will, thus, be added to the 2011 Work Programme. A list of project evaluations scheduled for 2011 is provided in annex C.

Under **other evaluations** the approved Work Programme for 2010/2011 includes the evaluation of the UNIDO *Online procurement training*, which was initiated in 2010 with a reduced budget and scope (see above).

The evaluation of UNIDO's *Climate change initiative* has been postponed to 2012/13. This evaluation will cover the implementation of the Organization-wide climate policy and the various actions initiated in relation to procurement, business travel, staff awareness and in Buildings Management through the "Greening the VIC initiative".

#### **4. Methodological development, organizational learning and capacity building**

During 2010 ODG/EVA continued the development of an Evaluation Manual to be used by UNIDO staff and consultants as well as in capacity building events. As already detailed in the 2010/2011 Work Programme document, ODG/EVA will pursue its efforts towards strengthening evaluation capacities of decentralized functions. This is in line with present practices of most development cooperation agencies and, in addition, the continuous and rapid growth of UNIDO's technical assistance portfolio makes it difficult for ODG/EVA, at its present capacity, to manage all mandatory project evaluations.

Moreover, ODG/EVA aims to, within the context of the forthcoming UNIDO Institute, and in cooperation with RSF and HRM, implement evaluation-related training for staff of counterpart ministries. It is expected that this will contribute to enhanced utility of evaluations through a closer involvement of host country partners in the evaluation process. ODG/EVA will, furthermore, continue to develop evaluation tools such as evaluation frameworks, evaluation plans, minimum standards, impact evaluation methodology and survey instruments.

Efforts to increase the usefulness of evaluations and their contribution to organizational learning will continue. To this end, ODG/EVA will contribute to PTC Technical Seminars and participate, in an advisory capacity, in UNIDO's approval system: Screening and Technical Review Committee (STC), Appraisal Group (AG) and the Programme Approval and Monitoring Committee (AMC). In addition, ODG/EVA will monitor the usefulness of the management response mechanism and the effectiveness of recommendations and launch an initiative aiming at an improved use of lessons learned from evaluations.

The active involvement in the United Nations Evaluation Group (UNEG) and the Network of Networks on Impact Evaluations (NONIE) will continue with ODG/EVA staff contributing to the work of various task forces and participating in experience exchange conferences.



## 5. Approved evaluation budget

The overall approved budget for the biennium was euro 573,000, out of which euro 286,500 were allocated for 2011. The budget breakdowns are given in table 9 below.
