## National Ozone Unit Daily Activities :

- Continuing the role of the Ozone Panel, which was established through a ministerial decree No.93 on July 24, 1993. It included all related ministries and authorities, in order to meet the Egyptian obligations under the Montreal Protocol, and guarantee the complete phase-out of all ODSs by the deadlines adopted and approved by the MP parties.
- Monitoring and control of imports and use of ODS in cooperation with customs authority, Continuing the role of the NOU to put the ministerial decree NO. 77 issued in 2000 into action through the daily follow-up of with and establishment of a mechanism to get the NOU-EEAA approval is essential before customs clearance, as this decree prohibits the importation af any ODS and equipment using ODS's without notifying and getting an apprpval from NOU-EEAA, to assure Egypt's compliance to the Montreal Protocol control measures.
- Continue updating the information system to track imports and consumption of Ozone Depleting Substances (ODS) for the monitoring and licensing system in compliance with Montreal Protocol measures and rechecking it with customs.
- Continuing following up all ongoing ODSs phase-out projects, in variouse sectors (CFCs Sector ,Refregeration, Medicical Aerosol Sector (MDI), Methyl Bromide).

## c) The legislative framework in place or planned

There is cooperation between NOU and Custom Authorities to improve the effectiveness of ODS regulations. In this framework, the following actions were identified:

- Harmonized sub-regional approach.
- Inforce coordination and synergies at the national level with other Multienvironmental Agencies.

# d) The system in place or planned to monitor the use of ODS by sector of application.

## **Strategies for Control of Ozone Depleting Substances:**

The Ozone Unit took the following actions in order to execute the Ministry policies and directions for the protection of ozone layer:

- Continue the follow-up of all implementation actions taken by the Egytian Gevernment to ratify Beijing Amendments, <u>The ratification to Beijing</u> <u>Amendments has been endorsed and finally approved.</u>
- Monitoring and following up the import/ export licensing system in collaboration with the Customs Agency in order to ensure monitoring, control and reporting of ODS consumption to the Ozone Secretariat and Multilateral Fund.
- Updated the information system to track imports and consumption of ODS and their application in all sectors for the monitoring and licensing system in compliance with Montreal Protocol.

• In cooperation with UNIDO, UNDP, monitoring and evaluation of progress of implementation of ODS- Phase-Out activities (CFC, Halon, CTC, TCA, Methyl Bromide, HCFC & others).

Implementation of innovative strategies to phase out ODS (for different industrial sectors):

- I. CFCs Sector:
  - a. NPP-III Egypt
  - In coordination with UNIDO, NOU continues to follow up preparation TOR of for phase three of NPP- Egypt projects.
- II. HCFCs Sector:

- In coordination with EEAA, NOU continues to follow up conducting survey for preparation of Natioal Strategy for TPMP- Egypt projects.
- In coordination with UNIDO, NOU follow up conducting TOR for preparation and inplementation the second workshop (11 Apr. 2009) of Natioal Strategy for TPMP-Egypt projects.
  - c. Medicical Aerosol Sector (MDI):
- NOU continue following up the project implementation in cooperation with UNIDO, the Ministry of Health and pharmaceutical companies and the prgress is as follows:
  - 1) The bidding procedures for the selection of a technology provider for the development and formulation of five drugs at the two benifeciary pharmaceutical enterprises has beed repeated.
  - 2) Pamasol company from Switzerland will manufacture the equipment and VARI company from Italy will provide assistance to the two benifeciary pharmaceutical enterprises in formulating the new MDI products based on the VARI HFA valve.

## III. Halon Sector:

- a. In Coopertion with UNDP Cairo office and Helwan Co. (Host enterprise for Halon Bank) the NOU following up the receiving amounts of Halons to be recycled..
- b. Discussing with Helwan Co. (Host enterprise for Halon Bank) the possiblies of for inplementing stage 3 of the Egyptian Halon Bank project

## IV. Methyl Bromide Sector:

NOU continue the coordination of ongoing activities to facilitate a smooth implementation of the Methyle Bromide project in Egypt, this included the following activities:

- Follow up on the demonstration in the use of straw bales, as an alternative to MBr. in colaboration with UNIDO and EEAA.

- Follow up the implementation of 2008 & 2009 work plan in coordination with ARC, Project coordenator - EEAA and other stachkholders of the project.

# e) Training and public awareness activities;

- Updated the web page of the National Ozone Unit and the Egyptian achievements for protecting the Ozone layer.
- Conducting awareness campaigns especially directed to decision makers, customs officials, investors, laborers and the general public.
- Assisted in design and publish Bezra and Ozone special edition (Bezra, which means seed in Arabic, is a National comic character directed to children environmental awarness with an irrugular magazine)
- Distributing awareness material for protecting the Ozone layer on the occasion of new year 2009.
