



#### CONCLUSIONS

1. The Preparatory Committee on the Establishment of the International Centre for Genetic Engineering and Biotechnology (ICGEB) continued, on 2 April 1984, the examination of the items on the agenda adopted by it at its first session and arrived at the following conclusions:

#### Agenda Item

Implementation of Madrid Resolution, Particularly Relating to the Decision to be Taken on the Location of the Centre

- 2. Further to its decision contained in paragraph 27 of its report (document ID/WG.421/2) the Preparatory Committee attempted to reach a consensus to accommodate the points of view of some countries. Those attempts were not successful.
- 3. In the light of the above, the recommendation on the location of the Centre contained in paragraph 27 of the report of the Preparatory Committee is transmitted for consideration and decision by the Plenipotentiary Meeting to be held on 3 April 1984.

#### Agenda Icem 6

Matters Relating to the Establishment of Affiliated Centres and Networks

4. A representative of the Secretariat made a statement on this item. Delegations from Cuba, Venezuela and Yugoslavia indicated their intention to host affiliated centres and stated that they would transmit their offers to the Secretariat. They emphasized the importance attached to the affiliated centres as an integral part of the work of the ICGEB. The representative of Greece reiterated the importance attached by his Government to this matter and expressed readiness to provide the details of its offer within 6 weeks subject to a satisfactory final decision being taken by the Plenipotentiary Meeting. The delegation of Egypt indicated that it was premature to proceed with the discussion of the subject pending a decision on the structure of the Centre.

#### Agenda Items 7 and 8

Programme of Work of the Preparatory Committee and Financial Matters Concerning (a) Work Related to Arriving at a Decision on the Location of the Centre and (b) Further Programme of Work of the Preparatory Committee

5. It was decided to postpone the discussions of these items to a later session of the Preparatory Committee. The Secretariat reminded delegations of contributions requested to cover the cost of the sessions of the Preparatory Committee as well as the cost of the current meeting and requested them to arrange to transmit their share of the payments at the earliest possible opportunity.

### Agenda Item 9

#### Other Matters

- 6. A request was made that the letters addressed to the Chairman of the Preparatory Committee by the delegations of Egypt, Pakistan, Spain, Thailand and Tunisia following the issuance of its report (document ID/WG.421/2), be annexed to the conclusions. Accordingly, those letters are contained in Annex I.
- 7. The representative of Spain made a statement on the position of his Government on the ICGEB and the forthcoming Plenipotentiary Meeting and requested that his statement be attached as annex to the conclusions. Accordingly, his statement is contained in Annex II.

Mr. Chairman,

I have the honour to refer to the letter ID/452/62 dated 13th February 1984, attaching the report of the Preparatory Committee of 27th January 1984, (Doc. ICGEB/Prep.Comm./2/4), and in this regard as our delegation together with several other delegations were not present neither at the voting refered to in Paragraph 27, nor at the adoption of the report, I wish to make the following observations:

- 1) The Preparatory Committee at its First and Second Meeting was mandated by the Madrid Ministerial-level Plenipotentiary Meeting to "examine the location of the Centre in different locations and components ...", and in view of our delegation the Committee has not fulfilled this mandate at its Second Meeting, but reversed to the situation prevailing prior to the Madrid Decision.
- 2) The Secretariat in its report has exceeded its mandate, which was confined only to prepare a report "on the financial implications and the most economical means of the establishment of the Centre in multiple components", and has ventured to express opinions which were not within its mandate, and which influenced the deliberations of the Committee.
- 3) The informal meeting of Scientists has not, at any stage of its deliberations, fulfilled its mandate which was to apply the criteria agreed upon by consensus in the First Meeting of the Preparatory Committee to the offers made to host the components of the ICGEB, upon the request of the First Meeting of the Preparatory Committee.

- 4) Although it was obvious that no "extreme necessity" existed, the Committee chose to proceed to vote on the matter under discussion, contrary to its prior consensus, and in contradiction with the text and spirit of paragraph E of Doc. ID/EG/397/6 and against the repeated appeals to it not resort to vote.
- 5) Furthermore, no criteria, scientific or otherwise, was applied to the choice of locations of the ICGEB which has been proposed and voted upon, as mentioned in para. 27 of the report.

For the above-mentioned considerations, the delegation of Egypt has not taken part in the voting nor in the adoption of the report.

Should the Egyptian delegation decide to participate in the Plenipotentiary Ministerial Meeting, it will consider itself bound only by the conclusions reached by consensus in the First Session of the Preparatory Committee.

May I ask you, Mr. Chairman, to kindly circulate this letter to all signatories of the Statute of the ICGEB as an official document of the Plenipotentiary Meeting.

# PERMANENT MISSION OF PAKISTAN TO THE INTERNATIONAL ORGANIZATIONS VIENNA (AUSTRIA)

Mr. Chairman,

This Mission has received a copy of the report, ICGEB/Prep. Comm./2/4 dated 8 February 1984, sent by the UNIDO Secretariat alongwith its letter No. ID 452/62 of 13 February 1984, on the meetings of the Preparatory Committee on the establishment of the International Centre for Genetic Engineering and Bio-technology.

We have carefully considered the contents of this report and wish to convey to you the following comments:

- 1. We believe that the report of the Preparatory

  Committee has failed to reflect the views expressed in

  favour of a multi-component ICGEB on considerations of

  technical and financial aspects involved and the potential

  benefits which would accrue through enlargement of parti
  cipation of countries interested in hosting components of

  this Centre.
- 2. The Preparatory Committee has failed to examine properly the location of the Centre in different locations and components which it was required to do under the mandate given by the Madrid Ministerial Level Plenipotentiary Meeting. This fact was brought to the notice of the Preparatory Committee by our delegation alongwith many other delegations during its second session from January 24-27, 1984.

- decision making as agreed upon in the first meeting of the Preparatory Committee, a devisive procedure of voting was resorted to without giving a fair chance to those proposals which were aimed at reaching a compromise. We believe, that this procedure was not only contrary to the agreed upon principle of consensus as a basis for taking decisions on this matter but would also have strong negative consequences for the establishment of the ICGEB itself. On these considerations, Pakistan and several other countries, who had made some commendable efforts for arriving at an agreed consensus, could not make themselves a party to the forced voting or to the results of such voting.
- 4. Pakistan delegation feels that under these circumstances no useful purpose will be served by holding the scheduled plenipotentiary meeting to discuss a decision which does not have the full backing of an already small house of 28 members. The house is split at this stage and any decision forced by the plenipotentiaries could prove to be counter-productive. It is our considered opinion that in the larger interest of international cooperation and promotion of this new and promising technology in the service of developing countries, it would be desirable to postpone the plenipotentiary meeting from the first week of April to a suitable later date. In the meantime a special meeting of the potential host countries or of the Prepcom may be convened to facilitate

consultations among interested signatory states with a view to finding a solution acceptable to all so that the sprit of collaboration can be insured from the very beginning of the establishment of the ICGEB.

May I request you, Mr. Chairman, to kindly circulate this letter to all signatories of the Statutes of the ICGEB, and to also issue this as an official document for the next meeting of the Preparatory Committee.

Dear Mr. President,

With reference to the "Report of the Preparatory Committee to the Plenipotentiary Meeting" (ICGEB/ Prep.Comm/2/4), dated 8 February 1984, I have the honour to inform you of my Government's opinion.

2.- The competent Spanish authorities cannot accept the Report in question as a working document for the Meeting of Plenipotentiaries scheduled for 3 April 1984. The Delegation of Spain left the Preparatory Committee before the voting and did not participate in the vote, nor did it take part in the rest of the Second Meeting, as is recorded in paragraph 25 of the Report. Consequently, the Delegation of Spain did not adopt the Report.

3.- The Resolution (Doc.ID.WG.397/9, Annexa IA) on the Preparatory Committee, adopted by the Ministerial Plen-ipotenciary Meeting of Madrid, establishes that the "Committee shall be composed of one representative from each of the signatory States" and that "the representative shall preferably have a background in fields relevant to the planned activities of the Centre".

Unfortunately, not only did many delegations participating in the meetings of the Preparatory Committee not have a biotechnologist as Representative, but

ult was that a discussion of generalities prevailed in the meetings, which made any systematic, scientific and economic analysis impossible, and, consequently, the Report fails to provide a rationale for the proposal put to the vote (paragraph 27 of the Report). Furthermore, the proposal did not correspond to the mandate within the framework of which the offers were submitted - a mandate that the Committee had agreed by consensus at its first meeting.

- 4.- In order to decide whether Spain will be able to participate in the Meeting of Plenipotentiaries the competent Spanish authorities wish to know whether it is possible, before holding that Meeting, for a Special Meeting of the Preparatory Committee to be convened in which each Signatory State would be represented by a scientist, as foreseen in the Madrid Resolution, or whether by any other procedure guaranteeing competent scientific and economic analysis the Spanish offer for a component of the Centre self-financed and, in the opinion of the Spanish authorities, scientifically viable could be seriously evaluated.
- 5.- If it should prove impossible for the Spanish offer to be properly understood and fairly evaluated, so that Spain felt obligated not to participate in the Meeting of Plenipotentiaries, Spain would limit its financial contribution to the Centre to a symbolic amount, if any, and it would proceed with the development (already in progress) of a National Centre for Biotechnology with a pronounced international vocation, open to cooperation with any interested country.
- 6.- In order to facilitate a balanced consideration of their concerns in this matter, the Spanish authorities propose to the Signatory States that the Meeting for 3 April 1984 have the character of a Special Meeting of the Preparatory Committee, in which each Signatory State

would be represented by a scientist, to allow for thorough consultations among interested Signatory States, before holding the Heeting of Planipotenciaries.

7.- I ask you, Mr. Chairman, to be so kind as to circulate this letter, as an official document of the Preparatory Committee, to all Signatory States.

Mr. Chairman,

I have the honour to refer to the letter No.ID/452/62 dated 13 February 1984, enclosing the Report of the Preparatory Committee adopted on 27 January 1984 (Doc.ICGEB/Prep.Comm.2/4) and to inform you that the said Report is not acceptable to Thailand.

- 1. The said Report takes no account of the Report of the selected Committee (ID/WG.397/1) which recommends Thailand as one of the three suitable locations for ICGEB.
- 2. The Second Preparatory Committee has not fulfilled the mandate of Madrid Ministerial-level Plenipotentiary Meeting which instructed the Preparatory Committee to "examine the location of the Centre in different locations and components ..."
- 3. The informal meeting of scientists during the Second Preparatory Committee did not fulfill. the mandate to apply the criteria agreed upon by consensus in the First Preparatory Committee to the offers made to host the components of the ICGEB.
- 4. It must be added that no scientific criteria were applied to the choice of locations of the ICGEB which had been proposed and voted upon, as mentioned in para 27 of the report.
- 5. Contrary to its prior consensus and in contradiction to the text and spirit of para E of ID/WG.397/6, the Committee chose to resort to voting as a means to resolve the issue on location of ICGEB. In objection to this hasty decision by voting, the delegation of Thailand walked out of the Second Preparatory Committee Meeting.

May I request you, Mr. Chairman, to be kind enough to circulate this letter to all signatories of the Statute of the ICGEB as an official document of the Third Preparatory Committee and of the Plenipotentiary Meetings.

The Permanent Mission of Tunisia in Vienna has, under cover of letter ID 452/62 of 13 February 1984 from the Secretariat of UNIDO, received the report ICGEB/Prep. Com. 2/4 by the Preparatory Committee on the Establishment of the International Centre for Genetic Engineering and Dictechnology. In this connection the Permanent Mission wishes to offer the following observations.

The second session of the Preparatory Committee held at Vienna from 24 to 27 January 1984 followed neither the letter nor the spirit of the conclusions adopted by consensus at its first session held on 24 November 1983. For:

- 1. Paragraph 1 (agenda item 5) of the conclusions of the first session states that: "the Committee agreed that the establishment of a Centre with multiple locations should be pursued, within the framework of the Statutes signed at Madrid ...". This recommendation has been totally ignored.
- 2. Paragraph 4 of the same document ICGEB/Prep. Com. 1/5 invited the Governments of the seven countries to submit documentation analysing their offers with reference to the criteria described in paragraph 1 of the document. On that basis the Tunisian Government renewed its offer, raising it to approximately 27 million dollars. This offer has not been studied by the Committee.
- 3. The divergent points of view put forward during the informal meeting of scientists have not been faithfully reflected in the report, and the statements at the meeting were very often made by delegates who had no scientific qualifications; the work of the meeting therefore did not assume the technical character specified in its terms of reference.

- 4. The constructive proposal for a compromise put forward by the Executive Director of UNIDO in CRP/10, although it was supported by a number of delegations including that of Tunisia, has been simply passed over in silence in the report.
- 5. One group of countries unfortunately forced a vote on document CRP/13, the first paragraph of which originally referred erroneously to paragraph 51 of the Belgrade report and to paragraphs 44 and 81'4' of the Madrid report, and likewise to paragraph C of the Preparatory Committee's resolution a state of affairs that was of course likely to mislead ill-informed delegates. Although it was subsequently amended, this document merely illustrates the turn taken by the discussions, and involves the responsibility of its authors.
- 6. The so-called vote and the choice resulting therefrom were in no way based on any kind of comparative study of the technical or financial merits of the seven offers put forward.
- 7. Following this chain of "aberrations", the Tunisian delegation reserved the right to reconsider its offer, after having drawn your attention to the importance of reaching decisions by consensus. The delegation preferred not to participate in the vote and not to assume any responsibility for the failure of a substantial project which was originally meant to be a serious, valuable and joint effort and to which Tunisia had wished to make a generous contribution.

In the light of the foregoing it would be prudent to defer the date of the meeting of the Plenipotentiaries, at present set for 3 April 1984, in order to permit fresh consultations.

I should be obliged if you would kindly proceed to distribute this letter to all signatories of the Statutes of the ICGEB as an official document for the meeting of the Plenipotentiaries or, as appropriate, for a forthcoming meeting of the Preparatory Committee.

#### ANNEX II

### Statement of the Delegation of Spain

Mr. Chairman,

I want to make a statement on the position of Spain with regard to the ICGEB.

Taking into consideration the aims of the foreign policy of Spain and also our permanent intentions and activities to encourage the transfer of technology and resources from developed to developing countries, my Government has been in favour of the initiative of UNIDO in order to establish a Centre for Genetic Engineering and Biotechnology. That is why my Government agreed that the Ministerial-Level Plenipotentiary Meeting be neld at Madrid. That was the case last September.

As a second proof of our goodwill for the idea, my Government made on that occasion a generous offer of US\$ 15 million in addition to other facilities to cover the expenses of the Centre in concessionary terms which substantially would be used to subsidize the Centre at Madrid. Later on our scientists participated continuously in the decisions of the Preparatory Committee during its two sessions held in the months of November 1983 and January 1984.

Our delegation has been trying to reach a compromise solution during both parts of the Preparatory Committee based on the following four points:

- 1. The Centre is politically of the utmost importance.
- The Centre has to be a Centre of excellence and the host countries have to bear major financial burden of its functioning.
- 3. The multiple location is not the most expensive in terms of asking larger budget to be shared among the signatory countries of the Statutes. On the contrary, it has been demonstrated that the more countries that participate, the more resources you can put to work with less cost (per country).
- 4. The Centre should not be a controversial issue among the developing countries and the developed countries, but, on the contrary, it has to be a common project in favour of the global effort for biotechnology. The course of events has gone in a different direction.

The two component centre was a formula voted upon, i.e. abandoning the principle of consensus. That situation raised serious objections about the reasons why the offer made by my Government was not taken into consideration. The Spanish offer was

- (a) scientifically impeccable;
- (b) financially viable:
- (c) politically acceptable.

So we made a last attempt to reach a consensus presenting a draft accompanying four more countries in the informal meeting that was held today. We thank the 10 countries that considered our paper a basis from which to reach a consensus before the Plenipotentiary Meeting of tomorrow.

Under these conditions I have instructions that my delegation will not be present at the Plenipotentiary Meeting. This attitude does not mean that Spain withdraws from their continuous policy of co-operation with the developing countries. On the contrary, I am advised to announce that the Spanish Centre, which is already functioning, shall be available to co-operate in the field of genetic engineering and biotechnology.

Mr. Chairman, in this lengthy discussion we must say that at a certain point of time we almost had a consensus about the Centre, its locations and the division of the tasks, but the spirit of that time has not been maintained. Spain does not withdraw from the consensus achieved at that time.

I would like to state that my delegation will only be present in an observer capacity at the Plenipotentiary Meeting tomorrow.
