Introduction

The UK Government Know How Fund has established Trust Funds in order to support technical assistance programmes for the Governments of the countries in Central and Eastern Europe. These projects are administered by the United Nations Industrial Development Organisation (UNIDO).

The twelve month project, Company-wide Quality Control for Industrial Development in Hungary, project number TF/HUN/90/912, was approved in October 1992, with the host country counterpart and recipient identified as the Ministry of Industry and Trade (MIT).

The objectives of the project are twofold:

- to strengthen the division for Industrial Development within the MIT to increase the technical level of its regulatory and advisory services, and
- to enable the MIT to decide on the functions and the costs of the establishment, as well as the continuous operation, of a non-profit making Quality Centre for Industry and Trade.

The project promotes the application of the UK's experience in the field of developing and managing national quality policy and programmes to the current economic environment in Hungary.

Background to the visit

The overall project consists of various outputs and activities which are intended to introduce a National Quality Campaign and the development of a Centre for the promotion of Quality Assurance in Hungary including the following elements:

- A study of the formulation, implementation and promotion of quality policy and programmes by the UK's Department of Trade and Industry,
- A study tour to the United Kingdom to look at major aspects of the UK strategy and

- practice of industrial quality policy and programme control,
- The development of publicity documents and video materials in Hungarian,
- The development of a database and library,
- Study tour to the UK to attend training courses on quality assurance,
- Analysis of the problems which may arise in managing a quality campaign in light of the current Hungarian macroeconomic environment and market conditions,
- Assessment and ranking of existing Hungarian quality institutions to take on the role of the Hungarian Quality Development Centre for Industry and Trade,
- Assessment of the costs of establishment and continuous operation of the non-profit making Centre,
- Preparation of a set of customised textbooks and teaching materials in Hungarian,
- Preparation of a report on the approach to and operation of a Hungarian Quality Award for Industry and Commerce.

Resource was awarded a contract by UNIDO to undertake the organisation and management of the inward mission to the UK of three representatives of the Ministry of Industry and Trade (MIT) to investigate the development and operation of the UK Quality Campaign and quality infrastructure.

Report on the visit

A list of the organisations and individuals targeted by the MIT for the visit was supplied and used as the framework for the week of meetings. Where possible meetings were arranged with the selected organisations, and Resource also arranged meetings with organisations whose activities were considered of importance to the objectives of the group and the project. A copy of the programme was sent to MIT for their approval and the final visit programme is attached at Annex I.

Resource also arranged the travel and accommodation for the MIT officials' visit, which took place in the week 19-23 April 1993. A copy of the travel itinerary is attached at Annex II.

Of the three officials selected to visit the UK (curricula vitae are attached at Annex III), Mr

Dányi works in the Department for Technical Development and both Mr Kálmán and Dr Vass works in the Department for Industrial Development. All three are closely involved with the promotion of Quality Assurance to Hungarian industry and will be responsible for developing a report on their findings, which will be developed into a policy document to promote a national quality campaign and the establishment of the quality centre.

The group learnt about:

- the levels of funding required for the work undertaken by UK Government

 Departments to promote Quality Assurance and also for the involvement of independent UK organisations to promote Quality concepts;
- training possibilities and the training needs and qualifications for Quality Assurance professionals;
- the role of the consultant and methods by which consultancy services can be monitored;
- the importance of independent certification, registration and accreditation;
- how a National Quality Centre might be established and what the relations with Government and business would be;
- Information Technology and audio visual methods to assist in their objectives.

Conclusion

The visit was perceived to be successful by the group, which also received presentations and documents from a number of organisations whose activities are directly related to the MIT's aims and objectives.

Resource was pleased to be invited by UNIDO to organise the mission of the MIT officials and looks forward to being invited to offer continuing help to UNIDO and the Government of Hungary as the Qualtiy Programme develops
