### **Background and introduction**

Economic growth through diversification of industries has been given priority-attention by Government. Over the last few years, Government has taken the following steps with a view to promoting industrial development for creation of employment, production of goods for exports as well as for import substitution, and diversification linking agriculture and industry:

- a) the formulation of Industrial Development Policy and Legislation (Industrial Development Incentives Act 1978) spelling out the criteria for investments, both by local and foreign entrepreneurs, the fiscal incentives and other facilities provided by Government;
- b) establishment of a development bank inter alia to provide financial assistance in the form of loans to industries;
- c) establishment of a Small Industries Centre (Industrial Estate) covering a 12 acre area as infrastructure facility for setting up small scale and medium industries;
- a Rural Development Fund for providing financial assistance in the form of grants up to 50% of the project cost inter alia to promote rural industrial development;
- e) an Industrial Promotion and Evaluation Unit within the Ministry of Labour, Commerce and Industries to perform varied tasks of promoting and developing industries and business counselling to entrepreneurs.

To provide assistance to the Industrial Promotion Unit an Expert was recruited under the UNDP project TON/79/004 for three years. The Adviser was available to the Ministry for one year only as the project had to be dropped due to cut back of funds by UNDP. The Unit became functional in August 1983 (after a gap of 1-1/2 years) when CFTC assistance was available. However this assistance was terminated in June 1987.

The assistance envisaged from the present UNDP-UNIDO is precisely focussed on strengthening the institutional capability of the Industry Division and embarking upon systematic development of first generation indigenous entrepreneurs.

The strengthening of the institutional infrastructure for the promotion of the economic activities nationwide through small scale industries is a priority objective of the Government aiming to increase incomes and employment, while reducing the growing reliance of the Tongan economy on imported goods and overseas remittances.

It was felt that by taking deliberate measures of entrepreneurship development, the latent talent of indigenous entrepreneurship could be developed to set up viable enterprises. Also, working of the existing industries could also be improved.

Against this background, and arising out of a request by Government, a draft project was formulated in November 1985. After discussions, the project document was signed on 19 February 1987 by Government, UNIDO and UNDP. The co-operating agency was the Ministry of Labour, Commerce and Industries and the executing agency was UNIDO. The project became operational in June 1987 when the CTA was recruited and was in position.

Originally the project was conceived for a period of three years with UNDP inputs of US\$ 337,600. Government contribution at T\$107,990 was in the form of salaries of four counterpart officers of the Industry Division, office space, and secretarial assistance etc. Arising out of the Tripartite review held on 27 July 1989, the duration of the project was extended by 30 months. While the project objectives, concept and approach remain essentially the same, the extension was needed to consolidate the activities towards strengthening the Industrial and Business Advisory Unit so as to ensure the sustainability of support and technical assistance to small and medium industries after completion of the project.

Special emphasis was to be given to promote the involvement of Tongan entrepreneurs in setting up of joint ventures and for that purpose intensifying investment promotion efforts. After the latest revision, the UNDP contribution was increased to US\$ 714,057. The project ended in June 1993.

The international staff comprised CTA/Business Adviser and two UNVs. Local counterpart staff comprises four officers- Industrial Promotion Officer/Deputy Secretary, Assistant Industrial Promotion Officer, an Assistant Secretary and Senior Executive Officer. Details of the project staff are enclosed as Annexure - 1.

The development objective of the project was to actively promote and develop the industrial sector particularly small, medium scale and rural industries in the Kingdom and thereby to contribute to additional employment and income generation activities among the indigenous population in urban and rural areas, while helping to reduce dependence upon imported goods and services. Particular attention was to be given to the guidance and training of existing and potential indigenous entrepreneurs through deliberate measures.

During implementation, the objective of the project was not revised and the same was attained.

The following outputs were envisaged:

- 1. A functional Business Advisory Unit
- 2. Operational procedures with all agencies connected with industrial development in Tonga.
- 3. Establishment of 15 small scale Tongan enterprises.
- 4. Investment Promotion programmes aimed at promoting joint ventures with Tongan involvement.
- 5. Three training programmes per year for existing and prospective entrepreneurs.
- 6. Three trained counterparts who could take over and carry out the project activities at the end of the project.
- The following activities were envisaged

 elaborate and establish a system for identifying potential and viable projects for Tongan entrepreneurs: advise on selection of projects suitable to local skills, raw materials and capital availability;

- 2. carry out studies with a view to identify industrial products which could be locally manufactured on small-scale using appropriate technologies;
- 3. review current national policies and programmes for promotion of indigenous small enterprises and advise in the development and formulation of medium and longterm objectives for industrial sector and in designing an integrated Programme for Small and Medium-scale Industry Development;
- 4. make recommendations on the institutional framework for implementing the Small and Medium-Scale Industries Development Programme and the related industrial policies set by the Government;
- 5. advise in the development and formulation of medium and long-term objectives for industrial sector and in consolidating the integrated programme for small and medium industries development;
- 6. provide business counselling and extension service to:
  - local investors in formulating their projects and securing loans from Development Bank and/or commercial banks; in providing information on manufacturing methods, plant and equipment, marketing, etc.,
  - existing or newly established enterprises in improved management and organization methods, book-keeping, cost-price analysis, stock control, quality control and maintenance;
- 7. organize direct assistance (consultancies) to local entrepreneurs in selected industrial branches (as determined by the Government) through provision of short-term technical expertise from the regional project;
- 8. assist in establishing a programme for promoting joint ventures, particularly with involvement of Tongan entrepreneurs;
- 9. organize and assist investment promotion missions;

- 10. organize training through courses/workshops, study tours, fellowships as required, in association with the regional project and other UNIDO projects;
- 11. on-the-job training of national counterparts at Business Advisory Unit so as to enable them to take over the activities of the project after its completion.

The above activities were carried and outputs created.

Fellowship was provided under which the Secretary for Labour, Commerce and Industries undertook a visit to the Philippines to study the industrial development and export processing zones.

Satisfactory on the job training was provided to the counterpart staff on all aspects of work.

All equipment ordered were received. Year wise inventories of project equipment were carried out and were reported to the PAC. The signed copy of latest version of non expendable property record is enclosed as Annexure -2.

# Chapter I: Activities and output

The project provided assistance at three levels:

- Policy advice to Government
- Institution building
- Extension services to industries

This was carried out through the following activities:

(i) The Industrial Development Policy and incentives were reviewed in 1989 with a view to make them more effective and competitive in the region.

(ii) Assistance was provided in the formulation of the five year plan (1991-95) for the manufacturing sector.

(iii) Business advisory assistance was provided to the entrepreneurs in formulation of their proposals for availing incentives and financial assistance as also information sources of machinery, raw materials etc.

New industries were promoted through conduct of entreprenurship development programmes, industrial promotion seminars and business counselling.

Management skills were upgraded through conduct of commercial and management training programmes in the field of book-keeping and accounting, basic financial management, marketing management. Project personnel also visited the participants to render assistance in their offices.

Technical skills of the existing enterprises were upgraded through visits of specialised experts. The assistance was provided by visiting their enterprises and conduct of seminars where topics of common interest could be discussed.

Potential viable products suitable for manufacture by Tongan entrepreneurs were identified. The same were brought to the notice of the prospective entrepreneurs during their visits to the Business Advisory Unit and during the industrial promotion seminars and entrepreneurship development training programmes.

The counterpart staff was involved in all aspects of the project work as part of on the job training.

The following outputs were produced by the project and counterpart staff:

A Business Advisory Unit was established within the Ministry of Labour, Commerce and Industries. Most of the activities were carried out through the BAU.

Co-ordination was established with local, regional and international agencies and NGOs. This was maintained thrugh the involvement of the senior staff of the agencies in the conduct of the project programmes. Contact was also maintaine with the visiting officials of the agencies located out of Tonga. The main activities of the project were brought to the notice of the Standing Advisory Committee (SAC) on which the CTA was co-opted as a member. SAC is a high powered industry advisory committee headed by the Minister of Labour, Commerce and Industries. Other members are: Secretary for Labour, Commerce and Industries, Secretary for Finance, Director of Planning, Director for Agriculture and Forestry, Managing Director- Tonga Development Bank and General Manager of Bank of Tonga.

Joint ventures were set up and expanded through preparation of proposals for getting incentives and issue of DEvelopment Licence under the IDI Act. Proposals were prepared for mounting investment missions to New Zealand, Australia and U.S.A.. Meetings of prospective joint ventures were organised with the respresentatives of the Overseas PrivateInvestment Corporation (OPIC of USA, International Finanace Corporation (IFC) and the South Pacific Project Facility (SPPF) of the IFC. Industrial Promotion Seminars were organised inter-alia, covering information on investment opportunities and agencied providing information in setting up joint ventures.

Over 100 industries were established and/or expanded as a result of project activities. Details are enclosed as Annex-3.

Training programmes were organized in the field of Entreprenurship Development; Book-Keeping and Accounting; Basic Financial Management, Marketing Management, Automobile Repair, Diesel Engine Repair, Welding and Safety.

Training programmes on furniture and joinery industries and, garment making were organized with the assistance of regional project on small and medium industry development (RAS/075).

Specialized seminars were organized on: Industrial Promotion, Private Sector Development, Export Oriented Manufacturing Enterprises.

In all, twenty six training programmes/seminars were organized in Tongatapu and outer islands, under the auspices of this project. A list of training programmes/ seminars organized under the aegis of this project are enclosed as Annex-4. Thirty three per cent participants in these programmes comprised women. Details are given in Annex-5.

# Chapter II: Achievement of immediate objectives

The immediate objectives of the project were :

- 1. To establish an Industrial and Business Advisory Unit within the Ministry of Labour, Commerce and Industries (MLCI).
- 2. To advice and assist MLC&I in the development of policies programmes and project proposals for the effective promotion of the industrial sectors particularly small-scale industries

3. To assist the MLC&I with the aim of training the counterparts to take over responsibility of the Advisory Unit by the end of the project.

A Business Advisory Unit (BAU) was set up within six months of the inception of the project. The BAU is part of the Industry Division of the Ministry and is working in conjunction with its Industrial Promotion Unit (IPU). Under the aegis of the BAU, advisory and extension services were offered. Please see Annexure -6. These comprise:

- Information on investment opportunities
- Advise and assistance in preparation of proposals for availing incentives and other assistance from Government.
- Technical information on machinery equipment and raw materials etc.
- Assistance in preparation of proposals for availing financial accommodation- loan and grant funds
- In-plant visits of the existing enterprises for follow up on training programmes and to ascertain areas in which further assistance could be provided.
- Exposure visits to overseas countries
- Export marketing assistance
- Training programme and seminars

The objective No. 2 involved the following activities:

- Review of the existing industrial development policy
- Making recommendations on the institutional framework and industrial policies set by Government
- Assistance in appraisal of projects submitted to Government for grant of incentives and issue of development license under the Industrial Development Incentives (IDI) Act.
- Funding proposals prepared for conduct of specialized seminars on exporting to USA, and exporting to Japan.
- Provision of the services /approvals at one place (ONE STOP SERVICE) and making known the availability of these services.
- Identification of investment opportunities and bringing the same to the notice of prospective entrepreneurs.

- Assistance in conducting Private Sector Development Seminars and participation as resource persons in programmes organized by other agencies. Please see Annexure -7
- Conduct of industrial promotion seminars, entrepreneurship development training programmes, fellowships, special training programmes for upgradation of technical and management skills.

Review of the extant industrial policy was carried out in 1989. Strategies and recommendations were made and amendments to the IDI Act were carried out in stages to make Tongan incentives more attractive.

A detailed appraisal report for the expansion of the Small Industries Centre at Tongatapu to accommodate export oriented industries was prepared.

Assistance was provided for setting up the Management Information System with use of personal computers. Please see Annexure -8.

Assistance was provided in mounting Overseas Investment Mission. Details are enclosed at Annexure -9.

Identification of investment opportunities were carried out based on the earlier studies. List of identified industries are enclosed as Annexure -10. Profiles for investments were updated for setting up joint ventures with overseas investment.

The information was disseminated through the following:

- During visit of prospective entrepreneurs to the Business Advisory Unit
- Through conduct of Industrial Promotion Seminars of one to two days duration.
- Conduct of Entrepreneurship Development Training Programmes (EDTP).
- Through media, press and radio releases.

In conduct of Industrial Promotion Seminars, information on investment opportunities; incentives under the IDI Act and other assistances offered by Government, regional, bilateral and international agencies ; concessional entry of products as a result of special agreements such as SPARTECA, visit to local industries and exchange of experience with successful entrepreneurs etc. were provided. Please see Annexure -11.

In conduct of entrepreneurship training programmes, special inputs of achievement motivation, more details of investment opportunities, requirements of a bankable project, key contact with persons connected with implementation of industries, basic aspects of management and assistance in preparing business proposals is included in addition to the topics covered in the

Industrial Promotion Seminars. The training programmes on Entrepreneurship Development have been found to be an important tool for the development of indigenous small enterprises. Details of such a programme are enclosed as Annexure -12.

A special entrepreneurship development training programme was organized for women, at the initiative of the project. Details are enclosed as Annexure -13.

The CTA of the project was invited to assist in the conduct of Entrepreneurship Development Training Programmes and other matters relating to industrial development in neighbouring countries of the South Pacific. As such the project had also an element of Economic Cooperation Amongst Developing Countries (ECDC). Please see Annexure -14.

The conduct of the training programmes and seminars were carried out with the assistance and involvement of other concerned agencies and departments such as Central Planning Department; Tonga Development Bank; Bank of Tonga; New Zealand High Commission; Australian High Commissions, Chamber of Commerce; and Small Business Association, who deputed their senior officials as resource persons. In some cases funding assistance, was also provided by these agencies. For example the first training programme on entrepreneurship

development organized in June 1987, was mainly funded by CHOGRM Working Group on Industries but was organised under the auspices of the project. The second programme on Entrepreneurship Development in November 1987 was funded by the Australian Government. Assistance was also provided by the USAID through two consultants who were resource persons in the programme. The training programme on Book -Keeping and Accounting at Ha'apai was organised in association with the Tonga Development Bank. The special entrepreneurship training programme for women was jointly organised with the Tonga Small Business Association.

The third objective of assisting the MLCI with the aim of training local counterparts to take over the responsibility of the Business and Industrial Advisory Unit was carried out through full involvement of t' e counterpart staff in all activities carried out. The involvement was at all stages from planning, conduct and follow up activities. Howover, constraint of non availAbility of adequate local staff was always felt because of deputation of such staff on long study leave. For example the Industrial Promotion Officer (Now Deputy Secretary Industries) was away to England on study leave to study for MBA. Currently the Assistant Industrial Promotion Officer is away for his post graduation studies for two years in Australia.

Keeping in view the constraints indicated above, the results achieved compare favourably with the objectives of the project.

# Chapter III: Utilization of project results

The project results are the following:

- Establishment of a Business Advisory Unit
- Established programmes and operational procedures for co-ordination between IPU, MLCI and other government and institutions providing financial and or commercial support to small industries.
- Establishment of over 100 new industries through entrepreneurship development and/or through project activities

Conduct of 26 training programmes and seminars.
Three trained counterparts.

A Business Advisory Unit was established within six months of the start of the project. All the training programmes, seminars, extension services were carried out by this Unit which works as a part of the Industrial Promotion Unit.

Arising out of the review of the policies, amendments to the IDI Act and Regulations were carried out in 1990. Amendments to the IDI Act were also carried out in 1992. Amendments to the Regulations are under process.

The report prepared for the expansion of Small Industries Centre has been accepted as a substitute project for loan funding to the the tune of T\$ 1.1 million. Built up space to accommodate five export industries is expected to be completed by July 1993.

At the time of inception of the project about 100 industries were in operation. As of December 1992, over 200 industries were in operation.

A study on the establishment of Export Processing Zone was carried out jointly with a UNIDO consultant. Three Senior Officers of Tonga Government have undertaken exposure visit of successful export processing zones of developing countries of Asia/Pacific under UNIDO Fellowship.

In all 26 training programmes/seminars were organized under the auspices of this project. These were attended by about seven hundred participants. One third of which were women. The follow up of these training programmes indicated that the participants have utilized the knowledge gained.

Three counterparts have been fully trained to take over the responsibility after the departure of international experts.

# Chapter IV: Conclusions

In line with the immediate objectives of the project, integrated assistance was provided at three levels: industrial policy advice, institutional building and extension services including training programmes for private sector. The annual Tripartite Reviews found the progress of the project satisfactory.

In the process of industrial development, every developing country goes through certain phases of development. Tonga is no exception. Having laid the conducive policy framework, establishment of infrastructural facilities, setting up the Industrial Promotion Unit, initiation and implementation of the project under report-Small industries Promotion and Entrepreneurial Development, there are other logical steps to be taken. These are establishment of specialized institutions -Industrial Development Corporation, Export Processing Zone, Risk Capital Fund, Export Credit Guarantee Scheme. Government would need assistance in evaluation and implementation of these specialized institutions.

Following recommendations are made:

# **Recommendations.**

Non availability of built up space at the SIC has proved to be a constraint in attracting investments for Tonga. The preference of the investors being to rent the factory space rather than to build their own. There have been instances when the investors have gone to other countries where built up space was readily available. The project has assisted in making a report for expansion of the Small Industries Centre. However, there is urgent need for construction of about ten additional factory buildings at the Tongatapu SIC for accommodating export factories. Technical assistance needs to be provided for the same. UNDP/UNIDO

With a view to ensuring success rate of the existing enterprises, in-depth study of the existing enterprises needs to be carried out to find out problems faced by them and solutions for the same. Preliminary studies were carried out for few industries. These needs to be upgraded and further work in this area is necessary. Govt/UNDP/UNIDO

Entreprneurship development training programmes were organized for the first time in Tonga. Conduct of these programmes is essential on continuous basis for motivating and harnessing the latent talent for the availability of viable local entrepreneurs. It is recommended that these programmes be continued. A special training programme on entrepreneurship development for women was also organized under the aegis of the project. Non availability of institutional finance is also a constraint. Policies in regard to flow of funds to the small scale industries need to be strengthened. UNIDO

Majority of service oriented industries such as automobile repair enterprises, fabrication, welding etc. have been set up by indigenous entrepreneurs. Short term training programmes organised under the auspices of the project were well received. Technical assistance is required by these enterprises by way of short term training programmes to further upgrade their skills. UNIDO

Tonga has been able to offer the most attractive incentives. After recent amendments in the Industrial Development Incentives Act, Tonga's incentives for export industries are similar to those allowed in export processing zones. Technical assistance has also been provided by UNIDO for study of export processing zone as a policy option. It is recommended that Tonga should immediately establish an export processing zone. Government.

As a result of the review of the policy, certain incentives have been dropped and others enlarged to encourage the establishment of export oriented industries. Review of the industrial policy is an ongoing activity. To remain competitive, the policy and the incentives have to be reviewed from time to time. A review is again due as an independent exercise. Government.

With a small domestic market, the industrial investment opportunities are limited. Establishment of export oriented industries has been encouraged through better incentives in comparison to the import substitute industries. However, non availability of skilled manpower, distance from export markets, limited sources of institutional finance limit the industries which could be set up. Niche market products and relocation of industries from New Zealand and Australia are better answers. Government resources to have outward approach have been limited. Only one Investment Mission was mounted in 1988 to New Zealand. Increased allocation by Government is essential. Government.

It is recommended that on completion of the project, the equipment be transferred to Government, namely Ministry of Labour, Commerce and Industries, for use by the Industry Division (Business Advisory Unit) which needs this equipment including the project vehicle for its smooth running. #### Basic Financial Management. ( Four programmes ) Page-2

These programmes are extensions of the programmes on Book-Keeping and Accounting and include sessions on Financial Analysis, working capital management, profit planning, sources and uses of funds etc. Four programmes were organised in Tongatapu and outer islands.

#### Marketing Management.

The above training programme was organized in Tongatapu from 6-9 November 1990. The following topics were included: Introduction to marketing, marketing environment, marketing research, product planning, pricing, advertising and sales promotion, distribution and product display

### UPGRADATION OF TECHNICAL SKILLS.

#### Assistance to garment industry.

A five month consultancy was provided to garment industry in 1987. The expert visited various industries to provide hands on technical assistance. Training classes were also organized to provide one day per week. Mr Ron Mathews, UNIDO Consultant was recruited for the purpose.

#### <u>Agricultural handtools</u>

A consultancy on the development of simple agricultural handtools with local materials was provided . A display was also organised. Sample of tools were exhibited in the annual industrial and agriculture show. Mr Kherdaker was recruited for the purpose under the regional project RAS/075.

#### Furniture and ioinery industry

A specialized consultancy for furniture and joinery industry was organized in 1988. The expert visited all furniture and joinery industries and suggested improvements in their working. Mr. H Brion, UNIDO Expert, recruited under the regional project RAS/075, provided the expert assistance.

#### Bamboo product study

A study was organized in 1989 to find out the products which could be made from bamboo in Tonga. Mr Vincecio, a UNIDO Consultant provided the designs and practical demonstrations.

### <u>Training programmes for Automobile repair and small engineering</u> workshops ( Four programmes )

Automobile repair enterprises comprise an important part of the service industries in Tonga and 25 such enterprises were in operation in 1990. Training programmes, on automobile repair were organised, for the existing workers of small enterprises, to upgrade their knowledge. The project staff comprised core faculty.

Prior to the conduct of these programmes a seminar on automobile repair enterprises was organised in the year 1990, to find out problems and areas in which assistance could be provided.

#### Workshop on Rootcrop Processing.

The workshop was jointly organized by the FAO project RAS/86/034-Root Crop Development Systems with the Ministry of Agriculture and Forestry and the UNDP/UNIDO project DP/TON/86/002- Small Industries Promotion and Entreprenurial Development with the Ministry of Labour, Commerce and Industries. For demonstrations and training in practical root crop processing a consultant was contracted by FAO. The venue of the workshop was Vaini Research Farm of MAF.

#### SEMINARS

The following seminars were organized,.

- 1. Automobile repair enterprises.
- 2. Furniture and joinery industry seminar.
- 3. Industrial Promotion Seminar. (Three seminars)
- 4. Seminar on Bamboo Products.
- 5. Seminar on Export Oriented Manufacturing Enterprises.

Brief details are of the above seminars are as follows:

### <u>Automobile Repair Enterprises Semin</u>ar. <u>Tonga National Centr</u>e

The above seminar was organised in June 1990 The objective of the seminar was to ascertain and discuss common problems faced by them with a view to providing assistance. The seminar provided a platform to discuss their problems. The programme included screening a film film highlighting essential machinery and equipment. Literature was exhibited on tools and equipment for auto repair enterprises. Visit to leading workshops was arranged. Representatives of commercial and development banks were also invited to address the participants. Arising out of the deliberations of this seminar, training programmes including in-house training programmes were organised.

### <u>Furniture and Joinery Industry seminar</u> <u>15-16 February 1988. International Dateline Hotel. Tongatapu</u>

The seminar was conducted at the end of technical assistance provided by a specialised expert, Mr Brion, at shop floor level. Fifteen owner/managers of furniture factories attended the seminar.

#### industrial Promotion Seminars.

Three seminars were organised. Please see Annex-11 for contents.

### <u>Seminar on Export Oriented Manufacturing Industries</u> <u>Ministry of Labour, Commerce and Industries</u>

The above seminar was organised with the aim of bringing to the notice of manufacturer exporters, latest policies, incentives and procedures etc. in regard to exports from Tonga. In addition to the project and the Ministry staff, Customs department, representative of the Australian High Commission (AIDAB) and the representative of the Export Marketing Division of the CFTC addressed the Seminar. The Minister of Labour, Commerce and Industry inaugurated the Seminar. The exporters took this opportunity to express difficulties faced by them.



The above seminar was sponsored and funded by UNDP, Suva, Fiji. - to use the experience of Fiji, Mauritius, Tonga and other countries as case studies for the issues involved in creating an enabling environment.

The CTA of the project was invited to be a resource person. He also headed a panel. Heads of the departments dealing with private sector development (Permanent Secretaries of the Ministries of Trade and Industries, Directors of Trade and Investment Boards) and owners of private businesses of the countries of the South Pacific attended the seminar. Three senior officers from Tonga attended the seminar.

#### **ANNEXURE-8**

#### MANAGEMENT INFORMATION SYSTEM WITH USE OF PERSONAL COMPUTERS

From the inception of the IDI Act in 1978 till March 1993, about 700 Development Licences have been issued by the Ministry of Labour. Commerce and Industries, under the Industrial Development Incentives pertain to manufacturing enterprises, industrial Act. These workshops, tourism prime facilities, commercial farming for export and commercial fishing for exports. Many of these licencees have embarked upon expansion & diversification programmes and development licences have been issued for that purpose. All development licence holders are required to submit information on investment, production, employment etc. However, this information is not submitted by most of the approved industries. As per the latest amendment in the IDI Act, all export proceeds are required to be brought back to Tonga. There is no proper check on this. Many licensees are inoperative but their development licences have not been revoked. A beginning for the follow up of industries was made under the auspices of the project. However, information on industries approved needs to be properly collected, stored and analysed.

At present, data on these industries is collected by the Statistics Department which does not cover all industries. Licensed enterprises in outer islands are also not covered.

Under the aegis of the project, assistance was provided in developing information system to create data base for the development licences issued and in operation. An independent system developed for the industry division was integrated in the dBase IV. Training was also provided to the staff in the operation of the system and a Manual was developed.

# OVERSEAS INVESTMENT MISSION. NEW ZEALAND, NOVEMBER 1988

A Trade and Investment Mission comprising officials and private businessmen visited New Zealand from 7 - 14 November 1988. While the Bilateral Trade talks were held between the officials of the two countries, the private sector businessmen discussed possibilities of establishing joint venture industries in Tonga. The Trade talks included discussions on issues of bilateral trade, assistance under South Pacific Regional Technical Cooperation Agreement, Pacific Islands Industrial Development Scheme (PIIDS), and the effect on Tonga's trade with New Zealand as a result of Australia New Zealand Closer Economic Relation Agreement (ANZERTA) etc.

On the investment component of the visit, project discussed included: industrial clothing; carton making for export of fresh produce; T shirts; footwear; papain from pawpaw; ship repair services game fishing; yacht charter and hotel etc.

Baron Vaea, Hon. Minister for Labour, Commerce and Industries led the delegation. Other member of the Mission were:

Five Entrepreneurship Development Training Programmes were organised under the project, including a special programme for women.

The objective of the entrepreneurship development training programme is to develop the potentials of the participants to set up their own small industries.

These specially devised training programmes provided comprehensive information on various aspects of setting up a small enterprise and included the following:

Strengthening the motivation of the prospective entrepreneurs and bringing to their notice their strengths and weaknesses viz a viz business situation.

Information on assistances and incentives made available by the Government and banks for setting up small enterprises. Investment opportunities, preparation of business plan, assistance made available from bilateral, regional and international agencies. Procedures and requirements for setting up joint ventures. Preferential market access and export market assistance. Basic aspects of business management. Exchange of experiences with successful entrepreneurs. Interface with key contacts connected with industrial development. Tour of industrial estate (SIC) and selected industries.

The programmes were well received and many participants were highly motivated to set up their own enterprises. Arising out of the course, several new applications for setting up small industries were received.

The training programmes need follow up to assist the participants to set up their enterprises.

The CTA of the project was invited to assist in the conduct of similar programmes in other countries in the region - Kiribati in 1988 and Vanuatu in 1992.










