Explanatory notes

Unless otherwise indicated, "manufacturing" includes the industry groups listed under major division 3 in the International Standard Industrial Classification of All Economic Activities (United Nations publication, Sales No. E.68.XVII.8).

International Standard Industrial Classification of All Economic Activities (ISIC) code numbers are accompanied by a descriptive title (for example, ISIC 323: "Manufacture of leather and products of leather, leather substitutes and fur, except footwear and wearing apparel"). For considerations of space, however, the description is sometimes shortened (that is, ISIC 323 may be described simply as "Leather and fur products"). For the same reason, the descriptive titles of code numbers of the Standard International Trade Classification (United Nations publication, Sales No. E.61.XVII.6) and the names of countries and country groups are sometimes shortened.

References to dollars (\$) are to United States dollars. For production and wages data, national currencies have been converted to dollar equivalents by using exchange rates as published in International Financial Statistics (International Monetary Fund publication). The data on international trade have been presented in dollar terms by using the exchange rates published in Commodity Trade Statistics (United Nations publication).

Data converted to dollars by using current exchange rates are of course influenced by fluctuations in exchange rates. Variations of data converted in that manner may not reflect movements in the national currency data.

Periods set off by a hyphen (for instance, 1980-1989) include the beginning and end years.

Apparent arithmetical discrepancies, such as percentages that do not add up to totals, result from the rounding of basic data or figures known to different degrees of precision.

Three dots (...) indicate that data are not available or are not separately reported.

Two dots (...) indicate that data are not applicable.

A dash (-) indicates that an amount is nil or negligible.

The letter "x" designates the item applicable to a country when several options exist.

INTRODUCTION

The present publication "ASEAN Industry in Figures 1993" focuses on the member countries of the Association of South East Asian Nations (ASEAN). ASEAN includes the following countries: Brunei Darussalam, Indonesia, Malaysia, the Philippines, Singapore and Thailand. In this publication, however, Brunei Darussalam could not be taken into account due to the scarcity of data.

During the past two decades the member countries of the ASEAN achieved remarkable industrial growth and their economies underwent deep structural changes. The purpose of the present publication is to provide statistical indicators describing these processes. Data are presented in two sections: Part 1. International comparisons, where data are shown for the ASEAN countries as a group, for selected country groups and countries, and, Part 2. Country indicators which focuses on individual ASEAN countries and selected Asian developing countries in order to facilitate comparison.

While relying largely on readily available data - particularly data compiled by UNIDO and other Statistical Offices of the United Nations - the presentation of data in ASEAN Industry in Figures 1993 is original in three ways. First, the basic data have been accumulated from several sources and have been combined to form indicators such as ratios, growth rates and indices. Second, many of the indicators presented are derived from estimates made by UNIDO to supplement missing data. Third, trade data have been aggregated to make them comparable to production data, the aggregation is described under Sources and methods.

Sources and methods

The source of industrial statistics is the UNIDO database which is composed mainly of data communicated by official national sources. To facilitate the comparability of data over time and across countries, they have been supplemented from sources that include industrial censuses, statistics supplied by national and international organizations, as well as estimates by the UNIDO secretariat.¹

Manufacturing value added (MVA), when referring to the manufacturing sector as a whole, is estimated in accordance with the national accounting concept. It represents the net contribution of the manufacturing sector to gross domestic product (GDP). Value added, shown by manufacturing group, branch or industry (i.e. at the 2-digit, 3-digit or 4-digit level of ISIC) is derived from the UNIDO database on industrial statistics. The majority of countries included in the country groups, other than ASEAN, report value added in producers' prices. For the ASEAN countries value added is reported in producers' prices for the Philippines and Thailand while Indonesia, Malaysia and Singapore show value added at factor costs.

The source of the trade data used in this publication is the United Nations trade tapes. In order to be able to present trade data comparable to production data, trade data following the Standard International Trade Classification, Revised (SITC) are reclassified in accordance with the four-digit code of the International Standard Industrial Classification (ISIC), by employing a concordance developed by the Organization for Economic Co-operation and Development (OECD) and, where required, these data are aggregated into the three-digit code of ISIC.

Appendix I to the present introduction gives the groupings of countries as used in this publication. Those developing countries that have recorded extraordinarily high rates of growth for manufactured exports over the 1970s² are in this publication referred to as dynamic exporters of manufactures (DEM). The ASEAN countries belong to this group, however, to facilitate intra-group comparisons, data are shown separately in part one of this publication for the ASEAN countries as a group and the non-ASEAN DEM. Due to insufficient data, China could not be included in any country grouping or world totals.

Appendix II to this introduction lists the SITC items that correspond to ISIC manufactured goods and classifies them by final use, as well as by research-and-development-intensity (R & D intensity).

Trade figures are presented in this publication in current dollars, national accounts data are shown in constant 1980 dollars. The industrial statistics are presented partly in current and partly in constant dollars.

Average annual growth rates are calculated as compound growth rates from the first and last years of a period. All growth rates are expressed in percentages.

Trade data not reported by a country are estimated from data reported by trading partners. Due to incomplete reporting from trading partners this is likely to bring about an underestimation, particularly in recent years.

The tables and figures

Part One. International Comparisons.

Table 1.1 shows the distribution of GDP by sector of origin for the ASEAN countries as a group and selected countries and country groups. GDP in this instance is calculated as the sum of the sectoral components.

Table 1.2 shows the average annual growth rates of the total GDP as well as its components for the ASEAN countries as a group and selected countries and country groups.

Table 1.3 shows GDP per capita and MVA per capita and the average annual growth rates of the per capita data for the ASEAN countries as a group and selected countries and country groups.

Table 1.4 presents the share of industries grouped by end-use and factor-intensity in total MVA for the ASEAN countries as a group as well as for selected countries and country groups.

Table 1.5 shows the percentage distribution of MVA among the 28 manufacturing branches (i.e. the 28 major groups within division 3 of ISIC), for the ASEAN countries as a group and for selected countries and country groups.

Table 1.6 shows the annual average growth rates of value added for the 28 manufacturing branches for the ASEAN countries as a group as well as for selected countries and country groups.

Table 1.7 gives a comparison of shares in world MVA and world manufactured exports of the ASEAN countries as a group and selected countries and country groups. It must be noted that here MVA is based on constant prices while exports are in current prices.

Table 1.8 presents ratios of commodity exports and imports (SITC 0-9) to GDP as well as manufactured exports and imports (SITC 5 to 8, less 68) to total trade for ASEAN countries as a group and selected countries and country groups.

Table 1.9 shows per capita trade in goods and services and its growth for the ASEAN countries as a group and for selected countries and country groups.

Table 1.10 presents the flow of manufactured exports (SITC 5 to 8, less 68) from and to the ASEAN countries as a group as well as from and to selected countries and country groups.

Data shown in tables 1.1 to 1.6 and 1.9 are at constant 1980 prices.

Part Two. Country indicators

Table 2.1 shows the distribution of GDP by sector of origin for the individual ASEAN countries, where GDP is calculated as the sum of its components.

Table 2.2 shows the annual average growth rates of total GDP and its components for individual ASEAN countries as well as for selected Asian developing countries.

Table 2.3 presents per capita data for both GDP and MVA and their growth for individual ASEAN countries and selected Asian developing countries.

Table 2.4 shows the industry groups' share in total MVA for individual ASEAN countries as well as selected Asian developing countries.

Table 2.5 gives the structure of MVA, i.e. the percentage distribution of the 28 branches of manufacturing in total MVA (ISIC 300) for individual ASEAN countries.

Figure 1 is based on table 2.5 and shows the change over time in the shares of manufacturing groups at the 2-digit level of ISIC in total manufacturing (ISIC 300).

Table 2.6 shows the average annual growth rates of the 28 manufacturing branches for individual ASEAN countries. Growth rates for the Philippines were not shown for the later period, because of inconsistencies in data reporting as stated below.

It should be noted that some indicators for the Philippines, i.e. distribution of value added among the manufacturing branches (table 2.5) and the indices of relative specialization (table 2.8) as well as manufacturing employment by branch (table 2.10) for the period after 1980, although shown, are not comparable to the earlier period. Up to 1983 the Philippines included data on establishments with one or more persons engaged, as of 1983 only those with more than 10 persons engaged and as of 1987 data for establishments with average monthly sales or receipts of not less than 1 million pesos are included.

Table 2.7 shows the shares of the ASEAN countries and selected developing countries from South and East Asia in the total MVA for the developing countries of this region.

Table 2.8 shows the relative specialization in manufacturing for the ASEAN countries using the formula:

$$[(VA_i/VA_{j,00})_j]/[(VA_i)/(VA_{j,00})_w]$$

where VA_i = value added in branch i , $VA_{j,00}$ = value added in total manufacturing and subscripts j and w denote country j and world respectively. A figure close to 1.00 means that the branch's importance in a country's manufacturing structure is similar to that of the world aggregate. The higher the figure, the greater the specialization in this branch relative to the world average.

Table 2.9 lists the share of manufacturing in GDP and GDP per capita to show the structural transformation during the period 1965 to 1990 for the ASEAN and selected Asian developing countries. Although for the ASEAN countries these figures are given in tables 2.1 and 2.3, they are repeated here and supplemented with data for additional years in order to facilitate a comparison with the selected Asian developing countries.

Figure 2 which is based on the data presented in table 2.9 shows the patterns of structural transformation with 1965 and 1990 as end points. The data are presented in semi-log form.

Table 2.10 shows the percentage distribution of manufacturing employment among the 28 manufacturing branches and the annual growth rates for ASEAN countries. Growth rates for the Philippines for the period after 1980 are shown, however, the data are not comparable to the earlier period, due to changes in data coverage. Data for Thailand could not be obtained.

Table 2.11 gives the ratios of commodity exports and imports (SITC 0-9) to GDP and manufactured exports and imports (SITC 5 to 8, less 68) to total commodity exports and imports for the individual ASEAN countries.

Table 2.12 shows imports and exports of goods and services per capita at constant 1980 prices and the per capita growth rates. These data are presented for the individual ASEAN countries and selected Asian developing countries. In this instance, national accounts data are shown.

Table 2.13 presents the export trade flow of manufactured exports (SITC 5 to 8, less 68) by origin and destination for the ASEAN as well as selected Asian countries as a percentage of total manufactured export in Asia.

Table 2.14 shows the annual growth rates for exports and imports by manufacturing branch as well as the percentage distribution of exports and imports among the 28 manufacturing branches for the ASEAN countries.

Table 2.15 shows net exports (exports less imports) as a percentage of total trade for the 28 manufacturing branches for the ASEAN countries, where the percentages were calculated as:

$$(X_{ij} - M_{ij}) / (X_{ij} + M_{ij}) * 100$$

where X_{ij} = exports in branch i by country j, and
 M_{ij} = imports in branch i by country j

Table 2.16 presents for the ASEAN countries the ratio of the share of branch i in total export for country j over the share of branch i in total export for the world as an indicator of revealed comparative advantage, using the formula:

$$[(X_i/X_m)]_j / [(X_i/X_w)_w]$$

where X = exports and subscripts i, m, j and w denote respectively branch i, total manufacturing, country j and world, where world excludes China.

Table 2.17 shows selected indicators of trade in manufactures by end-use and R & D intensity for the ASEAN countries. A classification by end-use and R & D intensity is given in Appendix II.

Table 2.18 shows data for the ASEAN countries by industry at the four-digit level of ISIC, such as wages and salaries per employee, value added per employee, value added by establishment, value added as a percentage of gross output and wages and salaries as a percentage of value added. The data are presented in current dollars. The number of employees refer in the case of Malaysia to those employed at the end of December of the given year, in the case of Singapore to those employed at 30 June of the reference year, no details on the reference period are given for the other countries. The number of establishments included in the reported data refer in the case of Indonesia to those employing 20 or more workers, for Malaysia to all establishments registered under the Industrial Co-ordination Act of 1975. For the Philippines and Singapore the coverage is establishments with 10 or more workers. Since Thailand does not report production data at the four-digit level, Thailand could not be included in table 2.18.

Table 2.19 shows selected indicators of demand-supply relationships concerning the 81 manufacturing industries at the four-digit level of ISIC for the ASEAN countries. The percentage of output in apparent consumption e.g. is presented as an indicator of self-sufficiency and trade-dependence is shown by the percentage of imports in apparent consumption. Output refers to census output. Apparent consumption is defined as output plus imports less exports. Net exports are exports less imports. Total supply is the sum of output and imports. Since Thailand does not report production data at the four-digit level, Thailand could not be included in this table.

Table 2.20 shows the value indices (1985=100), based on current dollars, of production, imports and exports for selected manufacturing industries defined at the four-digit level of ISIC for the ASEAN countries. The selection criteria for these industries were a high growth in current values of either production, imports or exports for at least one of the ASEAN countries. Indices were chosen to show the magnitude of growth or decline for the individual ASEAN countries. Since Thailand does not report production data at the four-digit level, Thailand could not be included in this table.


Figure 3 Development of production, imports and exports,

Figure 3 presents in graph form the development of production, imports and exports in current values on the same scale per industry for selected ASEAN countries.

Table 2.21 shows the main manufactured exports of the ASEAN countries, based on value, at the four-digit level of ISIC for 1991 and a comparison to earlier years.

Table 2.22 shows the main manufactured imports of the ASEAN countries, based on value, at the four-digit level of ISIC for 1991 and a comparison to earlier years.

Table 2.23 shows the sectoral shares and geographical distribution of direct foreign investment for the ASEAN countries. For Malaysia and Singapore these data are only available for the manufacturing sector while for Indonesia, the Philippines and Thailand all sectors are covered. The indicators presented here are based on data supplied by national sources. Definitions of direct foreign investment show variations from country to country and are, therefore, given in footnotes on the tables in question.









1965, 1990, at constant 1980 prices







**Development of production, imports and exports,


**Development of production, imports and exports,
ASEAN countries, selected product groups 1985-1991**





ASEAN countries, selected product groups 1985-1991**




