Environmental Issues and Restructuring

This session will discuss the main environmental concerns in the Danube countries, focusing on the Danube Programme's 'hot spot' approach and the need for prioritization. It also aims to briefly present key concerns and issues by country and medium. The second part of the session will focus on the impact of industrial restructuring on the environment, and on the linkage of industrial restructuring/privatization, competitiveness and the environment.

Session 3

Regulatory Trends, Tools and Implications

This section will discuss the principles and main trade-offs of environmental policy. It will also set out regulatory trends (particularly in the context of harmonization with EU standards and laws), and the main policy instruments for environmental management. It will finally discuss the economic and financial implications of such management measures.

Industry Sector Response

The purpose of the session is to discuss the key elements of an industry sector strategy in general, and with regard to sustainability needs and requirements.
