



# ADVANCE INFORMATION FOR PARTICIPANTS

### Travel to Brazil

- 1. The Brazilian airline, VARIG, has kindly arranged that for participants arriving in Sao Paulo on VARIG flights, transport from the airport to the notel in downtown Sao Paulo (a journey of about 45 minutes) will be at the expense of VARIG. There will be a VARIG Reception Office for this purpose at the airport in Sao Paulo.
- 2. Participants are advised to obtain a visa, if required, and check vaccination requirements well in advance.

#### Duration of the Meeting extended

3. The Third Consultation on the Fertilizer Industry will open on Monday 29 September 1980 at 9.30 a.m. and will close on Saturday 4 October, not 3 October as indicated in the Aide-Mémoire.

# Plant visits

4. There will be no sessions on Friday, 3 October, when participants will be free to make visits to fertilizer plants arranged by the Brazilian hosts.

# Place

5. The Third Consultation will be convened in Sao Paulo at the Hilton Hotel, address: Avenida Ipiranga 165, Sao Paulo, Brazil; telephone 256 0033; telex: 01121981.

#### Reservation of Hotel Rooms

6. Participants should make their hotel reservations up to 4 October 1980 by completing and mailing the form attached to this note as soon as possible and in any case before 15 August 1980.

# Registration and Sessions

7. Registration will start on Sunday 28 September from 4 p.m. to 6 p.m. and will continue on Monday 29 September from 8.30 to 9.30 a.m. The session will be held from 9.30 to 12.30 and from 14.30 to 17.30.

### Documents

8. Participants are required to bring their own copies of documents to the meeting. A List of Documents is provided in document ID/WG.318/9. All documents have been mailed to participants in advance. There will only be a very limited supply of documents available in Sao Paulo.

# Local Currency

9. The local currency is the Cruzeiro. The exchange rate as of 4 July was about 52 Cruzeiros per U.S.\$. To purchase Cruzeiros in Brazil, it is advisable to have travellers' cheques or an easily convertible currency.

# Weather

10. The temperature in Sao Paulo in September/October ranges between 20°C and 30°C during the day and between 15°C and 20°C at night. Rain is unlikely but possible.
