The subcontractor has completed following work according to the terms of reference (ToR) of the UNIDO contract No.95/196P:

- The contractor prior to start of the interior work white-washed the office premises; located on the first floor in TNPCB building. 100 Anna Salai, Guindy, Madras 600 032.
- Thereafter, the subcontractor provided and erected aluminium-glass partition walls for one
 full-size cabin with door and two half-size partition walls as well as one aluminium-glass door
 with frame as shown in the attached drawing.
- 3. The subcontractor supplied and fixed following furniture in the said office premises:
- One reception table made of 18 mm commercial plywood with laminated top (size: 122 x 61 x 61 x 76 cm)
- One executive table with side rack unit made of 18mm commercial plywood with laminated top (size 122 x 90 x 75 x 75 x 75 cm)
- · One executive revolving chair with casters and cushions
- One workstation with four individual tables, side tables and drawerboxes and softboards (size 122 x 75 x 75cm; side unit: 61 x 40 x 75 cm) made of commercial plywood and laminated surface.
- Eight staff revolving chairs with casters and cushions
- Seven visitor chairs, made of wood, with cushions
- Eight planter boxes, made of 18mm commercial plywood and laminated surfaces
- One sofa set, consisting of one three-seater unit, two single seater units, made of hardwood with cushions and fully upholstered and one tea poy
- Two filing cabinets made of 18mm commercial plywood and laminated front, inner surface wax polished and varnished with brass hardware and individual locks.
- One pantry table made of commercial plywood with laminated top, witg drawers and one cupboard
- One printer table made of 18mm commercial plywood and laminated top with two drawers and stationary shelves (size 152 x 75 x 75 cm)
- · Vertical blinds for all windows.
- One aluminium-glass door with door frame
- Two staff tables with two Lide racks and drawerboxes(size 122 x 75 x 75 cm; side units: 61 x 40 x 75 cm)
