Abstract:

In accordance with the terms and conditions stated in the contract, the Beijing Si Wei Da (Sun World) Science and Technology Company, China has fulfilled its obligations and responsibilities under the contract before the end of June, 1997. The NT-environment for IPS-Beijing has been established, the relevant training was accomplished which met the requirement of the client.

It is witnessed by the client that the contractor has met every possible requirement of the service indicated in the Terms of Reference which is the Annex B of the Contract.

The service was provided from June 10 to June 30, 1997. At the time, we had not yet signed formal contract delivered to us through UNIDO IPS-Beijing and sent it back to the UNDIO HQ. It was due to the internal Chinese payment system through banks here. In normal cases, the Chinese companies register their Chinese name of company with their opening banks. We were afraid that if the payment from the UNIDO HQ was issued in our English name, our opening bank may reject the payment. That's why we had to consult with our opening bank before we sent back the invoice together with the signed contract. It wook quite some time for the bank to ensure us the payment if the check to be issued in our banks name. However, because of the trust to UN organizations, we fulfilled our obligation according to the contract anyway even before the payment.

According to the terms of reference, the following work has been done under the contract mainly by our two engineers namely Mr. Yuan Ming and Ms. Gao Weihong:

- Hardware provided under the contract:
- (1) 100 meter Network cable for the connection of the computers;
- (2) 3 network adapters (3COM 3c509-TPO;
- (3) one Hub D-Link;
- (4) one PageSaver Plus.
- Software/Project Engineering Service provided under the contract:
- Windows NT Server has been installed:
- (2) Network Client Configuration has been adjusted;
- (3) All computers within the Office have been connected with network cable;



- (4) MS Internet Info. Server has been setup;
- (5) Scan&kill Virus KV300 has been installed.
- (6) The original technical problems have been fixed before our software installation.
- 3 Training part has been done according to the contract. The staff of the office namely. Ms. Feng Xiaohong, Ms. Cheng Yuling, Ms. Weipingde and some trainees from IPS-China's focal points at the provincial/city level have been received the training on the following items.
- 1) Training on network administration essential for 8 hours in the office;
- Training for network application of Windows95 for 4 hours in the office;
- (3) Training for the application of Office 95 for 4 hours in the office.

After the work was accomplished under the contract, the NT-environment has been built in IPS-China
