In according to the terms and conditions stated in the contract numbered 97/123's Annex B under the project US/CPR/95/121, the UNIDO Software Application Workshop was held successfully by Beijing Chance City Information Company with assistance of UNIDO IPS-China in Zhongxie Hotel, Beijing from 7-9 July 1997. The participants included representatives from our two centres namely Investment Service Network Centre and Investment Project Evaluation Centre and from 12 focal points/stations at local level, representatives from the Foreign Investment Management Department of MOFTEC, and from some Beijing investment consulting institutions/companies (please see the list of the participants attached herewith as Annex A). The workshop has several purposes which were mainly to familiarize all UNIDO IPS-China's focal points/stations at provincial/city level with the UNIDO investment mechanism, to answer common questions arising in filling up IIPP forms, to exchange experience in investment promotion at the local level and to have fact-finding meetings on the possible improvement of IIPP forms and our way of distributing forms as well as evaluating the forms.

On the first day, Mr. Hu Yuandong who is the Head of IPS-China gave a summary report on last year's investment promotion activities and the development of China investment network service. He also outlined on UNIDO investment promotion system and WINS. After that, the participants paid a visit to Investment Service Network Centre of UNIDO IPS-China which is located in Zhongxie Hotel. From the visit and the demonstration shown to them by our technicians, the participants all had a clearer idea on how they can communicate with UNIDO IPS-China through the China Investment Service Network on Internet and how to deal with some technical problems arising from electronic communication. In the afternoon, Ms. Feng Xiaohong, the project officer of UNIDO IPS-China in charge of project evaluation and training explained in-depth at the workshop on how to fill up UNIDO IIPP forms and Ms. Zhou Nan, the technician from Investment Service Network Centre demonstrated various E-Mail software and answered questions arising in sending IIPP through E-Mail attachments.

On the second day, Mr. Wang Chaogang, who is IPS-China's national consultant, and the Division Chief of Feasibility Study Division in Ministry of Construction, gave a detailed training on evaluating IIPP with PROSPIN and making project feasibility study with COMFAR III. A mini COMFAR was also shown during the workshop. Case studies

with computer-projector demonstration was conducted. The participants were of the view that the UNIDIO software is the best software they had ever used in investment project evaluation and investment promotion. And the software should be used by the focal points/stations of IPS-China in the investment promotion at the local level.

In the morning of the third day of the workshop, a field visit was arranged to Asia-Pacific Network Service which is among the best network services in China. The purpose is to expand participants' field of vision on the advanced network technology and renewed idea on information exchange. In the afternoon, a free discussion and face-to-face consulting was conducted among the participants on investment promotion activities, the experience, the existing problems, the electronic linkage issue with IPS-China and the expectation on IP from UNIDO IPS system. At the end of the workshop, Mr. Hu Yuandong made a summary on the discussions and the demonstration.
