

**11. Functions of the Agency:**

The Office of Foreign Investment (Gabinete de Investimento Estrangeiro-GIE), working under the authority of the Ministry of Economy and Finance, is responsible for:

- guaranteeing foreign investment policy;
- promoting, coordinating, orienting and supervising undertakings in this area.

**12. Procedures for the establishment of investment projects:**

- Proposals for foreign investment should be submitted to the GIE using the appropriate forms and be accompanied by documentation identifying the applicant and, when applicable, documentation identifying the Angolan investor (authenticated copies of identifying documents and proof of residence for individuals or proof of legal standing for corporations). If the proposal is not endorsed by the applicant, the endorser should have a mandate from the applicant recognized by the GIE.
- When the project involves incorporation of a company, a draft of the articles and memorandum of association, a certificate of the name of the company and a draft association agreement or agreements should be submitted.
- In cases dealing with acquiring shares in the capital of already existing companies, authenticated copies of the articles and memorandum of association of the company in question, the incorporation charter and a declaration of the governing bodies approving the acquisition should be presented. Authenticated copies of company balance sheet and

accounts for the prior fiscal year, recognized by the Ministry of Finance should also be submitted.

During the process, the Office of Foreign Investment will lend assistance of an economic, financial, legal and technical nature. Besides official support in carrying out the formalities required for the project, the investor can also apply for domestic credit, under existing legislation. Access to foreign credit will be granted following clearance and authorization from the Ministry of Finance and the Central Bank.

In order to receive the status of foreign investment and enjoy the protection appertaining thereto, only those projects with a volume of investment greater than 250,000 US dollars will be considered as foreign investment. Projects involving a lesser amount will be subject to commercial and foreign exchange legislation in force.

The applications procedure to be followed for each foreign investment project depends on the amount invested and is as follows:

APPLICATION PROCEDURE	AMOUNT INVESTED (US \$)	DESCRIPTION
<b>Prior Declaration</b>	250,000 to 5,000,000	Following ruling by the body responsible for the area of investment in question, the GIE will issue a declaration acknowledging acceptance. The declaration will entitle the applicant to invest under the exact terms stated in the proposal submitted. If the responsible body does not issue an opinion within 45 days, the project is considered approved.
<b>Prior Approval</b>	5,000,000 to 50,000,000	Following scrutiny by the GIE and subsequent valuation by the Appraisal Committee (an advisory body), proposals under 15 million dollars, are forwarded to the Prime Minister for a decision. Proposals exceeding this amount are sent to the Council of Ministers. Proposals must be forwarded for approval no later than 90 days after being submitted.
<b>Contractual</b>	> 50,000,000	The GIE has 10 days to rule on the admissibility of the proposal. If admissibility is granted, based on the ruling of the Appraisal Committee, the GIE has 30 days to approve the proposal and forward it to the Minister of Planning and Economic Coordination who will appoint a negotiating committee. Final approval of the project is given by the Council of Ministers.





Toute personne physique ou morale de nationalité Camerounaise ou étrangère peut solliciter un agrément à l'un des régimes suivants prévus par le code des investissements:


- le régime des Petites et Moyennes Entreprises (PME)
- le régime de Base
- le régime des Entreprises Stratégiques
- le régime de la Zone Franche

La procédure au bénéfice du régime des **PME** et du régime de **Base** il suffit de déposer l'étude de faisabilité en cinq copie auprès de la CGCI qui dispose d'un délai de 30 jours pour se prononcer sur la recevabilité de ce dossier. Au cas où le projet est jugé recevable conformément aux dispositions du Code des investissements l'acte d'agrément est signé par le Ministre Chargé de l'Industrie et notifié au promoteur.

L'agrément au régime des **Entreprises Stratégiques** prévoit la tenue d'un Comité de Direction de la CGCD qui est seul habilité selon la loi à se prononcer sur ces cas dans les mêmes délais de 30 jours. En cas de silence de la CGCI à l'issue des 30 jours, le projet est jugé recevable d'office et l'acte d'agrément signé en conséquence.

Le régime de la **Zone Franche** est administré par l'Office National des Zones Franches Industrielles. A l'exception des activités rentrant dans le cadre de la recherche ou de l'exploration des ressources minières y compris les hydrocarbures, des activités de prestation de services dans le domaine financier, de formation scolaire, d'entretenir et de réparation de toute nature, de pressing et des bureaux d'études qui sont exclus du champ d'application du code des investissements, toutes les autres activités industrielles peuvent être éligibles dans le cadre dudit code.

## **11. Functions of the Agency:**

PROMEX is one-stop shop for foreign investors, established in August 1990 by the Government as the principal promoter for and adviser to foreign investors and exporters.


Notably it will:

- Provide general information on the economy, investment climate, incentives and guarantees
- Advise on the legal and administrative procedures for investing in Cape Verde
- Analyze proposals to invest in Cape Verde
- Expedite the processing of applications and permits for starting up approved investments
- Manage the Integrated Tourism Development Zones (ITDZ) and Industrial Parks
- Negotiate the concession of the land parcel with relevant authorities
- Negotiate on the investor's behalf to obtain Tourist Utility status.

## **12. Procedures for the establishment of investment projects:**

- *Submitting the Application:* applications forms for external investment should be completed and addressed to the Minister of Economic Coordination. Three copies have to be send to PROMEX
- *Awaiting the response:* PROMEX organizes the investor's file and sends it to the External Investment and Free-Zone Enterprise Evaluation Commission (CIEF) for appraisal. The Minister makes the final decision which is sent to the investor within 30 days from the date the application is submitted to PROMEX. If the investor does not receive a response (acceptance or rejection) within this period, the application is considered approved.
- *Receiving Investment Authorization:* the Office of the Ministry of Economic Coordination issues a Certificate of External Investment, which PROMEX sends to the investor or his legal representative. Copies of the certificate are also sent to the Bank of Cape Verde and to the government entity responsible for the sector. The certificate gives the investor access to the incentives established under the Investment Code (Decree-Law No. 89/IV/93).
- *Registering the Project with the Central Bank:* all external investments must be registered in person or by registered airmail at the Bank of Cape Verde. Three copies of the registration form must be submitted within 30 days from the start of operation (see Annex 4, Decree-Law No. 1/94 for a copy of the form).
- *Submitting to Site Inspection:* the start-up or reopening of businesses is subject to inspection by the responsible authorities 30 days from the date of the investment application.

- To receive and screen investment requests and issue investment permits; to decide on application for incentives; to monitor the implementation of the investments for which investment permits are issued; to register capital imported into and invested in Ethiopia by foreign investors.
- To receive, approve and register technology transfer agreements related to investments.
- To collect, compile, analyze and disseminate information on resource potential of the country and on the investment opportunities it offers; to promote concrete investment projects and match making service of possible joint investment partners.
- To give advice and technical support to regional investment bureaus with a view to building their capacity.
- To prepare and distribute pamphlets, brochures, films and other materials to help enhancement of investment activities; to organize investment promotional activities such as exhibition, conferences, training seminars, etc.
- Issuing trade and operating licenses, granting work permits to expatriate employees, registration of business organizations with respect to investors holding investment permits.

- To initiate and submit to the Federal Investment Board policy and implementation measures needed to create a conducive investment climate.
- To negotiate bilateral investment promotion and protection treaties for conclusion between Ethiopia and capital exporting countries and to sign same upon approval by the Council of Ministers.

## **12. Procedures for the establishment of investment projects:**

- An application for investment permit should be made in a form designed for such purpose and submitted to the Ethiopian Investment Authority together with:
  - ◆ the project profile;
  - ◆ a list of the type of machinery and equipment intended to be exempted from import duties and taxes;
  - ◆ memorandum and articles of association in the case of business organization;
  - ◆ a brief description of the existing enterprise in the case of expansion or upgrading;
  - ◆ in the case of planned employment of expatriates, the training program designed to upgrade the skill of the Ethiopian staff and a statement on the time schedule for their replacement by Ethiopians;
  - ◆ power of attorney in the case of application made through a representative;
  - ◆ other relevant information related to the particulars of the project.
- After reviewing and evaluating the completed application form and the submitted documents, the Ethiopian Investment Authority issues investment permits within 10 days.
- Investment permits need to be renewed annually until the commencement of production or service.





- Under the Ghana Investment Promotion Centre Act 1994, investment projects in all sectors other than mining and petroleum have to be approved by the *GIPC*. Mining and petroleum projects have to be approved by the *Minerals Commission and the Ghana National Petroleum Corporation*, respectively. All investors intending to invest in Ghana should register as business entities with the Registrar General's Department under the relevant laws.
- *Enterprise with foreign participation* i.e. joint ventures and wholly foreign-owned enterprises, must complete application forms from GIPC for the purpose of registering the actual minimum foreign capital requirement and customs entry forms for investment goods.
- *Wholly Ghanaian enterprises* do not need to register with GIPC since the minimum foreign capital requirement does not apply to such enterprises.
- Enterprises seeking exemption from import duties and related charges should send invoices for clearance directly to *Costums, Excise and Preventive Services (CEPS)*.

- Approval for projects is based on viability verified by feasibility study,

In this respect the LNDC funding can only go up to 60% of the required initial investment, while 40% has to be provided by the investor. These projects are approved by the LNDC board after appraisal by LNDC management.
- projects requiring factories for rent get approval by LNDC management based on verifiable viability.



## **11. Functions of the Agency:**

The Malawi Investment Promotion Agency was established from the Act of Parliament of 1991 with a principle mandate to promote, attract, encourage, support and facilitate local and foreign investment in Malawi. In order to fulfill its mandate the Agency has the following functions:

- facilitate all aspects of the investment process in Malawi including, but not limited to, the timely receipt of Government approvals, permits, licenses, registrations and the fulfillment of any other regulatory authorizations;
- provide courtesy services to investors;
- provide information relating to investment in Malawi;
- identify partners in or outside Malawi for joint venture business opportunities in Malawi;
- liaise and generally interact with local and international financial institutions for the benefit of investors;
- encourage expansions and new investments by existing investors in Malawi;
- develop a favorable investment image of Malawi regionally and outside the region;
- undertake investment promotion missions within the region and outside the region;

- recommend to the Government changes in the statutory and administrative framework relevant to the investment climate of Malawi and make representations against or regarding any changes to any such statutory or administrative framework; and
- consult with private sector entities with a view to enabling the Agency to make recommendations to the Government for the improvement of the investment climate of Malawi.

## **12. Procedures for the establishment of investment projects:**


Malawi adopted a very simple process for the establishment of investment projects. Investors need to registered their companies with the Registrar General Department and incorporation takes less than 15 days. Foreign investors need to register their capital inflows with the Reserve Bank for data collection purposes.

Manufacturing activities do not require an industrial license except for a few industries whose operations pose health, environmental, and safety concerns such as the manufacture of firearms, ammunition, chemical and biological weapons, explosives, those involving hazardous waste and radioactive materials.

Trading activities do, however, require licenses. The Ministry of Commerce and Industry is responsible for the issuance of the trading licenses.

The Malawi Investment Promotion Agency which was established under the Investment Promotion Act of 1991 plays a key role in facilitating the investment process for all investors and acting as a one stop agency to provide all information to prospective investors.





## 11. Functions of the Agency:

The Mauritius Export Development and Investment Authority is the focal point for investment and export promotion activities in Mauritius. MEDIA provides dedicated support to both potential investors and existing industrialists. The services provided by the Authority include:

- Assistance in the identification of investment opportunities
- Organization of visits and meetings with economic operators on the island
- Identification of joint venture partners
- Assistance in site location and factory buildings
- Assistance in obtaining the various clearances prior to start-up
- Identification of markets for Mauritius products
- Participation in international trade fairs
- Organization of the Mauritius International Apparel & Textile Exhibition
- Provision of market intelligence through the Trade Information Centre.

MEDIA operates several overseas offices to provide assistance to foreign investors and promote exports from Mauritius. The London, Paris, Dusseldorf, and Washington offices are involved in both investment and export promotion and provide personalized services to companies wishing to find market outlets for products manufactured in the EPZ.

The Delhi and Mumbai offices, on the other hand, promote Mauritius in India as a base for offshore manufacturing.

MEDIA also operates seven offices in Southern and Eastern Africa, namely, Kenya, Malawi, South Africa, Tanzania, Uganda, Zimbabwe and Zambia. These offices provide active support to local manufacturers looking for export outlets in Africa.

## **12. Procedures for the establishment of investment projects:**

A project write-up should be submitted on the prescribed form at the Ministry of Industry. All projects proposals are dealt with expeditiously and are normally approved within four weeks from submission date.


All necessary licenses, clearance and permits can be obtained through the One-Stop-Shop at the Ministry of Industry. The One-Stop-Shop acts as a facilitator, but MEDIA also helps actively in obtaining all clearances besides providing an after sales service also.

Normally, promoters entrust the incorporation of their companies to consultancy organizations (e.g. firms of Chartered Accountants). The latter complete all required formalities against payment of a relatively nominal fee.

MEDIA also help industrialists to establish their projects.

## **12. Procedures for the establishment of investment projects:**


Investment proposals should be presented to CPI in three copies, on the appropriate application form, for approval. After the appropriate verification and necessary inter-ministerial coordination (within 7 working days), the component decision-maker for the approval of investment proposals will be the:

- Governor of the relevant organization for investment up to the equivalent of US\$100,000.
- above the equivalent of US\$100 million
- involving areas of land exceeding 5,000 ha for agriculture and 10,000 ha for livestock and/or forestry activities,
- any project with serious foreseeable implications of a political, social, economic and financial order, or of any other nature:

### Tacit authorization:

Once the fixed deadlines for inter-ministerial coordination (within 7 working days) and for decision (within 3 or 10 working days) have elapsed without a decision having been taken on the submitted proposal, the CPI will confirm the tacit authorization of the investment project so granted by the relevant authority, being null and void any other subsequent position or decision which may be taken after the confirmation of the tacit authorization already confirmed.

### *A. Investment Promotion and Facilitation*

The Uganda Investment Authority (UIA) is the statutory body responsible for investment promotion and facilitation. It is a business-oriented organization, equipped to handle an investor's requirement swiftly.

UIA provides personalized services to investors who seek information, action and advice on project development, implementation or expansion. There is no fee for its services, which include the following:

- Providing first-hand information on investment opportunities
- Helping to implement project ideas
- Providing "after-care" support services
- Issuing investment licenses and certificates of incentives
- Helping to acquire secondary licenses and approvals
- Securing work permits and special passes for investors
- Assisting in the preparation and presentation of a project for submission to the approval process
- Arranging contacts for an investor and organization itineraries for exploratory visits
- Providing advice on the acquisition of industrial land and the employment local staff

- Ensuring protection for intellectual property and trade secrets when technology transfer is involved.

*B. Policy Advocacy*

The UIA reviews and makes policy recommendations to government about investment.

**12. Procedures for the establishment of investment projects:**

*A. Incorporate a legal entity in Uganda*

- A foreign investor is a person who is not a citizen of Uganda or a foreign body holding shares of any business entity registered in Uganda.
- Business registration documents


*B. Apply for an Investment License*

- Minimum threshold, foreign investors US\$ 100,000 in qualifying assets in the first year of the investment programme
- Procure a UIA Form. This form should be filled and a business plan completed and attached. This is a look ahead for three years for your planned investment programme including:
  - information about promoters background;
  - information on environmental considerations where applicable
- Indicate secondary incentives required and utilities.

*C. Submit to UIA*

- A fully completed application which is acceptable will take 2 weeks to process.





**11. Functions of the Agency:**

- Promote, coordinate Government policies on, and facilitate, investment in Zambia, so as to provide a one-stop support facility to investors.
- Promote investment in Zambia
- Monitor performance of enterprises approved by it and enforce compliance with the terms and conditions of investment certificates approved
- Establish and maintain institutional liaison arrangements with all relevant organizations
- Assist investors in securing from any Government Ministry/Department, local authority or other relevant body any permission, exemption, authorization, license, land and any other requirements for the purpose of establishing or operating a business enterprise
- Keep records of all technology transfer agreements relating to investments.
- Provide consultancy services to investors
- Collect and disseminate information on relevant laws and regulations and technical matters, including applicable standards, specifications and quality control procedures
- Undertake economic and sector studies, including market surveys, with a view to identifying investment opportunities
- Register investors
- Implement decisions made by the Board of Directors.

## **12. Procedures for the establishment of investment projects:**

An investor wishing to invest in Zambia would firstly be required to register with the Registrar of Companies and comply with the Companies Act No.24 of 1995. The Office of the Registrar of Companies is housed in the Ministry of Commerce, Trade and Industry.


The Company Act allows foreign companies to register with the Registrar of Companies as a foreign company within 28 days of setting up or acquiring an established place of business in Zambia. The established place of business of a subsidiary company incorporated in Zambia is not recognized as an established place of business of the foreign company.

Applications for an Investment Certificate are made to the Investment Center and should be accompanied by the following documents:

- Certificate of Incorporation in Zambia;
- Relevant permit license for the particular industry.

## 11. Functions of the Agency:

- analyse investment policies and formulate recommendations for policy rationalization and reform
- interact on investment policy and planning issues with private sector and relevant Government organizations
- maintain a database of investment opportunities including local investors interested in possible joint ventures
- formulate strategies for international cooperation and coordination of outside technical assistance
- identify sectors of the economy with potential for direct investment

## 12. Procedures for the establishment of investment projects:

- Incorporate a company in Zimbabwe through Registrar of Companies directly or through consultancy companies
- apply to ZIC for registration if project is manufacturing , mining and infrastructural provision in tourism, i.e. hotel and lodges construction
- approval process is 48 hours for project approval in services and commercial projects where joint ventures are encouraged to at most 35% foreign shareholding
- approval normally granted within 10 working days
