The Contractor found a lot of difficulties during the investigation of identifying companies and many efforts were made to persuade them for participating at the Stonetechmart.

Some of these companies were not able to participate at the Stonetechmart because of the limit of the time they had to decide while others were tied-up on these dates. Some others expressed their strong interest to discuss further the proposed matter for a future response. Other companies referred that they don't know the India market and would be difficult to take the risk for potential co-operations in this area. Few companies mentioned the long distance of India from Greece which is an obstacle for having a proper supervising for operations. Some companies are not interesting because their strategic targets are the Balkans where they have already operations and they don' intent for giving additional funds for seeking investment in other countries.
