COMMENTS

It was very disappointing to learn that only 2 Australians attended the Forum in Bangkok - Mr. Max England of Melbourne who is Thailand's BOI representative in Melbourne and Mr. Peter Forsythe of Stephen Fitzgerald Consulting Pty. Ltd. - who just happened to be in Bangkok (Stephen Fitzgerald is an ex-Australian Government Ambassador to China).

As copies of correspondence show, timing of the Forums - from Australia's point of view - was unfortunately too close to the Christmas shut down period. Our holiday period is the exact opposite to those countries north of the equator. I personally do not agree 100% with this view - but I do agree with the comments made by most people. I spoke to personally that the "lead" time to the Forums just did not allow sufficient time for alterations to be made to existing programs of personnel, who were either already travelling overseas, or had completed the years itineraries.

The general communication - or the lack thereof - left a lot to be desired.

It was taking 2 days for me to receive telexes from UNIDO Vienna which, for some reason or another, were retransmitted via U.N. New York. For instance the Indonesia brochures arrived on my front door step one day before the telex arrived advising me of their despatch from Vienna. Then it was taking 2/3 days for cables to arrive.

On receiving UNIDO's advice to pick up BOI brochures from the BOI Office in Sydney, I rang them to let them know I would be around to pick them up. They had no idea what I was talking about. BOI Bangkok had not informed them of the Forums in any way at all. And they had only 5 brochures. I called on them - received 100% co-operation particularly from their Ms. Colleen McMahon and later from Max England of Melbourne.

On arriving in Bangkok (18th November) I called on the Austrade, General Manager, Mr. Richard Fletcher at the Australian Embassy only to be told that invitations for the Ambassador, Mr. Richard Smith and for Richard Fletcher to attend the opening ceremony of the Forum, arrived "by hand" at 9:30 a.m. on the morning of the opening which was to commence at 9:00 a.m. Needless to say - they both were unable to attend - which they regretted - and of course if such information is sent to Canberra it does not help matters.

Overall, the idea of the Forums were very well accepted, notwithstanding that the majority (95%) of people I spoke to had no idea that there was an Investment Promotion Division within the UNIDO framework. I was given 100% co-operation by Federal Government departments and those associations I have previously listed. Unfortunately, some trade organisations were unable to print information in newsletters due to space deadlines etc.

RECOMMENDATIONS

The response by Australian industrialists and business organisations to UNIDO's Forum in Bangkok is indicative of the "thinking" of the majority of Australian exporters. See Appendum "T".

I have repeatedly suggested that the U.N. body as a whole has to implement a program to advise Australia and its people to know the aims and the workings of the United Nations in general.

Articles in our newspapers such as the one attached, Appendum "U", always manage to find editorial space. The good things that are carried out don't seem to find equal space.

An educational program on the workings of the United Nations Industrial Development Organisation as an identity is, I believe, the necessary action required to bring to the notice of the people of this country the practical endeavours of UNIDO. promote the workings of the Investment Promotion Division could only succeed - at this stage - by being financed completely by UNIDO for a two year period or by convincing Australian business organisations to contribute to maintaining such an office in Melbourne or Sydney. I cannot see the Federal Government making any contribution in its present mood. Then again it may take a "more realistic" view if it can be seen that UNIDO is keen to promote its worldwide activities in this country. With a well balanced approach to both State and Federal Governments, Chambers of Commerce, Chambers of Manufacturers, Metal Trades Industry Associations, bankers and industrialists, by UNIDO, an Investment Promotions Office in Australia would succeed.

While the return on investment between the Australian Government and UNIDO seems to be relatively low by way of contracts and/or consultancy services so it can also be said of the apathy of Australian exporters towards doing business with the United Nations agencies as a whole.

There is an alternative to an office in Melbourne and Sydney. I know that Brisbane and/or the State of Queensland would be most interested in supporting a UNIDO Investment Promotion Office. I have a very good liaison with the Queensland State Government and the Brisbane Development Council which is controlled by the Brisbane City Council and believe that with a "gentle" approach one would be able to overcome the obvious political differences - Queensland and Tasmania are the only non-labour held States in Australia – at this time. I have no doubt that general local industry and particularly, agro based industries, would support such a scheme, particularly if it were initiated by either the Brisbane Development Council and/or the State Government. You could also rely on the State bank, major trading banks and the larger Australian industrial organisations for support.
