# 4.0 REQUESTED MODIFICATIONS

## 1.0 INTRODUCTION TO A.C.S. (ANTIGUA'S CUSTOMS SYSTEM)

### 1.1 BACKGROUND

This report is in satisfaction of the development objectives of UNIDO Project Number DP/ANT/87/002 for the design and implementation of a computerized control system for the tourist complex, duty free shopping center at Heritage Quay.

Data General Puerto Rico, Inc. and the Caribbean Institute of Applied Computer Technology (CARIACT), Montserrat, entered into a joint venture agreement to satisfy the requirements of the project. The Terms of Reference for the Project direct that the Data General/ CARIACT Team work with the management of the St. John's Development Corporation (SJDC) to design an appropriate computerized system which will enable SJDC and Customs Service, to track both, duty-free and duty-paid sales at the Heritage Quay Shopping Center.

However, it should be mentioned that due to administrative matters, CARIACT withdraw from the study team previous to the completion of the system design. Data General then proceeded to complete the design and develop the software application.

## 1.2 SCOPE OF THE PROYECT

The project was initiated late in 1989, and suffered an unavoidable delay caused by Hurricane Hugo. This, together with the upcomming 1989/1990 tourist season, pressured the completion of the project and influenced the decision to focus the study on the automation of the manual system currently being used by Customs. This was decided at a Project Erieting conducted on September 14, 1989, which participants were members of government organizations, the Merchants Organization and the Chamber of Commerce.

The study team has been aware of ASYCUDA (Automated System for Customs Data Acquisition), the system being introduced throughout the Caribbean by the United Nations and the Organization of Eastern Caribbean States. Once implemented, ASYCUDA will automate information concerning the passage of imported goods into Heritage Quay shops. Discussions with Customs officials revealed that it was possible that ASYCUDA would not be fully operational before this project was finished. Consequently, the impact of ASYCUDA on the overall system did not significantly influence the proposed design.

Nevertheless, ASYCUDA was fully operational before the implementation of the proposed design was finished. During the training sessions, some modifications were requested so that the A.C.S. (Antigua's Customs System) would be compatible with the ASYCUDA.

The project suffered a second delay to comply with the workplan caused by a change in the scope of the project. Implementation of the system design was required in addition to its development.

### 1.3 EXECUTIVE SUMMARY

The difficulties associated with Custom's existing manual system are well recognized by Government officials, both in the Customs Service and in other branches. The legislation encouraging the local purchase of goods which would not be exported, and for which duty must be paid, has complicated the information needs of the Customs Service. This complication has proven almost impossible to manage manually and forced the design of an automated system. There is also the perception that duty which should be paid is not being paid due to the lack of positive control of the goods destined for the Heritage Quay Center. In addition, merchants comment that delays in processing data at Customs adversely affect their business operations.

Discussions with local Customs officials, as well as officials associated with the ASYCUDA program, help the development of the computer system: hardware and software. Many alternatives were considered. These range from systems which only permit receipt of the duty-free goods as the purchaser is leaving the country; to systems which place the entire burden of record keeping and tracking upon the merchant, with detailed audits being performed by Customs to assure compliance.

The study team recommended that an analysis of the overall economic impact of the Duty-Free Center and its automation be accomplished. It could treat such matters as the economic and political benefits to the nation resulting from the operation of the Center, relative to the costs associated with each of the suitable alternatives for Customs control. However, this analysis was not possible and the immediate development of the application was required.

A.C.S. (Antigua's Customs System), the developed application, automates the current system, chosen by the Customs Service to provide the necessary information to track the sale of duty-free goods and to collect duty on those goods which are subject to payment. It therefore allows an accurate control of the duty that most be paid by the merchants. The application is based on the SYSTEM DESIGN developed by the study team.

The installed hardware includes an IBM PS/2 with four terminals for operator input and data processing. It is located at the Heritage Quay offices of Customs Service, and is operated by Customs Service personne!.

### 2.0 SYSTEM DEFINITION

### 2.1 ACCOMPLISHED OBJECTIVE

Install hardware, develop and install software, and train users of a system that manages the consolidation of business transactions at Heritage Quay Complex.

# 2.2 ENVIRONMENT IN WHICH THE SYSTEM IS OPERATING

Owned by St. John's Development Corporation, Heritage Quay is a duty free shopping center and tourist complex that includes stores of various types.

These stores range from locally-owned first time entrepeneurs with small inventory levels, to internationally -recognized well established stores. Available merchandise includes items of all types and prices.

The computer system under discussion is located at Customs facility at the Heritage Quay Complex.

## 2.3 SCOPE OF THE SYSTEM

The system supports a total of 4 simultaneous users that monitor the daily flow of duty free and duty paid goods sold, as reported by each store.

The current estimated amount of this information comes to a yearly total of 273,000 transactions. Nevertheless, the increasing competitiveness of Antigua as a duty free port and the expansion of its tourism industry has led the study team to take into account a yearly increase of 10% in business transactions. Growing capacity has been estimated by Mr. Winston James, SJDC Executive Director, to double the amount of shops in two years. It should also be noted that Customs need to keep record of the information corresponding to seven years. Nevertheless, only that corresponding to the current year need to be online. It has therefore been provided for an "yearly cleanup". That is, at the end of each year they produce a hard copy report on the stores and their transactions, they also produce a backup, and then cleanup the files to free space in the computer. In case any of that information is again necessary, it can be restored from the backup.

### 2.4 BASIC FUNCTIONAL DESCRIPTION

Merchandise arrives in the Country at an airport or seaport It is generally accompanied by a commercial invoice or a "Bill of Landing", describing the merchandise in detail. The importer, or his agent, upon notification of the arrival of merchandise at a port of entry, prepares the Form 20, "Customs Warrant".

Information for transcription to the Form 20 is in general taken from a commercial invoice. There is a possibility that this information exists in machine readable form and thus could be automatically transferred to the Form 20. However, this part of the procedure will be influenced by ASYCUDA.

The filled-in Form 20, with computation for the amount of duty due, is sent with the merchandise listed on the form, for presentation to the Customs Examiner.

The warehouse of the vendor receiving the merchandise is treated by Customs as a Private Bonded Warehouse.

Each item in the shipment is inventoried by Customs officials, where the items are checked against reference numbers to determine legality for duty free sale. For each item that appears on the Form 20 a page must be prepared in a Customs Bond Book. A Bond Book is prepared for each vendor authorized to sell duty-free merchandise at the complex. Within each Book, a page is set up for each item for which reference numbers have been defined.

Entries on the pages of the Bond Book are structured to provide a running inventory of items that have been sold; i.e., removed from bond. Each entry is identified as duty free or duty-paid transaction and the amount of that item remaining in bond is adjusted to reflect the withdrawal.

Information contained in a "Summary of Goods Sold for Profit" form, which is prepared each day by each vendor, is used to keep the Bond Books current. Each line in the summary represents a sale and must be supported by the attachment of "DutyFree Sales Invoice". Duty paid sales must also be accompanied by an invoice.

Every month each vendor is required to review his Form 20 to determine the amount of duty that should be paid. He submits completed Forms 20, which are checked against his Bond Book at the Customs Office. If the information in the vendor's Forms 20 agrees with that in the Bond Book, the duty as computed is accepted from the vendor.

## 2.5 OPERATING SYSTEM

A multiuser system developed includes an operating system with support for data-base management software and application development languages. Considering future expansion, it also provides support for office automation software, communications, and networking.

The DOS operating system is an industry standard, single-user, singletask disk operating system. DOS manages all system resources including display, keyboard, printer, disks, and communications. A simple command language provides the user interface to the system. Some of its basic features include support for: large fixed disks and multiple DOS partitions on fixed disks, a virtual disk utility for creation of RAM disks for fast data access, a "searchlist" file access utility, a wide range of international keyboards, and networking support. A wide range of utilities enable file and disk management and program development. Third party utilities provide performance improvement, support for third party peripherals, and for the development of multiuser-multitasking application environments.

### 2.6 APPLICATION DEVELOPMENT TOOL

ICX, Data General's Interactive COBOL (ICOBOL) under DOS, has been used as the application development tool for A.C.S. (Antigua's Customs System), and utility to create a multiuser-multitasking environment of a microcomputer. With the appropriate hardware configuration, as many as eleven users may run ICOBOL programs concurrently.

This tool was selected and used since many ICOBOL applications have been designed specifically to meet the computing needs of businesses, large and small. Besides, it protects the customer's investment in application software by executing identical object code on diverse computer architectures. Application programs and associated data files may be moved among machines without recompilation or conversion. This level of compatibility offers an extremely attractive growth path at no cost in programming time. It should not be forgotten that under DOS operating system, Data General supports ICOBOL on a runtime only basis. That is, it provides an execution environment and data file maintenance utility for PCs running the industry-standard MS-DOS operating system. It is compatible with full development ICOBOL on Data General's proprietary and open systems products, but does not include a compiler. In order to be executed, application object and data files must be developed on DG's AViiON, 386/ix, Eclipse, MV, or Desktop families and copied to the DOS systems.

### 2.7 SUPPORT SOFTWARE

"Carbon Copy" has been acquired from Computer World to provide remote technical support. This is a software package that enables a microcomputer (PC) to connect via modem to a remote microcomputer (PC) running under the DOS operating system, and control the remote computer's monitor and keyboard. It also allows for file transfer between computers. The idea is for Data General Puerto Rico to be able to connect to the Customs PC and provide immediate technical support without having to travel to Antigua.

### 2.8 HUMAN RESOURCES

Two System Administrators has been selected to perform system operation functions such as password structuring, system backups, report generation and overall system management.

Another individual with sufficient programming experience would be required to perform some specialized tasks that will be necessary on a part-time basis.

Four to five full-time operators have been designated to do the ongoing data entry of transactions from the summary forms.

# 2.9 TRAINING OF PERSONNEL

# 2.9.1 APPLICATION SOFTWARE

During her visit to Antigua on March 11 - March 18, Mrs.Lydia Cuevas, one of Data General's software specialist, performed the corresponding application training.

Mr.Erling Rask, UNIDO representative, participated on Lydia's training. He then, with Lydia's assistance, performed a second training session for Custom's employees who could not assist to the previous one.

System Administrators were given most emphasis, since they will now be responsible for additional training required by the operators.

# 2.9.2 OPERATING SYSTEM

System Administrators and operators were trained on DOS operating system general concepts. System Administrators were given most emphasis, since they will now be responsible for additional training required by the operators.

DOS is an unsophisticated operating system, which do not have "user-friendly" utilities to help the user "manage" the system. For this reason the study team considers that a complete course on the DOS operating system is essential for the Administrators. This type of course is provided by either the hardware supplier or any educational institution.

# 2.9.3 ICX (INTERACTIVE COBOL)

System Administrators and operators were given a general overview on Interactive COBOL as the developing tool and environment manager.

An Antigua's government technical official was given a more technical overview of the ICX. An instruction manual and technical notes were given to him for consulting purposes. He and Mr.Erling Rask (UNIDO representative) were present when Mrs.Lydia Cuevas gave Mr.Raphael Benjamin (Customs Deputy Comptroller) the diskettes containing the Customs Application, and the Interactive COBOL. Instructions on how to install both were included with the diskettes.

# 2.9.4 BACKUP UTILITY

Custom's system has two medias available for backup: diskette drive and tape drive. The diskette drive is managed through DOS commands. However, the tape drive is managed through a software program.

On March 18, 1991, the System Administrators had not yet been trained on the use of this control program. This is the supplier's responsibility. Dr.Perry (Computer World's representative) has compromised himself to prepare a menu for the tape backup procedure, so to make it more "user friendly" and perform the corresponding training.

# 2.9.5 SUPPORT SOFTWARE

On March 18, 1991 the System Administrators had not yet been trained on the use of the "Carbon Copy" either. Once again, this is the suppliers responsibility. Dr.Perry (Computer World) has compromised to offer the corresponding training.

# 3.0 HARDWARE DEFINITION

1

### 3.1 BASIC FEATURES

The nature of the procedures being automated required the development of a multiuser system with a reliable, cost- effective processor with enough capacity to maintain a small business environment. The basic system supports 4 standard "dumb" terminals and a printer.

If necessary, it provides to be available 24 hours a day, 7 days a week. It also provides a mechanism for periodic backups of the data, so allowing for reconstruction in case of disaster. Likewise, U.P.S. power requirements should be set out in detail for disaster prevention.

Based on these characteristics, the following hardware configuration was acquired from Computer World, Antigua:

## 3.2 CONSTRAINTS

# 3.2.1 SITE CONSIDERATIONS

Proper site selection, preparation and maintenance can contribute to the successful operation of the computer system and to the efficiency and well-being of the people who work at the site. Certain aspects must be observed.

Avoid a corrosive or dusty environment. Keep in mind that the floor covering, and the computer hardware should be cleaned frequently.

Include space for the actual system, and for storage areas, worktables, desks, and traffic areas. Backup tapes should be stored in a well-protected, fire-proof vault or container. There should be enough space to expand your site as more equipment and personnel are added.

### 3.2.2 ENVIRONMENTAL CONDITIONS

Clean air is essential for the operation of a computer system. Airborne contamination can corrode copper and other metals and eventually can cause short circuits or other problems in computers.

Contamination may come into the computer room on people's clothes, in the air supply, or generated as paper dust, etc. Therefore, the air filtration system must be permanent and in proper working order. The best way to keep the air clean is with the site's air conditioner filters.

Computer equipment is not designed to operate outside of specified temperature and humidity ranges. Avoid abrupt changes in either, they could damage the equipment.

### 3.2.3 SAFETY AND SECURITY REQUIREMENTS

Always consider the safety of personnel, as well as system security. Check the local building safety codes, fire prevention and control codes, lighting protection, and emergency lighting codes to be sure that your site is in compliance.

### 3.2.4 ELECTRICAL REQUIREMENTS

A proper electrical system is essential to a site's safe and successful operation. Electrical problems can cause system downtime, lost data, and wasted manpower. Poor quality electrical power can even damage some equipment. Your main concern will be supplying the proper voltage and current. Power fluctuations in the external power system are quite common. Based on the Customs application and the environment in which it will operate, this study team recommended an Uninterrupted Power Supply (UPS) system, which has been included as part of the hardware configuration. To keep this UPS in optimal operating conditions is essential.

## 3.2.5 DELIVERY AND INSTALLATION

Computer World's hardware specialists were in charge of the equipment's installation. They prepared the system, connected the cables to the peripheral devices, and performed system diagnostics.

Data General's software specialist, Mrs.Lydia Cuevas, performed the application installation during her visit to Antigua, March 11-March 19. She gave Mr.Raphael Benjamin the diskettes with the application software and the ICX files, together with detailed written instructions on how to install both in case of disaster.

# 4.0 REQUESTED MODIFICATIONS

The training sessions were also used as a "debugging sessions" where the users were able to test all the A.C.S. (Antigua's Customs System) components. Several modifications were requested, some of them related to the ASYCUDA project, trying to make both systems compatibles.

Data General's programmer, Mr.Jorge Rodriguez, made the requested modificatios. Most of them were ready on time for Mrs.Lydia Cuevas to install them during her visit to Antigua (March 11 - March 18). The rest is been sent to Customs official Mr.Raphael Benjamin as A.C.S. Software Revision 1.1.

However, one of the requested modifications is beyond the scope of this project. It involves changes that do not comply with the system design developed according to the basic functional descriptions discussed by Customs officials, and approved by Customs and Government officials. It involves the development of an "Accounts Receivable Like" Module to inform the vendors about their duty liabilities and keep track of the payments.

It is this study team's recommendation that UNIDC evaluate the need for the development of such additional software module.

# CHAPTER I. WELCOME TO THE ANTIGUA CUSTOMS AT HERITAGE QUAY APPLICATION

This book introduces you to the Antigua Customs at Keritage Quay Application. You may use this book as a guide to learning about the system, and how it may help you in your office work. You do not need to have any experience with computers to use this book.

#### CHAPTER II. WORKING WITH THE TERMINAL AND COMPUTER

#### **KEYBOARD INFORMATION**

Your keyboard contains Function Keys and alphanumeric character keys. The Customs System uses both groups of keys. The keyboard layout varies depending on the personal computer and terminal you use. However, the key definition will be the same.

Function Keys appear at the top of the keyboard or to the left of the keyboard. The Function Keys are numbered F1 through F10 (F for Function key, and a number for the corresponding position). The "Advice/Help Line" (see next Chapter, Session "Using the Customs System Menus") labels the Function Keys used in the Customs System according to the tasks assigned to them.

You use the Function Keys alone or in combination with the Shift ( ) key. An example of a Function Key used with the Shift Key is the Index Key (Shift F2). The Index Key displays a "window" (small screen) with available options on prompts asking for: STORE NUMBER, REFERENCE NUMBER, CATEGORY OF GOOD, CARRIER, OR COUNTRY OF ORIGIN. This is true for all the Modules on the Customs System.

Use the ESC key (in the upper-left corner of your keyboard) to cancel an activity or exit a MENU.

The Alphanumeric Character keys are those keys you press to type some information. In addition, you may use some of these keys to perform a task when they identify a MENU option.

Key Name Symbols identify some keys on your keyboard that have printed names or abbreviations. Other keys have symbols instead of names.

For example:

- <- | Backspace - to position the cursor one space to the left of its current position.
  - Shift to type a capital letter, or in combination with a Function Key to perform an assigned task.



- New Line <NL> to accept a MENU option or prompt information.
- Carriage CR
  - Return - <CR> - similar to a New Line, but ignoring information ' the right of the cursor.

ESC | ESC - to cancel an activity or end MENU.

#### GETTING YOUR USERNAME AND PASSWORD

To begin using the system, you need to know your username and password. These are two code words that allow you to start communicating with the computer and the Customs Application. Your username and password are unique; they protect the privacy of each user.

If you haven't already done so, ask your office or system manager for your username and password. Make a note of them and keep it in a safe place. Your password is your personal key to the computer.

#### COMMUNICATING WITH THE COMPUTER

You are ready to open communications with the computer once your screen looks like this:

On your screen, you see a little underlined space ("\_\_") beside the word, USERNAME. That underlined space is called the **cursor**. It shows where the next character you type will appear on the screen.

The computer is waiting for you to type your username, so type it and press the NEW LINE key once.

Now the cursor rests beside the word PASSWORD:. Type your password and press NEW LINE once more. Your password will not show on the screen as you type it.

The computer checks your username and password. If it recognizes them, it will begin communicating with you. If it doesn't recognize your username and password, chances are you made a typing mistake. The system then displays an error message (see below) and allows you to re-enter the information. You are given three chances to enter a correct USERNAME/PASSWORD pair, or you will be automatically loged-off.

After the computer recognizes your username and password, your screen will display the MASTER MENU.

Below is the MASTER MENU for the regular user. Users with System Administrator's privilege will use a different MASTER MENU.

#### CHAPTER III. TOURING THROUGH THE CUSTOMS SYSTEM

As shown in the previous Chapter, the first screen you see when you are in the Customs System is the MASTER MENU. This is similar to a MENU in a restaurant, except that you may "order" only one choice at a time. After you decide on a choice, you tell the system what it is. The system may then "deliver" your choice, or ask you more details - often by displaying another MENU.

#### THE MENU SYSTEM

The Custom's Master Menu is your starting point. You may move to other MENUs by selecting choices from the MASTER MENU, and you may return to the MASTER MENU by pressing the ESC key. ESC will bring you one step ("MENU") back each time you press it.

The Custom's MENU SYSTEM is like a roadway with many intersections (see illustration below). Starting from the MASTER MENU, you may move to any of several destinations and back "home" again. When you are at one destination and want to move to another, you go home first, and then off to another destination.

Following is a diagram for the SYSTEM ADMINISTRATOR'S MENU SYSTEM:





Following is a diagram for the REGULAR USER'S MENU SYSTEM:

ALWAYS REMEMBER THAT THE ESC KEY BRINGS YOU ONE STEP BACK FROM WHERE YOU ARE; I.E., ONE MENU SCREEN OR ONE COMMAND SCREEN BACK. If you are at any particular screen on the system and you want to return to a previous Menu or to the "Master Menu", PRESS ESC the necessary amount of times until you get the desired Menu.

#### USING THE CUSTOMS SYSTEM MENUS

Let's look at a sample MENU SCREEN, the system's MASTER MENU:

Choices Lists the choices you may make from this MENU. Advice/ Help line Give you advice about what to do next, and about the tasks assigned to different keys. Choice Selection Shows which choice the user have selected. Whenever the system displays a MENU, it suggests a choice; you may either accept the system's suggestion, or type another number instead.

#### SELECTING A MENU CHOICE

You tell the Customs System what you want to do by selecting a choice from the MENU. The system responds to your choice only after you press the NEW LINE key ( $\langle NL \rangle$ ). That means you may change your mind any number of times before pressing this key. If you type a number that is not on the MENU, the system sends you an error message.

There are three ways to tell the system which MENU choice you want:

1. If you want the MENU choice number that the system give you automatically (the "default"), you do not have to type number at all. Just press NEW LINE (<NL>) and the system will you the MENU choice it has suggested.

- 2. If you want a MENU choice that is different than the one the system suggested, simply type the number that corresponds to your choice; for example, type 02 and press NEW LINE (<NL>). You could also type 2 and press CARRIAGE RETURN (<CR>).
- 3. Follow the description on the "Advice/Help Line" (see previous page) to identify the uparrow (F1) and downarrow (F2). On your keyboard, find those keys and press them. Watch the choice number change again; but nothing else happens because you have not preseed NEW LINE yet. Position the cursor where desired and press NEW LINE (<NL>).

#### GETTING HELP FROM A MENU

As shown in the MASTER MENU on a previous Session on this Chapter, Shift F1 is the key combination necessary for a regular user to display the MENU PROCESSOR screen; i.e., the help screen shown below.

#### COMMAND SCREENS

Most MENU options will bring you to a COMMAND SCREEN. A COMMAND SCREEN is a screen that contains one or more prompts, at which you are expected to enter information.

Just as discussed for MENU SCREENS, COMMAND SCREENs may also present "default answers" (system's guess) for some of its prompts. To accept any default response just press NEW LINE while the cursor is at the related prompt. To enter a different response, type over the default response, and erase any extra characters by pressing the CARRIAGE RETURN (CR) key, or pressing space bar the necessary number of times.

Some COMMAND SCREENS may lead you to another COMMAND SCREEN once the information on all the prompts is completed or once you type a Function Key. Always look at the information on the "Advise/Help Line" for instructions. Go to the next Chapter, "Putting the Customs System to Work", for a general explanation on available tasks.

You may return to the previous COMMAND SCREEN and/or MENU by pressing the ESC key each time.

Let's look at a sample COMMAND SCREEN. This screen is the one used by the Customs System to enter the information on GOODS SOLD FOR EXPORT:

ALWAYS REMEMBER THAT THE ESC KEY BRINGS YOU ONE STEP BACK FROM WHERE YOU ARE; I.E., ONE MENU SCREEN OR ONE COMMAND SCREEN BACK. If you are at any particular screen on the system and you want to return to a previous Menu or to the "Master Menu", PRESS ESC the necessary amount of times until you get the desired Menu.

This same line asks for the Choice Selection.

#### CHAPTER IV. PUTTING THE CUSTOMS SYSTEM TO WORK

Let's take a minute to talk about the "Advice/Help Lines".

#### **MENU SCREENS**

On MENU SCREENS, the "Advice/Help Line" is always the same:

F1-Up/F2-Down/F5-Execute/shF1-Help, <NL>-Select/{ESC}-Exit

- **F1-Up:** in all MENUS, Function Key 1 (F1) has been assigned the task of moving the cursor one line up throughout the MENU options. Remember that the system responds to your choice only after you press NEW LINE (<NL>).
- **F2-Down:** in all MENUS, Function Key 2 (F2) has been assigned the task of moving the cursor one line down throughout the menu options. Remember that the system responds to your choice only after you press NEW LINE (<NL>).
- **F5-Execute** Function Key 5 (F5) has been assigned a taks of an equivalent to NEW LINE (<NL>). Once you identify the desired MENU option, you press F5 and the system responds to your choice.
- ShF1-Help Function Ke<sup>1</sup> 1 (F1) pressed together with the Shift Key has been assigned the task of displaying a Help Screen (see Chapter III., Session "Getting Help from a Menu").
- <NL>-Select The NEW LINE Key has been assigned a task of an
  equivalent to F5 (Execute). Once you identify the
  desired MENU option, you press NEW LINE and the system
  responds to your choice.
- **(ESC)-Exit** The ESC Key is used to exit a MENU; i.e., move you back to the previous MENU.

#### **COMMAND SCREENS**

The first COMMAND SCREEN on most of the Modules (Security, Master Files, Bond, and Inventory), displays the following "Advice/Help Line":

#### F1-Create/F2-Modify/F3-Delete/F4-Search/ESC-Exit:

COMMAND SCREENS with a different "Advice/Help Line" refer to situations where not all tasks are possible. For example, the COMMAND SCREEN used to enter information on GOODS SOLD FOR EXPORT (discussed in the previous Chapter) do not display the MODIFY (F2) option. The purpose of this Session is to present a general explanation on the available tasks, so that you may work with the system even if the "Advice/Help Line" you get on a specific screen is different from the one discussed. On the next Chapter we will discuss all the MENU OPTIONS on the system and most of the operations associated with them.

Fl-Create: in the "Advice/Help Line" displayed above, Function Key 1 has been assigned the task CREATE a record.

> When this Function Key is pressed, the cursor is positioned on the first prompt on the SCREEN, allowing you to enter information. NOTICE THAT THE "ADVICE/ HELP LINE" GIVES GENERAL INSTRUCTIONS ON WHAT EACH PROMPT IS ASKING FOR. Enter the information and press NEW LINE or CARRIAGE RETURN. The cursor advances to the next prompt, and the "Advice/Help" displays corresponding instructions. Once you press NEW LINE or CARRIAGE RETURN on the last prompt, the system asks you if it is OK to CREATE the record.

You may cancel the CREATE operation at any point by pressing the ESC key. You may also press ESC after the CREATE operation is completed to go back one "step": each time you press ESC, the system will bring you back one COMMAND SCREEN or one MENU.

**F2-Modify:** Function Key 2 (F2) has been assigned the task MODIFY information on a CREATED record.

When this Function Key is pressed, the cursor is positioned on a prompt on the SCREEN where you may enter some information that identifies the record you want to MODIFY. When the record is identified and its information displayed, the cursor is positioned on the first prompt, allowing you to make changes.

THE "ADVICE/ HELP LINE" GIVES GENERAL INSTRUCTION ON WHAT TO DO AT EACH PROMPT. Once you press NEW LINE or CARRIAGE RETURN on the last prompt, the system asks if it is OK to update the record.

You may cancel the SEARCH operation at any point by pressing the ESC key. You may also press ESC after the SEARCH operation is completed to go back one "step": each time you press ESC, the system will bring you back one COMMAND SCREEN or one MENU. **F3-Delete:** in the "Advice/Help Line" displayed above, Function Key 3 (F3) has been assigned the task DELETE; i.e., delete the information on a record that has been CREATED already.

> When this Function Key is pressed, the cursor is positioned on a prompt on the SCREEN where you may enter some information that identifies the record you want to DELETE. Once the record is identified and its information is displayed, the system confirms if you really want to DELETE it.

You may cancel the DELETE operation at any point by pressing the ESC key. You may also press ESC after the DELETE operation is completed to go back one "step": each time you press ESC, the system will bring you back one COMMAND SCREEN or one MENU.

#### F4-Search: in the "Advice/Help Line" displayed above, Function Key 4 (F4) has been assigned the task SEARCH; i.e., SEARCH for a record and display it's information.

When this Function Key is pressed, the cursor is positioned on a prompt on the SCREEN where you may enter some information that identifies the record you want to SEARCH for. Once the record is identified and its information is displayed, you are presented with another "Advice/Help Line" giving you the available tasks you may perform with that information.

Note that in a SEARCH operation the system does not verify the validity of the information you enter to identify the record it is going to SEARCH for. The reason for this is that if the system is unable to find a record with the exact same information as you specified, it will bring the available record with information closest to the one specified.

Note also that the SEARCH may be used as an indirect way to MODIFY a record. If you are not absolutely sure of which record you want to MODIFY, you may use the SEARCH operation to display the information for various records with a particular information. Once you find the specific record you are looking for, you may then choose to MODIFY it.

You may cancel the SEARCH operation at any point by pressing the ESC key. You may also press ESC after the SEARCH operation is completed to go back one "step": each time you press ESC, the system will bring you back one COMMAND SCREEN or one MENU.

**ESC-Exit:** The ESC Key is used to cancel the current activity and go back one step; i.e., go back one task, or one MENU, or one COMMAND SCREEN.

Once you have entered the TRANSACTION DATE, the system displays a number on the left side of the third line on the screen. This number represents the amount of shipments received (records created) on the specified TRANSACTION DATE, and for the specified REFERENCE NUMBER (good) for that STORE.

Continue to enter the corresponding information for the next prompts. REMEMBER TO PRESS NEW LINE EACH TIME AFTER TYPING THE INFORMATION, NOTICE THAT THE SYSTEM WILL NOT ALLOW YOU TO LEAVE AN EMPTY PROMPT, AND NOTICE THE AVAILABILITY OF AN INDEX KEY FOR "COUNTRY OF ORIGIN".

It might be helpfull for you to use CARRIAGE RETURN (<CR>) instead of NEW LINE (<NL>) on the prompts asking for a number. This way you will not have to enter the decimal period and values each time (for more information go to Session "Keyboard Information" on Chapter II. "Working with the Terminal and Computer").

Also notice that some of the prompts are calculated automatically. For example, once you enter the the QUANTITY received, the "ON HAND" quantity is automatically updated to include the amount just received. Once you enter the DUTY RATE, the DUTY AMOUNT is calculated; once you enter the CONSUMPTION RATE, the CONSUMPTION TAX is calculated.

The CUSTOMS SERVICE RATE is a constant, which was defined to the system by the System Administrator, through the "Company File Maintenance" option of the "Security Menu". The system gets this constant and automatically calculates the CUSTOMS SERVICE CHARGE. It then adds up all the tax information (DUTY AMOUNT, CONSUMPTION TAX, CUSTOMS SERVICE CHARGE) and calculates the total DUTY LIABILITY. When all the information is entered and you press NEW LINE or CARRIAGE RETURN on the "Remarks" prompt, the system verifies if it is OK to CREATE the record.

AS ALREADY MENTIONED, REGULAR USERS only have the option to CREATE records; i.e., enter information regarding RECEIVED GOODS.

ON THE OTHER HAND, USERS WITH SYSTEM ADMINISTRATOR'S PRIVILEGE also have the option to MODIFY, or DELETE records (i.e., information on GOODS RECEIVED).

When a System Administrator selects to SEARCH, the system gives him the choice to SEARCH by STORE NUMBER, REFERENCE NUMBER, or WARRANT NUMBER.

Once the user specifies the type of SEARCH desired, the system positions the cursor on the corresponding prompt, allowing the user to enter the information. Remember the availability of the Index Key (Shift F2) to define the STORE NUMBER and REFERENCE NUMBER.

When the user fills the prompt and presses NEW LINE, the system displays the information corresponding to the first shipment recorded for that STORE/REFERENCE NUMBER/WARRANT NUMBER. If it cannot find a record with the exact information as specified, the system brings the record with information closest to the specified. It then gives the user the options to: go to the information on the NEXT record available, MODIFY, or DELETE the displayed information.

If the user selects to MODIFY, the cursor is positioned on the "Warrant No" prompt, allowing to make changes. Notice that the information on the previous prompts ("Store Number", "Reference No", "Tariff Item No", and "Transaction Date") may not be MODIFIED. To MODIFY this information, the record would have to be DELETEd and CREATEd again.

Once the user presses NEW LINE or CARRIAGE RETURN on the "Remarks" prompt, the system confirms if it is OK to update the record.

Valid REFERENCE NUMBERs are those that have been created by a System Administrator through the "Reference File Maintenance" option on the "Master Files Menu". Note that in the COMMAND SCREEN we are discussing, the system does not verify the validity of the REFERENCE NUMBER you enter. The reason is that the system gets it's information to produce the report after doing a SEARCH of the file. If it is unable to find a record with the exact same REFERENCE NUMBER as you specified, it will use the available record with a REFERENCE NUMBER closest to the one specified. This is a powerful feature that allows you to produce reports that satisfy all your needs.

You may then start defining combinations of STORE/REFERENCE NUMBER. kemember that, as suggested in the "Advice/Help Line", Shift F2 is the Index Key available to help you define the STORE NUMBER and the REFERENCE NUMBER. REMEMBER TO PRESS NEW LINE EACH TIME AFTER TYPING THE INFORMATION, NOTICE THAT THE SYSTEM WILL NOT ALLOW YOU TO LEAVE AN EMPTY PROMPT, AND NOTICE THE AVAILABILITY OF AN INDEX KEY (Shift F2) FOR "CARRIER".

It might be helpful if you use CARRIAGE RETURN (<CR>) instead of NEW LINE (<NL>) on the prompts asking for a number. Remember that the system verifies that the quantity sold is available as part of the updated inventory. The cursor is positioned on the first REFERENCE NUMBER on the Index Window, which is highlighted. The bottom line on the window defines the task assigned to each Function Key that may be used to move through the Index. Notice that F1 moves the cursor one REFERENCE NO. up, while F2 moves it one REFERENCE NO. down. On the other hand, F3 (PREV SCREEN) displays the <u>previous</u> ten (10) REFERENCE NO'S (if there are as many), and F4 (NEXT SCREEN) displays the <u>next</u> ten (10) REFERENCE NO'S (if there are as many).

Use the function keys until the desired REFERENCE NUMBER is highlighted by the cursor; then press F5 to select it. The system automatically displays on the COMMAND SCREEN the REFERENCE NO., and the description for the selected good.

Suppose for example, that we select REFERENCE NO. 6283. The corresponding information is displayed and the cursor is positioned on the "Transaction Date" prompt.

Continue to enter the corresponding information for the next prompts.

REMEMBER TO PRESS NEW LINE EACH TIME AFTER TYPING THE INFORMATION, NOTICE THAT THE SYSTEM WILL NOT ALLOW YOU TO LEAVE AN EMPTY PROMPT.

It might be helpful if you use CARRIAGE RETURN (<CR>) instead of NEW LINE (<NL>) on the prompts asking for a number. This way you will not have to enter the decimal period and values each time (for more information go to Session "Keyboard Information" on Chapter II. "Working with the Terminal and Computer").

Remember that the system verifies that the quantity sold is available as part of the updated inventory. If the quantity on hand is insufficient, the system will display the following error message and will not accept the transaction: "Quantity on stock exceeded. Qty available: X.XX", where X.XX is the available amount.

Once all the information is entered and you press NEW LINE or CARRIAGE RETURN on the "Remarks" prompt, the system verifies the REPORTED CIF VALUE AND DUTY LIABILITY with the information on recorded shipments, i.e., information entered for the current inventory (entered through the "Customs Private Bond" option on the "Bond Menu").

How does the system knows which CIF VALUE to use? The system keeps record of the dates of the recorded shipments. It then looks within the shipments with positive balance (i.e., all goods have not been sold), and selects the one with the earliest date. This is known as a "First In - First Out" method.

The CIF VALUE and DUTY LIABILITY on the selected shipments are the ones that will be compared against CIF VALUE and DUTY LIABILITY of the sale transaction been recorded. If there is a discrepancy between these values, the system displays a message informing you. You may then press F1 to see where the error lies. LETS LOOK AT AN EXAMPLE:

If you answer "N" (no), the system will not create the record, and consequently will not substract the specified QUANTITY from inventory. On the other hand, if you answer "Y" (yes), the system will create the record, substracting the specified QUANTITY from the current inventory.

Remember that creating this record simply enters the information reported by the merchant. As we know, if there is a discrepancy between the reported DUTY LIABILITY and the real DUTY LIABILITY the merchant has to correct it (i.e., pay). The system provides a program to keep record of the corresponding transactions through the "Duty Liability Maintenance" option (next Session) on the same MENU we are discussing, the "Sales Menu". LETS GO BACK TO THE "GOODS SOLD LOCALLY" COMMAND SCREEN AND SELECT TO PERFORM A SEARCH OPERATION.

The "Duty Liability Maintenanace" option provides a mechanism to update the information on the duty liability for the merchants. Notice that when a local sale transaction is entered ("Goods Sold Locally" option of the "Bond Transaction Menu" Module on the Master Menu), the system verifies that the reported duty liability is the appropriate. If it is not, a message is displayed where the user may compare the reported liability versus the correct, and then take the appropriate actions to collect the difference. Once this is accomplished, the system provides this "Duty Liability Maintenance" program to update the information.

The "Advice/Help Line" defines the task assigned to each Function Key that may be used to move through the list of delinquent STORES. Notice that F1 moves the cursor one line up, F2 moves it one line down, F3 displays the <u>previous</u> ten (10) "recorded delinquent sales" (if there are as many), and F4 displays the <u>next</u> ten (10) sales (if there are as many).

On the previous screen the system has displayed the result of our request. We requested a SEARCH by STORE NUMBER, and specified STORE 777. The system then SEARCHED the available information on that STORE'S INVENTORY. It first selected the smallest available REFERENCE NUMBER; and then selected the oldest shipment.

Notice the number on the left side of the third line on the screen. This number is the same as appeared on the "Customs Private Bonded" program when we were recording the shipment. It represents the amount of shipments received (records created) on the specified TRANSACTION DATE, and for the specified REFERENCE NUMBER (good).

Lets discuss the screen displayed above. We notice that it is the information for the first (1) shipment recorded on January 14, 1990 for Black Nylon Ribbons (REFERENCE NUMBER) on Data General Antigua, Inc. (STORE). We also notice that 20 units were received (TOTAL QUANTITY), from which there is none available (QUANTITY AVAILABLE) because all 20 have been sold (QUANTITY SOLD). The recorded CIF VALUE is 15.00, with a DUTY LIABILITY of 3.00. Press F1 to view the information on the NEXT record. The system displays a shipment received on August 8, 1990 for the same REFERENCE NUMBER. 600 units were received, and 600 units have been sold:

The "Advice/Help Line" defines the task assigned to each Function Key that may be used to move through the selected STORES/REFERENCE NO.'s and to add other combinations to the list. Notice that F1 moves the cursor one STORE/REF. NO. up (within those already defined), while F2 moves it one STORE/REF. NO. down. On the other hand, F3 (PREV SCREEN) displays the previous ten (10) STORES/REF. NO.'s (if there are as many), and F4 (NEXT SCREEN) displays the <u>next</u> ten (10) STORES/REF. NO.'s (if there are as many).

If you define a STORE/REF. NO. by mistake, use the function keys until the corresponding combination is highlighted by the cursor. You may then press F7 to DELETE it.

If on the other hand, you want to add another, press F6 to do so.

Add the combination STORE 777, REFERENCE NUMBER 2280. Once your 'ist is complete, press F5 to start the PRINT operation. Notice you always have the ESC option to abort the operation.

Remember that the system will SEARCH the BOND File for the specified values, and that in a SEARCH operation the system does not verify the validity of the information you enter to identify the record it is going to SEARCH for. If it is unable to find a record with the exact same information as specified, it will print the available record with information closest to the one specified.

Once you press F5 to start printing, the system confirms the PRINTING operation, giving you a last chance to abort it:

Suppose we select STORE 777, the system automatically displays the name of the STORE and asks you for the REFERENCE NUMBER that defines the BEGINNING value of REFERENCE NUMBERS to PRINT. Once again, remember the availability of the Index Key (Shift F2) (for more information go to Session "Reference Master File Maintenance" on Chapter VI. "The Master Files Module").

Valid REFERENCE NUMBERs are those that have been created by a System Administrator through the "Reference File Maintenance" option on the "Master Files Menu". Note that in the COMMAND SCREEN we are discussing, the system does not verify the validity of the REFERENCE NUMBER you enter. The reason is that the system gets it's information to produce the report after doing a SEARCH of the file. If it is unable to find a record with the exact same REFERENCE NUMBER as you specified, it will use the available record with a REFERENCE NUMBER closest to the one specified. This is a powerful feature that allows you to produce reports that satisfy all your needs.
