

What is UNIDO?


UNIDO is the specialized agency of the United Nations that promotes industrial development for poverty reduction, inclusive globalization and environmental sustainability

The mandate of the United Nations Industrial Development Organization (UNIDO) is to promote and accelerate inclusive and sustainable industrial development in developing countries and economies in transition.

UNIDO's vision is a world where economic development is inclusive and sustainable and economic progress is equitable. The Organization focuses on three main thematic areas:

- Poverty reduction through productive activities
- Trade capacity-building
- Energy and environment

The Organization is recognized as a specialized and efficient provider of key services meeting the interlinked challenges of reducing poverty through productive activities, integrating developing countries in global trade through trade capacity-building, fostering environmental sustainability in industry, and improving access to clean energy.



Director General



LI Yong is the Director General of UNIDO, a post to which he was elected in June 2013. The Director General has been a strong advocate of inclusive and sustainable industrial development (ISID), which was endorsed by UNIDO Member States at UNIDOs' General Conference in Lima in December 2013.

In light of this new mandate UNIDO organized two ISID Forums in 2014. The first one, held in June, engaged Member States in a dialogue to formulate strategies and policies that promote inclusive and sustainable industrial development. The second forum, held in November, extended the impact and outreach of ISID goals by strengthening the partnership dialogue between UNIDO, recipient governments, development finance institutions, development agencies, the private sector and donors in order to scale up investment for inclusive and sustainable industrial development in developing countries.

Message from the Head

Takeshi Furutani

About one year has passed since the General Conference of UNIDO held in Lima in December 2013 adopted the Lima Declaration, which gave UNIDO a new mandate to promote inclusive and sustainable industrial development (ISID).

ISID is described as follows: "Every country achieves a higher level of industrialization in their economies, and benefits from the globalization of markets for industrial goods and services; no one is left behind in benefiting from industrial growth, and prosperity is shared among women and men in all countries; broader economic and social growth is supported within an environmentally sustainable framework; the unique knowledge and resources of all relevant development actors are combined to maximize the development impact of ISID".

In 2014, UNIDO developed activities to implement the mandate to promote ISID including organizing the first and second ISID Forums, held in Vienna. At the same time, UNIDO ITPO Tokyo started implementing its new three-year plan for 2014 - 2016 to increase investment and technology flows from Japan to recipient countries in line with the ISID concept. I am therefore very pleased to introduce the Annual Report on our investment and technology promotion activities of 2014.

In 2014, UNIDO ITPO Tokyo invited 9 investment/technology delegates from recipient countries, who undertook promotional activities to attract foreign direct investment and technology transfer from Japan through seminars, exhibitions and bilateral business meetings. A total of 8,460 people attended the events and 1,367 business meetings were held with Japanese companies. The information they obtained from delegates and the discussions they held encouraged these companies to proceed with their investment activities. We have created a good number of success stories where delegates' support led to actual investments and an increase in employment in recipient countries since we launched the "Delegate Programme."

The "Africa Advisory Programme" is another one of our important activities which many Japanese companies appreciate in terms of practical support to greatly facilitate their investment activities. While the programme was formally launched in 2013, it was accelerated in 2014. We have assigned well qualified UNIDO experts as Advisors in Algeria, Ethiopia and Mozambique, and I believe that they can create successful outcomes.

In September 2014, we launched a new user-friendly website so that you can easily access the latest information on our activities. As described in this Annual Report, we are providing you with a wide variety of opportunities ranging from obtaining useful and practical information to networking with potential business partners, to getting assistance when promoting and negotiating investment projects in recipient countries. I believe that the website as well as this Annual Report can increase your chances to utilize these opportunities for your activities.

Mission

The mission of UNIDO ITPO Tokyo is to help developing countries and economies in transition in their efforts to achieve inclusive and sustainable industrial development by promoting foreign direct investment (FDI) and technology transfer from Japan through various activities (see page 4).

The office was established in March 1981 under an agreement concluded between UNIDO and the Government of Japan, and is one of 7 ITPO offices worldwide.

The geographical coverage of the office extends to the whole developing world, and recently focus has been increased on Africa and the least developed countries in other continents. Sector wise, the coverage is also wide, including manufacturing industries, agro-based industries, environment and energy related industries, as well as promotion of small and medium enterprises (SMEs).

ABSTRACT

UNIDO ITPO Tokyo promotes investment and technology from Japan to developing and emerging countries, by inviting officials from these countries to Japan and organizing tailor-made programmes, including promotion events and business meetings in Japan.

What is the Delegate Programme?

Investment or technology promotion delegates are invited for a short-term stay (average 2 weeks) in Japan, to promote the delegate's country as a possible destination for Japanese investments or technology transfer. Promotional activities include country presentation seminars and business meetings, where projects from the delegate's country are presented.

Support by UNIDO ITPO Tokyo

Assistance includes promotion of projects; identification of potential business partners; arrangement of meetings and visits; organization of seminars/roundtable meetings; assistance for business communication/ negotiation; provision of temporary office facilities.

Application

Government, semi-government, or non-government organizations are welcome to submit candidates with the following qualifications:

- Age between 30-45 with management experience
- Perfect command of spoken/written English
- ■Strong negotiation and presentation skills
- ■Ample knowledge of local industry
- ■Report writing and computer skills

Financial Conditions

UNIDO ITPO Tokyo covers most of the costs, except for the delegate's round-trip airfare, which is the minimum contribution required from the delegate's organization.



HIGHLIGHTS

UNIDO Booth at Green Innovation Expo 2014 (GIE 2014)

UNIDO ITPO Tokyo cooperated with the Japan Management Association and the Society of Chemical Engineers, Japan to organize a UNIDO booth on the theme of "Innovation in Water Management" at the GIE 2014 held at Tokyo Big Sight from November 12th - 14th, 2014.

The event attracted a total of 26,574 visitors from Japanese private and public institutions during three days, out of which approximately 800 came to the UNIDO booth to learn about UNIDO's activities in general, and water related projects in particular.





Three delegates in charge of water management from Bangladesh, Myanmar and South Africa were invited to participate in the event to meet with Japanese companies. As a result, a total of 102 bilateral business meetings were held between Japanese companies and the delegates at the booth.



Seminar on Water Business and Management

On the sidelines of the GIE 2014, UNIDO ITPO Tokyo and JMA organized a seminar on water business and management on November 13th, 2014, highlighting business and investment opportunities in Bangladesh, Myanmar and South Africa.



The seminar was attended by 176 Japanese companies and institutions, and included presentations by each country and a panel discussion session between the delegates and Japanese experts on water management, focusing on the need for water technologies, and possibilities as well as means to transfer such technologies by Japanese companies.





Low Carbon Low Emission Clean Energy Technology (LCET) Transfer Programme

LCETs have emerged as potential solutions that can simultaneously address three key global challenges of energy poverty, job creation and climate change.

UNIDO and the Ministry of Economy, Trade and Industry of Japan (METI) are implementing a collaborative global programme to promote the rapid deployment and dissemination of LCETs through demonstration projects, capacity building and knowledge management.

Under the programme, UNIDO is aiming to showcase Japanese technologies on micro hydropower, solar energy and waste-to-energy technologies in Africa. Ultimately, these projects are expected to create new job opportunities and generate income to local communities.

SEMINARS AND EVENTS



ABSTRACT

UNIDO ITPO Tokyo organizes and supports seminars, workshops & forums and participates in various exhibitions and events, to promote UNIDO's activities and developing and emerging countries in Japan. For a full list, please see pages 21 - 22 (Appendix).



UNIDO Seminar "Partner for Prosperity" in Tokyo

UNIDO organized the high-level seminar on March 18th, 2014 in Tokyo, in cooperation with the Institute of Developing Economies (IDE-JETRO) and the United Nations University (UNU). More than 150 participants attended the event, including representatives of the diplomatic corps, the Japanese government and the private sector.

At the event, UNIDO announced a new vision for Inclusive and Sustainable Industrial Development (ISID) towards the Post 2015 Development Agenda, introduced UNIDO's activities in cooperation with Japan, and also urged Japanese companies to cooperate for further investment and technology transfer overseas, through various programmes and support offered by UNIDO ITPO Tokyo.

UNIDO also presented the publication of the "Industrial Development Report 2013" (IDR 2013). Key findings stressed that manufacturing is still one of the most essential sources of employment for most countries, yet the structure is different among developing and developed countries.













Japan-Africa Business Forum 2014 in Tokyo

UNIDO supported the "Japan-Africa Business Forum 2014", hosted by the African Diplomatic Corps (ADC) and the African Development Bank (AfDB), on June 10th - 11th, 2014, in Tokyo. The two-day forum was organized as a follow-up event of TICAD V and Prime Minister Abe's visit to Africa in January 2014.

The Forum included presentations by various government and business leaders from Africa and Japan. The event attracted 1,221 participants, including 225 from Africa. UNIDO's advisors from Algeria, Ethiopia and Mozambique attended the Forum and networked with participants.

On this occasion, a side event seminar titled the "East African Community (EAC) Business Seminar – Experiences and Strategies of Businessmen" was also held on June 12th, 2014, attracting 116 participants. The event provided information on business opportunities in East Africa for Japanese private sector companies with a target to create stronger relationships and understanding between the two business communities. Presentations and a panel discussion were provided by representatives from UNIDO and five executives from the East African Business Council (EABC).







Green Technology Forum in Tokyo

UNIDO hosted the "Green Technology Forum" on November 12th, 2014 in Tokyo, in cooperation with the Japan Management Association (JMA) on the sidelines of the Green Innovation Expo 2014. The seminar attracted 135 participants from Japanese companies, the public sector, and various embassies in Japan.

The forum highlighted UNIDO's initiatives to promote green technologies for Inclusive and Sustainable Industrial Development (ISID) through public-private partnerships. The seminar was composed of two thematic technical sessions on "Waste Management" and "Low Carbon" technologies.

Keynote speeches provided by Kazuhiko Hombu of the University of Tokyo, and Wilson Songa, Principal Secretary of the Ministry of Industrialization and Enterprise Development of the Republic of Kenya, focused on low carbon initiatives in Japan and promotion of energy projects in Kenya. Technical sessions focusing on Waste Management and Low Carbon highlighted contributions by Japanese companies to infrastructure projects in developing countries and emerging markets.

ABSTRACT

UNIDO ITPO Tokyo organizes capacity building activities such as lectures, visits to factories and exhibitions, and fact-finding meetings for various delegations from developing countries as well as embassy officials in Japan.









Embassy Programmes

UNIDO ITPO Tokyo organizes programmes for embassies in Tokyo by holding workshops, tours to exhibitions and business meetings to introduce the latest Japanese manufacturing and environment related technologies. In 2014, a total of 139 diplomats in Tokyo participated in such events.

UNIDO ITPO Tokyo facilitates missions and study tours from developing and emerging countries to Japan to discuss investment and technology promotion issues, and also to organize seminars, business meetings, as well as visits to industrial sites and exhibitions.

ABSTRACT

UNIDO ITPO Tokyo facilitates the business activities of Japanese companies overseas, through a network of UNIDO, government and private sector contacts in developing and emerging countries, and also through the Africa Advisory Programme.





Africa Advisory Programme

Since 2013, UNIDO ITPO Tokyo has supported Japanese companies interested in starting their businesses in Algeria, Ethiopia and Mozambique.

This programme is aimed to provide Japanese enterprises with consultancy services, by way of information dissemination, arrangement of meetings with government agencies, support for match-making with local partners, and facilitation of visits to local companies.

Three advisors assigned at the selected countries work hand-inhand with potential Japanese and local partner companies in order to attract investment, partnerships, and technology transfer to each country. In 2014, the advisors supported 43 Japanese companies through this project.

Missions Overseas

UNIDO ITPO Tokyo assists and organizes Japanese business missions to selected destinations overseas, including arrangement of business meetings with the private and public sector, and participation in international events.

Business Mission to Turkey

UNIDO ITPO Tokyo co-organized a 13 member Japanese business mission from Kansai and Yokohama to Turkey from November 1st - 7th, 2014, in cooperation with JAFTA (Japan Foreign Traders Association).

The mission visited Istanbul and Izmir and met with Turkish as well as Japanese organizations and companies. Mission members held 15 bilateral meetings in Istanbul and 2 bilateral meetings in Izmir. Potential partnership projects are being followed-up.
