## **3<sup>rd</sup> PLENARY MEETING**

#### **Item 4: Organization of work**

## General debate — Items 8 to 23

With the President in the Chair, statements were made by H.E. Mr. Ilunga Leu Marcel, Minister of Industry of the Democratic Republic of the Congo; Mr. Niyazi Safarov, Deputy Minister of Economy of Azerbaijan; Mr. Marco Velarde, Vice-Minister of Production of Peru; Ms. Yam Kumari Khatiwada Baskota, Secretary at the Ministry of Industry of Nepal; Mr. Feroz Khan Masjidi, Deputy Minister of Commerce and Industries of Afghanistan; Mr. Barat Ghobadian, Deputy Minister of Industry, Mine and Trade of the Islamic Republic of Iran; Mr. Maroof Afzal, Deputy Minister of Industries and Production of Pakistan; Mr. Gennady Gatilov, Deputy Minister of Foreign Affairs of the Russian Federation; H.E. Mr. Hussein El-Hajj Hassan, Minister of Industry of Lebanon; and Mr. Carlos Játiva, Undersecretary of North America and Europe at the Ministry of Foreign Affairs of Ecuador; the Islamic Republic of Iran (on behalf of the Group of 77 and China); Thailand (on behalf of the Asia and Pacific Group); and Argentina (on behalf of the GRULAC).

#### **Item 9: Fourth Donor meeting**

The event, which consisted of three panels exploring the contribution of donors to UNIDO's work, was moderated by Ms. Linda Yueh.

Introductory remarks were delivered by Mr. LI Yong, Director General of UNIDO.

The first panel was entitled "Japan-UNIDO partnership: Fostering technology transfer towards achieving the SDGs". The panellists were Mr. Satoshi Kurimoto, Director, Technical Cooperation Division, Trade and Economic Cooperation Bureau, Ministry of Economy, Trade and Industry of Japan; Mr. Mitsuhiro Wada, First Secretary, Embassy of Japan in Lebanon; Ms. Miguele Makari, Student at the Lebanese University; Mr. Shiferaw Feyissa Balcha, Vice-President for Research and Technology Transfer, Adama Science and Technology University, Ethiopia.

The second panel was entitled "Stronger in partnership: Sweden and Finland supporting industrial skills development". The panellists were H.E. ## Industry 4.0 – The opportunities behind the challenge

### Launch of the Industrial Development Report 2018

Industrial development has typically been studied from a supply-side perspective, relegating the importance of demand. The initiation of industrial development, however, requires a critical mass of demand for manufactures. With the right set of conditions, the consumption of manufactures can set in motion a virtuous circle of industrial development comprising income creation, demand diversification and massification of consumption. This circle, however, requires specific policy measures to attain socially inclusive or environmentally sustainable industrialization.

This event presents the launch of the Industrial Development Report 2018 "Demand for Manufacturing: Driving Inclusive and Sustainable Development". The main findings of the report will be presented and discussed with a panel of leading experts in the field of industrial development.
